There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with
warrants or unpaid fines:Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the
above date and time. Failure to comply with this requirement may result in a delay of the
granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

He was doing business during the COVID Stay at home

He added a vent from his place at the bottom of the door at foot step level blowing perfume and whatever out of the building. Health issue for COVID and for asthmatics,

Also a building code violation as anyone can throw a firebomb into the vent and burn the inside of the building.

Parking: they park their cars and the owner may arrive in one of three cars, gray SUV, GMC logal painted out black SUV. or a new motorcycle. Then a woman arrives, the tattoo guy arrives, all park in front, the customer parking place, forcing the customers to park in front of driveways, bus stops and alleyways all clearly marked as no parking. Customers get angry for being ticketed then trash the area, and break windows and tag the neighbors garage.

Since PP Piercings licence was awarded last October, that building has had 4 homicides, three shootings, one car torched, two cars smashed into the building causing the school to go into lock down. due to midday assault rifle gun battles. This area has not had a homicide in roughly 25 years yet directly after the licensing, within two months after his legal presence there were 4 homicides, three shootings, one car torched.

This adult body piercing business is located kiddy corner from Washington High School, very young children have to walk past it to go to the candy store, THIS IS NOT THE AREA FOR AN ADULT BODY PIERCING BUSINESS of this nature. Who and what are being brought into the neighborhood subjecting this community and High School to such violence? The people coming into the area are told this community is the hood, the ghetto, we and Whasington high school deserve a better shake than this in our community.

To whom it may concern:

I am writing to object to the renewal of the license for Piercings Plus at 4412 W Center Street, Milwaukee WI 53210.

, and have worked hard to maintain a strong, vibrant neighborhood with strong connections to Washington High School. have several young families on the and wish to maintain a strong family-oriented environment. The arrival of Piercings Plus has had a measurable detrimental effect on our efforts to maintain a safe and vibrant neighborhood.

With the arrival of Piercings Plus, there has been an increase of nuisance activities, including loud noise, foul odors emanating from the building (from a vent on the door), and parking violations in the alley between 44th and 45 Street north of Center Street and on Center Street itself, with customers from Piercings Plus occasionally parked in the bus stop on Center Street and in front of neighbor's garages. Worst of all, there has been an uptick in violence, including an increase in the number of homicides in this area that is simultaneous with the arrival of Piercings Plus.

As you may know, 53210 had the largest number of human traffickers according to the report on human trafficking based on police statistics published by the Homicide Review Commission in 2013. There have been reports of a heightened amount of sex trafficking associated with the arrival of Piercings Plus, and so the proximity of this business to Washington High School and to the young families on our block therefore remains a grave concern to area residents.

Our neighborhood desperately needs your help as we strive to establish a more family-friendly community with a large number of young families on our block and to maintain a positive and welcoming relationship with the Washington High School community.




This bus stops right back door, illegal parking in no parking bus area or driveway and the bus does not or should I say can not stop.


Teens use this bus stop on a regular basis. Mothers with children use this bus stop, seniors use this bus stop and use driveway.




Jay's is harder to monitor as they come and go.





I went to P+P Piercings yesterday afternoon around 2:30 and spoke to about your parking concerns. He has numerous signs informing his customers not to park in the alley or in the drive West of the business stated he tells his customers to park accordingly, and I see nothing else within the realm of reason he can do to assist your concerns. If people that frequent his business park illegally, then the call has to be made to the dispatch at parking enforcement.

Although the police department can deal with parking concerns on occasion, this is the primary responsibility of DPW-parking operations and parking concerns should be brought to their attention.

In regard to the shots fired calls, a D3 squad was sent there yesterday, recovered and did recover casings. I will be reaching out to Captain Johnson at D3 to have increased patrols to deal with the shots fired and drug dealing concerns you brought forth.

As always, in order to get a property or business in a nuisance status there has to be calls generated in the dispatch center and then these have to be linked to either the property or business. I see no reason at this time to place P+P Piercings in this nuisance status due to attempts to deal with the parking issue. The license committee also needs documented calls linking issues to the business for any kind of licensing suspension or revocation.

Your parking concerns have been forwarded to the officers at D7 on several occasions and they get there when they can, but as you are well aware, other calls for service are given priority.

If you have issues with the MPD dispatch center, their supervisor extension is 935-7472.

Some suggestions I have to address the parking concerns are some kind of barrier between drive and the alley or signage placed on property/garage of no parking. I do not know if there are any grant funds to assist in the costs of these suggestions, but that may be an option. Changing signage on street signs (bus stop or no parking), road change design (bump-outs) or changing the alley to a one-way S/B would have to be addressed to city government.


Yesterday I had to wait 10 min. so I was late with my rideshare person because a car was blocking my ability to swing from my garage without hitting him.





All is legally marked tow away but they continue to use my property even when they have legal parking in front of the stores.

I am told that Ald. Rainey is issuing Promotional parties which seem to be almost twice a week at these businesses, and the people coming become erratic drivers cruising around the building, fighting, and is their parking area.

Last Saturday not only did these incidents occur but hangout and also fights were in the alleyway. My neighbor , said they had a shootout also. I heard the fight and got some pictures of it. Called it in but it took an hour before reaching back. Fortunately no one was hurt.
