Combined Sewer Overflow facilities and appurtenances located in Schroeder and Trostel's Subdivision in southeast and northeast quarter of Section 20 and southwest and northwest quarter of Section 21, Township 7 North, Range 22 East that part of Lot 2 in said Subdivision commencing in the most westerly corner of said lot which is in the southeasterly line of North Commerce Street thence southeasterly 88.40 feet thence

Stat. 6i2.73), in and to those portions of vacated North 5th Street public right-of-way ("ROW") shown on **EXHIBIT A-2**, and in and to those portions of vacated West Galena Street public ROW shown on **EXHIBIT A-2**, and in and to those portions of vacated North 2nd Street public ROW shown on **EXHIBIT A-2**.

The North 5th Street public ROW was vacated by City Common Council Resolution No. 702098 in 1971.

The West Galena Street public ROW was vacated by City Common Council Resolution Numbers:

File 69-299 in 1968 File 910214 in 1992

The North 2nd Street public ROW was vacated by City Common Council Resolution No. 940749 in 1999.
