What sort of "investigation" was conducted?

This entire issue was caused by Milwaukee Waterworks employees' negligence. If the meter was properly installed and fastened, which is typical for a meter change, there would have been no damage. Whether it was the gasket or washer, I do not know as I am not a plumber. What I do know is, something with the connection was wrong. How is it our responsibility to pay for damage, caused by meter installation? Are you suggesting we are lying, or simply we enjoy flooding our own property for the fun of it?

GRIRE 3333 Investments, LLC formally is appealing this decision and would like to request a hearing be set for a future date. Attached you fill the previous letter sent, your correspondence, and the postmarked envelope needed for an appeal. Any attorney fees incurred will be included in our damage claim. This is more of a matter of principle. You have wasted our money and more importantly our time.

We have received your claim in the amount of \$1,040.50, in relation to damage sustained to your property on December 10, 2021, at or near 3333 South Clement Avenue.

Our investigation reveals that on December 9, 2021, Milwaukee Water Works (MWW) completed a meter exchange at the subject property. On December 10, 2021, we received notice of flooding reported to the MWW Meter Services Section, due to a leak at the water meter, which had previously been repaired by a private plumber on the afternoon of December 9, 2021. MWW responded to that report of the leak, and a meter read was taken that indicated 2.8 ccfs (centum cubic feet, 1 ccf=748 gallons) of water usage within a period of 24 hours since the meter had been exchanged. The utility records indicated that the property typically registers about 250 ccfs of quarterly usage which averages 2.7 ccfs per day.

The leak was found to be unrelated to the meter exchange that occurred on December 9, 2021. As such, the City of Milwaukee is not liable for damages. Therefore, we are denying your claim.
