While doing so, he noticed a few inches of standing water in the hallway and running water coming from the room where the meter is located. He did not have keys to the room with the meter, which forced him to kick the door to get to the source of the water. The meter was improperly installed and caused a massive leak.

We are seeking reimbursement for any cost incurred, because of Milwaukee Waterworks negligence. We immediately called a plumber on site, to stop the leak and securely fasten the meter to the water connection. Additionally, we are requesting reimbursement for labor, the cost of fixing the door, and the water that was wasted. Our employees worked a total of 10 hours, we want reimbursement for each hour worked at a rate of \$35/hr. Three employees worked 2.5 hours on 12/09/21 cleaning up the water and two employees worked 1.5 hours fixing the door on 12/10/21. The only parts required to fix the door are inventoried at our corporate headquarters and costed roughly \$25. Lastly, we would a \$100 for the unknown amount of water that was wasted. At this time we do not know the usage of the building, as the usage remains unbilled at this time.


