The Milwaukee Police Department's investigation regarding this application revealed the following:

 On 08/30/2018, 12:08am, officers were dispatched to a Noise Nuisance complaint at Urban Bay View, 2301 S Logan Av. Upon arrival the officer could hear loud talking and yelling coming from the patio area of the bar. The officer spoke with the bartender, Marta ALCANTAR, who stated she would have the people come in from the patio. The officer asked for ALCANTAR'S Class D operator's license, but she was not able to produce one. A check of LIRA revealed she had not been issued a license. ALCANTAR was cited and the applicant was cited for Responsible Person on Premise.

The dogs started barking and the owners were yelling at them, causing a disturbance. The officers spoke with the bartender whom had the remaining subjects on the patio move to the front of the building.

3. On 04/17/20 at 4:28pm, Milwaukee Police were dispatched to 2301 S. Logan Avenue for a business covid check complaint. Investigation revealed that the business was in full compliance with Wisconsin State Statute 252.02(3).

The applicant stated he has worked with the neighbor to try and reduce complaints. The officer advised the applicant to follow all food truck regulations including returning to the base kitchen once every 24 hours for cleaning.

This report is being submitted by PO Xavier Benitez assigned to the License Investigation Unit. On Friday April 1st, 2022 at approximately 1:00pm, a citizen called the general phone number of the License Investigation Unit to express concerns about a mobile food truck, Gavilan, which is associated with the Mothership Tavern located at 2301 S. Logan Ave. The citizen later identified as Dennis Kukla, stated that

he resides next door (929 E. Lincoln Ave) of the tavern and that the food truck exhaust fan sounded loud and they may not be adhering to food operation regulations. I stated to Mr. Kukla I PO Benitez would look into the concerns regarding the food truck.

On 04/01/22 at 1:20pm, I arrived at the location of 2301 S. Logan Ave and observed the Gavilan Food Truck legally parked and not currently opened for serving food, and the tavern Mother Ship was not currently operating as well. I was approached by a citizen who identified himself as Dennis Kukla, and stated that he called regarding the truck. I informed Mr. Kukla, that I observed no violations and will contact the agent expressing his concerns with the food truck.

On 04/04/22 at 10:00am I made contact with Mr. Jonas regarding the possibility of a loud fan on the food truck, and that there are concerns that the truck is not following mobile food sales. Mr. Jonas immediately knew the particular neighbor and stated he has tried to work with him regarding any concerns, but Mr. Kukla is difficult. Mr. Jonas stated that he has sound barriered portions of the business to try not to be a nuisance with Mr. Kukla but he stills complains. I informed Mr. Jonas that I did come out to the location on 04/01/22 and observed the truck parked at 2301 S. Logan Ave. I stated that I had concerns that the food truck is not returning to the restaurant associated with the truck at least once every 24 hours.

Mr. Jonas was cooperative stating that he is following the rules and does return to the restaurant for regular cleaning. Mr. Jonas stated that I could come out and inspect the truck any time if need be. I told Mr. Jonas that it would not be necessary and be sure he is adhering to the City of Milwaukee Ordinances, pertaining to mobile food sales. Also that it would be in his best interest to try and work with his neighbors surrounding his businesses. Mr. Jonas stated that he has worked with officers from District 6 in the past regarding his neighbor, and could reach out if need be.

I verified that all the licenses on the Gavilan Food Truck were recently renew on March and valid through 2023.

The hearing before the Licenses Committee will take place virtually on 06/28/2022 at 09:05 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
