FIRST ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE DEPARTMENT OF ADMINISTRATION AND THE MILWAUKEE POLICE DEPARTMENT REGARDING USE OF ARPA FUNDS

THIS FIRST ADDENDUM ("ADDENDUM") to the Memorandum of Understanding Between the Department of Administration and the Milwaukee Police Department Regarding the Use of ARPA Funds ("MOU") is made and entered into by and between the Wisconsin Department of Administration ("DOA"), whose principal business address is 101 East Wilson Street, Madison, WI 53703 and the Milwaukee Police Department ("MPD"), whose principal business address is 749 West State Street, Milwaukee, WI 53233.

WHEREAS, the United States Department of the Treasury ("Treasury Department") has distributed to DOA funds ("ARPA Funds") from the Coronavirus State Fiscal Recovery Fund pursuant to 42 U.S.C. § 802, as added by section 9901 of the American Rescue Plan Act of 2021 ("ARPA"); and

WHEREAS, DOA is making a portion of such funds available to reimburse certain expenditures of local and tribal law enforcement agencies within Wisconsin (the "Program"), as set forth in the MOU; and

WHEREAS, the Program allocates funds to local and tribal law enforcement agencies based on their jurisdiction's population and violent-crime rate; and

WHEREAS, the Program and its related allocations were publicly announced on March 15, 2022; and

WHEREAS, recent incidents of gun-related violence in the City of Milwaukee, including the May 13, 2022 Deer District shootings which resulted in injuries to 21 people have highlighted the need for additional resources and funding flexibility for MPD to enable it to implement further measures to protect public safety in the City;

NOW, THEREFORE, DOA and MPD agree to add the following terms to the MOU:

1. In addition to the Allocation amount set forth in the MOU, MPD may seek reimbursement of an additional \$2.2 million of eligible expenditures through the Program. The additional funds shall be provided from the same federal funding source and shall be governed by the same requirements as the Allocation amount provided in the MOU, except to the extent those requirements are amended by paragraph 2 below.

2. In addition to the eligible expenditures set forth in the MOU, MPD may seek reimbursement through the Program for the following additional expenditures:

- a. Payroll costs for overtime hours worked by sworn law enforcement officers.
- b. Security fencing, including fencing that can be raised and lowered remotely.
- c. Forensic recovery of evidence devices (FRED).
- d. Clip-on night vision devices (CNVD).
- e. Self-contained breathing apparatus (SCBA) air tanks.
- f. Ballistics analysis software licenses.
- g. Accessories or training related to 2.b. through 2.f. above.

The person(s) signing this Addendum on behalf of MPD certifies and attests to having full and complete authority to bind MPD, on whose behalf they are executing this document.
