Dear City Clerk,

We received and reviewed your denial letter on June 7, 2022, regarding our claim for \$14,900.63 related to clean-up charges and damages we incurred because of a sewer back-up in our basement on January 16, 2022.

CITY CLEAKS OF THE ST. 15

We are disappointed regarding your denial of our claim, considering the cause of the sewer back-up was "due to heavy grease in the sewer mainline," resulting in a "clogged sanitary sewer lateral line that serves this address." As a City of Milwaukee homeowner and taxpayer of this property for over 31 years, it is discouraging and frustrating to learn that the City of Milwaukee is not responsible for the damages caused from the City's sewer system's "mainline." The clean-up was hazardous and was an inconvenience during the winter months, including incurring an unnecessary expense.

We are requesting an appeal of the denial decision. We acted responsibly in contacting the City of Milwaukee Water Works, 24 Hour Emergency Control Center to report the incident immediately. The Sewer Maintenance crew reported, as stated in the denial letter that the sewer back-up was caused by a "heavy grease" clog in the City of Milwaukee's main sewer system. Although the denial letter reports that the "City Sewer Maintenance Department followed proper procedures in this case and the sewer was found to be in good condition and functionally properly," this did not prevent the sewer back-up in our basement from the City's "sewer mainline."

A photocopy of the postmarked date of the denial letter received from the City of Milwaukee Office of the City Attorney is enclosed. We are looking forward to a hearing on this claim. Dear Ms. Ryan:

We are in receipt of your claim for \$14,900.63 relating to clean-up charges and property damage you incurred as a result of a sewer back-up at your residence located at 3446 North 48th Street on January16, 2022.

Our investigation revealed that a City of Milwaukee Sewer Maintenance crew responded to a call regarding sewer back-up at 3446 North 48<sup>th</sup> Street on January 16, 2022. The sewer crew discovered a clogged sanitary sewer lateral that serves this address and immediately called the jet-vac cleaning crew, and they were able to open the clog. The lateral was then referred to a CCTV crew to further investigate the problem.

On January 18, 2022, the sewer was CCTV examined and found to be in good condition and functioning properly. The clog was due to heavy grease in the sewer mainline. This sewer is on a three-year cleaning schedule and was last cleaned in September of 2019.

It is our view that the City Sewer Maintenance Department followed proper procedures in this case, and were not negligent regarding their investigation and cleaning of the sewer lateral. As such, we cannot accept liability for your damages and we are denying your claim.
