- Staffing, hiring and vacancy challenges



COMMUNITY HEALTH BRANCH 2021 HIGHLIGHTS



- Direct Assistance for Dads (DAD) and Empowering Families Milwaukee successfully merged
 - 0% of infants among mothers who enrolled in EFM prenatally before 37 weeks were born preterm
- Infant mortality special initiatives
 - 401 cribs distributed
 - 75% distributed in zip codes with a high prevalence of infant mortality



ANNUAL REPORT

• BOMB Doula

- 92 referrals received
- 100% of clients had a provider established
- Became fully staffed in 2021
- Certifications achieved (Lactation Educator, Breastfeeding Specialist, International Board Certified Lactation Consultant)
- Women, Infants, and Children Nutrition
 - 87,269 participants were enrolled
 - \$2,329,660 in WIC benefits were distributed



ANNUAL REPORT

- Office of Violence Prevention
 - 414 Life 66 community violence interruptions
 - 1,341 youth and families served by ReCast Milwaukee
 - 90 supervised exchange services
 - Initiated program wide evaluation planning




Consumer Environmental Health

- 1,123 weights & measures devices inspected



Emergency Preparedness and Environmental Health

- 124,791 COVID-19 PCR tests at community sites
- 216,853 total vaccinations administered
- 19,414 mobile vaccinations
- 568 mobile clinics completed

ANNUAL REPORT

Infectious Disease Program

- 750 communicable disease cases investigated
- 1,023 directly observed therapy home visits completed

Immunizations

- 83% of children were in compliance with school required imms
- 3,135 clients received immunizations



ANNUAL REPORT

Sexual and Reproductive Health

- 5,390 clients served at Keenan Health Center
- 92% of cases receiving case management were successfully treated
- 70% decrease in turn-aways from 2020 as operations resumed
- Challenges of increased syphilis and gonorrhea rates



Well Woman Program

- 838 breast cancer screenings were provided
- 89 cervical cancer screenings were provided
- 8,212 case management encounters occurred



ANNUAL REPORT

Laboratory

- 2,098 COVID-19 samples genomic sequenced
- 14,024 gonorrhea tests
- 7,445 environmental lead tests performed
- Implemented pilot programs for SARS-CoV-2 wastewater and aerosol sample surveillance
- Generated \$507,873 in fee for service and reimbursement revenue



POLICY INNOVATION AND ENGAGEMENT BRANCH 2021 HIGHLIGHTS



- Distributed more than 580 Narcan kits
- Maintained 18+ internal and external dashboards
 - COVID-19 dashboard received more than 500,000 views
- \$8 million in competitive grants received
- Managed the department's strategic plan process

- 8,241 births registered
- 5,075 deaths registered
- 72,821 total birth and death records issued
- \$594,254 total gross income
