## Background

- Common Council established the City-County Task Force on Climate and Economic Equity in 2019 (CCFN 190445) to address the ongoing climate crisis and mitigate racial and economic inequity through "green" jobs. The Task Force authorizing resolution contains no specific end date.
- The Task Force was co-chaired representatives of the Common Council and County Board. Alderman Nik Kovac was a consistent leader on the Task Force, until he was recently appointed to Budget Director. The County Board is now on its third chair (in order: Supreme Moore Omokunde; Marcelia Nicholson; now Priscilla Coggs-Jones).
- Broad coalition of organizations have representatives on the Task Force.
- The Task Force completed its Preliminary Report in March 2020; ECO completed Greenhouse Gas Inventory and supported preliminary analysis and Climate Vulnerability report. Nine subcommittees and the Task Force met extensively throughout 2021, did public outreach, and submitted plan recommendations to the Steering and Rules Committee in March 2022.
- The Communications sub-group and Accountability subgroup have met periodically since March, but the broader Task Force has not. The Task Force has not yet presented its recommendations to the County Board.
- The Environmental Collaboration Office (ECO) is serving as the project manager to develop the final Climate and Equity Plan, which we hope the Council will adopt in December 2022. ECO has hired a FUSE Fellow, Deneine Powell, to support additional community outreach on the plan this summer and fall. Website is <u>Milwaukee.gov/ClimatePlan</u>
- ECO hired a consulting firm, GRAEF-USA, to produce the final plan in consultation with ECO and Task Force members. **GRAEF will have a draft documents for the Task Force to react to in mid-July/early August.**
- The Environmental Collaboration Office (ECO) has a strong track record of implementing climate related projects and has already begun implementing parts of the plan. See page 2 for specifics.
- Members of the Accountability Working group have met with Common Council President Perez and County Supervisor Priscilla Coggs-Jones in June, 2022. Possible next steps include:
  - Presenting working group recommendations to the County Board
  - Possible appointment of a co-chair from the Milwaukee Common Council
- Both the Milwaukee County Board and Milwaukee Common Council are in recess during August. The full Task Force may reconvene in September.
