<u>Proposal:</u> This file refers to a Minor Modification to the Detailed Planned Development

known as Good Hope Industrial Center to allow additional fencing and other site changes at HellermannTyton's facilities located at 6701 West Good Hope Road, on the south side of West Good Hope Road, west of North 60th Street, in the 9th

Aldermanic District.

HellermannTyton Corporation manufactures cable management identification and connectivity solutions for automotive, electrical and Datacom markets, and has been at this location for 8 years. It recently expanded its operations on the

site.

This minor modification was requested by HellermannTyton Corporation and will allow additional fencing and other site changes. Currently, a portion of the surface parking lot along Good Hope Road between the building and the street is enclosed with a 5 foot tall decorative metal fence. HellermannTyton proposes to modify the fencing to enclose all of the parking area, as well as secure the entrance to the site along Good Hope. Other site changes include the addition of a modular guard shack, turnstile, operable gates, raising arm barriers, expanding visitor parking and the addition of a pickup/drop off lane with crosswalk.

Adjacent Land Use:

The Uihlein Soccer Park is located directly west of the site, and is in the Parks zoning district (PK). The W.H. Brady Company Corporate Center General Planned

Development and Detailed Planned Developments are located directly east of the site. Properties across W Good Hope Rd. to the north include a country club and golf course, zoned as Institutional District (TL), and other properties zoned as Commercial Service (CS).

#### Consistency with Area Plan:

This site is located within the Northwest Side Comprehensive Area Plan boundary. The Minor Modification to the DPD is consistent with the recommendations of the Plan.
