Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 12/21/2018 at 2:10am officers conducted a licensed premise check at Tool Box, 1500 W. Scott St. The officer heard loud music coming from inside the bar and observed 5 people sitting at the bar with full drinks. The officer spoke with the applicant who stated they were having a private party, then stated all of the people were employees. The applicant appeared intoxicated and stated she didn't know it was 2:00am already. The posted license show closing hours of 11:59pm.
- 2. On 01/01/2019 at 3:00am officers conducted a licensed premise check at The Tool Box, 1500 W. Scott St. The officers found the door locked but could hear music from inside and observed a bartender and patrons inside. The door was opened by David TORRES and he stated he did not know he couldn't lock the door when the business was open. The officer observed a patron smoking at the bar and ashtrays on the bar. The applicant was cited for the violations.

3. On 02/14/2019 officers along with agents from the Wisconsin Department of Revenue conducted a licensed premise check at The Tool Box, 1500 W. Scott St. The applicant was cooperative and no violations were observed.

4. On 12/15/19 at 6:30pm, Milwaukee Police were dispatched to 1500 W. Scott Street for a battery complaint. Investigation revealed that a battery occurred inside the tavern between two patrons. The owner broke up the altercation and asked the aggressor to leave the establishment. The owner was cooperative with police and showed them surveillance footage of the incident.

5. On 02/21/21 at 6:14pm, Milwaukee Police were dispatched to 1500 W. Scott Street for a subject with gun complaint. Surveillance video revealed that two patrons were having a physical fight when a third subject walks up and points a handgun at one of the subjects. The actor with then gun then points his firearm at one of the subjects fleeing the location.

On Sunday February 21, 2021 I was dispatched to 1500 W Scott St at "The Tool Box" in the City and County of Milwaukee, WI for a subject with gun complaint.

This incident happened at "The Tool Box" bar which is a corner bar with an entrance facing South towards W Scott St. Entering the establishment, the bar is located on the east wall going north to south with a dart board and electronic slot machines approximately 20ft away from the bar following the west wall. The west wall opens up to a small pool table area.

On scene I spoke with the caller, identified verbally as Venustiano GONZALEZ (W/M 12/30/60) who stated he was sitting inside of the bar at the electronic slot machines. GONZALEZ stated while he was playing the games, he looked over his right shoulder and saw suspect number one, identified as Miguel GARZA (W/M 6/27/76) sitting at the bar. GONZALEZ stated after he looked over, GARZA came up to him pushed him off of the bar stool he was sitting on, and onto the floor. At which point GONZALEZ stated GARZA held a pistol to his head stating "I want to kill you". GONZALEZ stated he did not know why GARZA did this and he did not say anything else to him while this incident took place. GARZA was identified by the bar owner David TORRES (W/M 2/5/60) as well as GONZALEZ. GONZALEZ stated he knew GARZA because he used to date GARZA's aunt, Estela MARES (w/f 03-27-62). There was also a red Nissan Titan parked outside of the bar on W Scott St facing west, which came back registered to GARZA.

I also spoke to a patron at the bar, identified verbally as Regina OCHOA (W/F 2/26/93). OCHOA stated she was sitting in the middle of the bar next to GARZA when he got up and approached GONZALEZ. Per the bar surveillance video, OCHOA attempted to grab GARZA as he got up and swiftly approached GONZALEZ. OCHOA stated she did not hear/understand anything that was being said because it was in Spanish however heard something about "respect" as the GARZA and GONZALEZ got up. OCHOA had no further information about the incident.

I also spoke to the bartender, identified as Jason TORRES (W/M 10/16/60) who stated he was at the other end of the bar (north end) when the incident occurred. TORRES stated he did not see any of the incident and was unable to provide any further information.

David TORRES (owner) had showed up to the bar a few minutes after the incident took place so he was not able to give any information about the incident. David was however, able to identify GARZA while officers reviewed security camera footage of the incident. David stated he knows GARZA as a regular from the bar and was able to recognize him in the video.

After reviewing the bar security cameras, it was determined there was another actor. It is clearly seen in the video another white male approaches GARZA and GONZALEZ as they are on the floor and produces a black hand gun from his right coat pocket. Later in the video, it is seen that once GONZALEZ left the bar, the white male points the firearm towards GONZALEZ as he is running away. This male is identified by David as Jimmie VALDEZ-AZUALDA (W/M 3/28/65). David stated he knew that VALDEZ lived right down the street from the bar, at 1243 S 15th St. Squad 2221 P.O VELOZ and P.O ESPARZA went to that location in an attempt to locate VALDEZ. VALDEZ was located at 1243 S 15th St and taken into custody (see P.O VELOZ supplemental).

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
