1. Description of Grant Project/Program (Include Target Locations and Populations):

The City of Milwaukee Health Department's Office of Violence Prevention is proud to be awarded a new five-year federal grant through the Substance Abuse and Mental Health Services Administration (SAMHSA) for the funding opportunity **Resiliency in Communities After Stress and Trauma (ReCAST)**. Municipalities with high rates of gun violence along with incidents of systemic violence resulting in civil unrest were eligible to apply for funding. The purpose of the grant is to promote individual and community resilience through the implementation of evidence-based violence prevention and community youth engagement programs. An additional area of focus are linkages to trauma-informed behavioral health services. This grant opportunity/application preceded the events in Sherman Park. **The goal of ReCAST MKE** is for community entities to work together in ways that lead to improved behavioral health, empowered community residents, and reductions in trauma and sustained community change. Additionally, ReCAST MKE aims to provide Milwaukee with equitable access to culturally responsive resources and services to ensure that high-risk youth and their families benefit from evidence-informed engagement efforts, as well as linkages to trauma-informed behavioral health services. The approach intends to strengthen the integration of behavioral health services and other community systems to address the needs of high-risk youth and families and to build the extent to which Milwaukee is resilient and healing-centered.

2. Relationship to City-Wide Strategic Goals and Departmental Objectives:

This grant supports the city of Milwaukee's commitment to advance a safe and healthy city.

Need for Grant Funds and Impact on Other Departmental Operations (Applies only to Programs):

The grant defined **civil unrest** as demonstrations of mass protest and mobilization, community harm, and disruption through violence often connected with law enforcement issues, noting that communities that have experienced civil unrest share similar characteristics:

- Barriers to access and lack of social services, health care, legal and political representation, housing, employment, and education;
- Current and historic strains in community and public sector relationships, e.g., law enforcement, school, health, and/or housing and community relationships;
- Racial/ethnic minority and marginalized populations with experiences of poverty and inequality; and
- Increased risk of mental illness for individuals who experience trauma and do not receive support.

While a lack of income, living wage employment, stable housing, and healthy neighborhoods are still persistent issues, we have identified specific needs, gaps and challenges related to trauma and violence prevention:

- Too many families are grieving losses due to COVID-19, with too few culturally relevant resources to process grief and trauma in non-harmful ways. A Community Healing Network is needed with culturally relevant grief support including support from others who have survived losses and traumas.
- Too many youth are faced with processing complex trauma and ACEs but never given the tools to do so. We need to prioritize the integration of strategies that foster social emotional learning into youth programming and schools as a primary prevention approach. This can give youth the tools they need for resilient mental wellness before they encounter trauma.
- Milwaukee's crisis response efforts have been passionate and well-intentioned, but disjointed and lacking coordination. A
 coordinated, culturally responsive Crisis Response Network for youth and families, including connections to community resources and
 trauma-informed behavioral health services is needed.

The project aims to raise awareness, increase understanding and address some of the long-standing, root causes of structural and community violence in Milwaukee while advancing interventions that reach youth and families in greatest needs of opportunities and supports.

- 2.1 meetings per year, to create a more coordinated response system, with annual focus groups tracking increased coordination over time.
- Obj. Strategically deploy mental health clinicians to areas of known unmet/emerging needs on an ongoing basis,
- 2.2 including crisis response for vulnerable youth and their families; facilitation of group healing circles to process trauma; initial stabilization sessions with youth/families in crisis; and vicarious trauma support for the 414LIFE violence interrupters. At least 85% of those completing follow-up interviews 3 or more months after their initial intervention will report that they felt supported in their time of crisis with basic needs being met.
