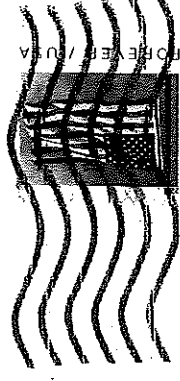
I am in requesting an hearing on the denial of our claim. We respectfully disagree with the decision and believe our video cameras and pictures will prove otherwise.


We are in receipt of your claim for damages in the amount of \$1,574.17 to your vehicle resulting from a fallen branch from a City tree located at 4900 North 19th Street on November 16, 2021.

Our investigation revealed that in response to this claim, the City of Milwaukee Forestry Department searched their records going back six years, and found no calls, requests, or complaints regarding this tree. After receipt of this claim, the tree in question was inspected and found to be healthy with no defects.

It is our position that the city has no negligence in this matter, and cannot accept liability for damages to your vehicle. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

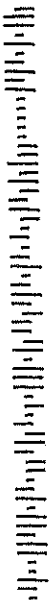

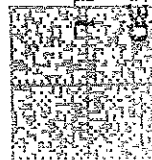
