

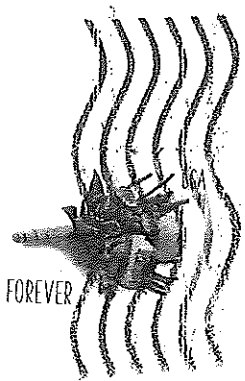

Dear Ms. McGowan:

We are in receipt of your claim in the amount of \$3,820.24, relating to damages sustained to your 2019 Land Rover, on January 23, 2022, when it was parked in front of your home at 9416 W. Melvina Street.

Our investigation reveals that on February 8, 2022, the Department of Public Works-Operations Division received a call regarding damages to your vehicle. In addition to that call, you also submitted footage from your home surveillance camera that captured a city plow truck plowing past your parked vehicle. The video footage does not show that the City snowplow made contact with your vehicle.

There is no evidence that a City plow truck caused damages to your vehicle. As such, the City is not liable for your damages to your vehicle and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
