Dear Ms. Merriweather:

We are in receipt of your claim regarding damages sustained to your 2010 Subaru Outback, on April 8, 2022, when your vehicle struck a pothole located on or near N. 28th Street and Vine Street.

Our investigation reveals that the Infrastructure Division completed a search of call center records from January 1, 2022 through April 8, 2022, and there were no calls reported regarding the 2800 block of W. Vine Street. On April 26, 2022, the Infrastructure Division further reported they received a call regarding the location of 2700 through 3000 W. Vine Street and completed the patch on April 28, 2022.

The City had no prior knowledge of a hazard in the roadway near the 2800 block of W. Vine Street prior to April 8, 2022, when your damage occurred. As such, the City of Milwaukee is not liable for your damages and we are denying your claim.

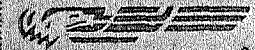
