Dear Commissioners:

Seventeen (17) recommended 911 Telecommunicator appointments are scheduled to begin on Monday, September 19, 2022 (submitted under separate cover), if there are no withdrawals on or prior to that date. If our past experience is an indication, the actual size of these appointments may be smaller as we may lose some individuals for various reasons by the time they are scheduled to begin.

These appointments are contingent upon successful completion of a pre-employment medical examination, drug screening, psychological test, background update, and the number of regularly appointed 911 Telecommunicators reporting for duty on Monday, September 19, 2022.

The recommended contingency appointment of these individuals shall become effective no earlier than Monday, September 19, 2022, and no later than September 26, 2022. Because it will be difficult to provide reasonable advance notice to these individuals subject to a contingency appointment, actual appointments will be predicated on their availability for work and may necessarily be out of eligibility list rank order. The individuals listed above for contingency appointment will retain their position on the 911 Telecommunicator eligible list for appointment consideration to the next occurring appointments if he or she is not appointed on September 19, 2022, unless the list expires or is rescinded.
