These appointments are contingent upon successful completion of a pre-employment medical examination, drug screening, psychological test, background update, and the number of regularly appointed 911 Telecommunicators reporting for duty on Monday, September 19, 2022.

The recommended contingency appointment of these individuals shall become effective no earlier than Monday, September 19, 2022, and no later than September 26, 2022. Because it will be difficult to provide reasonable advance notice to these individuals subject to a contingency appointment, actual appointments will be predicated on their availability for work and may necessarily be out of eligibility list rank order.
