Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. #### INITIAL INVESTIGATION

Finley, Jason T 029192

This report is written by Police Officer Jason FINLEY, assigned to District Four, Late Power Shift, Squad 4431.

On Sunday, October 31, 2021 at approximately 4:21 PM myself (in full duty uniform, marked MPD squad, and equipped with AXON 3 body camera) volunteered to meet Squad 4214 Sergeant Gregory HUNTER regarding and injured person (work place injury) and 6000 West Silver Spring Drive (Family Dollar) located in the City and County, State of Wisconsin.

Upon arrival, I met with the victim, verbally identified as Jessica JAIMES (f/b, 05/04/88) at the front of the store. While speaking with JAIMES I observed a laceration that was bleeding above the left eyebrow.

JAIMES stated she was the on-duty manager of the store, and was working in Aisle 13 restocking shelves. JAIMES stated while she was pushing a large cart down the isle, the cart struck an overhead camera that was hanging from the ceiling which is used to prevent shoplifting from the store. JAIMES stated when the cart struck the camera, the camera fell from the bracket on the ceiling and struck her in the head.

JAIMES stated she yelled for help once it occurred and another employee had come to her aid, later identified as Braxton L. DODD (f/b, 10/11/96) and called 911.

JAIMES stated there were no witness to the incident, but stated the incident should be on camera, as the camera that fell on her was operational.

JAIMES stated the camera was just recently installed within the past two weeks or so, and stated there was a customer that also struck the camera approximately two days ago and she believes that it may have been loose from that incident and that is why it had fallen today.

JAIMES stated she has only been working at Family Dollar for several months, and could not remember exactly when she started. JAIMES stated she has not ever had any prior work related injuries.

JAIMES stated she did not lose consciousness, and declined any medical attention on-scene. JAIMES stated she was not feeling well from the incident and stated she was going to go to an area hospital (possibly St. Joseph's) for medical attention once her ride was able to pick her up.

The Milwaukee Fire Department Engine 9 and MED 16 did respond to the scene, but left prior to police arrival. JAIMES stated she asked paramedics if the laceration was going to require stitches, and they told her they did not believe so.



The hearing before the Licenses Committee will take place virtually on 09/02/2022 at 09:15 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
