I am writing to object to the Class

A Liquor & Malt license filed for the property at 2865 N. Murray Avenue.

As an Eastside parent and resident, this is exactly the kind of store we do NOT need within a half mile radius of a block that has at least 50 children on its streets (and I am speaking just for three blocks of Stowell).

There are plenty of other stores where these vaping needs may be met. Though I would argue those stores are too many as well given the demographics of our neighborhood and the number of college kids in the area. In addition to substance abuse problems experienced by growing numbers of American children (including a 61 percent increase in drug use by eighth graders between 2016 to 2020), Milwaukee is experiencing a massive increase in reckless driving. Reckless driving and intoxication are a dangerous combination.

We see this regularly as cars whizz past children playing ball in the front yards.

Let's not add one more store that encourages and enables this kind of reckless behavior.

I strongly urge you to consider my request to reject a Class A Liquor & Malt License for the proposed Serenity420 establishment at 2865 N. Murray Avenue.

nand am writing to express my opposition to the granting of a liquor license to the applicant at 2865 North Murray Avenue in the Third Aldermanic District. With the current absence of aldermanic representation in the Third District, and until the election later this year, there is nobody to advise residents, and no one to receive input on the approval or disapproval of a license in this heavily residential location.

My reasons for opposing the granting of the license are as follows:

- 1. There are (3 within less than one mile) an adequate number of liquor stores within close proximity of the proposed site.
- 2. The neighborhood has virtually no off-street parking, limiting residents to on-street parking that is already extremely crowded. The proposed liquor store will only increase the existing on-street parking problem.

- 3. Because the proposed site is on a straight path to Bradford Beach and Lake Park, it has a high potential to increase the drinking and driving problem at both sites.
- 4. A liquor store is not conducive to the neighborhood and traffic patterns.

As a long-term resident on the block on which the application is being made, I am requesting aldermanic representation, counsel and consideration of this proposal before a license is granted. I believe in my heart of hearts that granting of a license to this type of establishment is not in the best interest of the neighborhood and will not be an asset to the area.

I am writing to oppose any liquor license for this location, on the corner of North Murray Ave and Locust St. in Milwaukee.

This location is in the middle of a residential district with no other food or drink services nearby and this would be very out of character for the location.

Additionally, because the primary residents of this area are University of Milwaukee students, most of which are under the age of 21, it would be putting a liquor store in an area where one isn't needed because those under age 21 are not allowed to shop there. There is a great deal of underage and illegal drinking in this neighborhood already due to the UWM Student population and if a liquor store were to be added in this neighborhood it would exacerbate the growing illegal use of alcohol without any further controls. It makes no sense to license a product (liquor) in an area where the local community (students) cannot purchase it.

Further there is no need for a liquor license on this corner because there is a full liquor store in the commercial district on Oakland Ave just 2 blocks west, and another Convenience store with a liquor license 2 blocks South. This area is well served already with liquor licenses there is no demand for another one.

As an eastside parent and resident, I patronized the Bikesmith several times yearly to purchase bike accessories, request a bike tuneup and even shop for a bike in the business formerly located at the now-vacant <u>2865 N. Murray Avenue</u> commercial address.

While I do not vape currently, I know that any neighborhood vaping needs can be easily serviced at one of the following locations:

- · Bambam's Smoke Shop & Hookah Lounge (3116 N. Downer Ave.)
- · Blue Dream Vape & Smoke Shop (3473 N. Oakland Ave.)
- · The Glass House Vape and Smoke Shop (2334 N. Farwell Avenue)
- Knuckleheads CBD & Vapes (2949 N. Oakland Ave.)
- · Milwaukee Vapor (3470 N. Oakland Ave.)
- · Purple Haze Smoke Shop (1653 N. Farwell Avenue)
- · Shirazi Market (2864 N. Oakland Ave.).

These seven vape vendors all are located within minutes (on foot or on bike or by car) of <u>2865 N. By way of introduction, my name i. and with my I and I I am writing to strenuously object to the Class A Liquor & Malt license filed for the property at 2865 N. Murray Avenue as this proposed use does conform to the residential uses of the neighborhood. This location is literally surrounded by homes and personal

Frankly, it is offensive that the licensee applicant is even pursuing a liquor and vape license in the middle of our bucolic, family neighborhood, colloquially referred to as the "Upper East Side" of Milwaukee. We are a small community comprised of families, professionals, students, children, and retirees. The notion that a former neighborhood bike shop would be replaced with liquor and vapes is unbelievable. As my fellow neighbors have written in their own letters to you, Oakland Avenue has an abundance of smoke, vape, and liquor stores and the one proposed for 2865 N. Murray is wholly unnecessary and unwanted.

In addition, this proposed business would be located within blocks of several grade schools and a high school:

Riverside University High School

The American Academy of Pediatrics has taken a strong stance against vape use by youth and young adults. Per the AAP, vape products have grown rapidly, particularly among youth and young adults, and youth use of e-cigarettes is a significant health problem. E-Cigarettes are the most commonly-used tobacco products among youth, and use is rising at an alarming rate. In 2020, 19.6% of high school students and 4.7% of middle school students reported having used e-cigarettes in the last 30 days, according to CDC data. Youth use of e-cigarettes has increased dramatically in recent years. Youth who use e-cigarettes are more likely to use cigarettes or other tobacco products, research and a Surgeon General's report has shown. Youth who use e-cigarettes are at higher risk of transitioning to traditional cigarettes, according to an AAP Policy Statement. Youth are uniquely vulnerable to the nicotine in e-cigarettes because their brains are still developing, CDC data has shown. www.aap.org/en/patient-care/tobacco-control-and-prevention/e-cigarettes-and-vaping.

To locate yet another vape shop, even closer to where our children live and go to school is inappropriate and dangerous. The owners of the proposed shop want to financially profit from the building's location to young college-aged students at UW-M and teenagers attending Riverside High School, and our adolescents. The presence of a vape and liquor store is wholly inconsistent with the needs of the neighborhood and is NOT supported by anyone in the community.

In addition, a liquor and vape shop will create undue offense, annoyance, disturbances, and inconvenience to those who live within the neighborhood. Furthermore, such a store will cause an increase in harm from alcohol abuse and associated violence. Again, all of which are wholly inconsistent with the residential character of the neighborhood. Locating a liquor vape store in the middle of our residential neighborhood will also have a negative impact on the value of our properties and is in no way an amenity.

In light of the negative impacts such a business would have on our community- increased crime and noise, increased harm to children, decrease in property value, its non-conforming use, I am urging you to reject the Class A Liquor & Malt License for the proposed Serenity420 establishment at 2865 N. Murray Avenue. Our neighborhood, and our children, deserve more than a corner liquor and vape shop. Perhaps the owner can look at the North end of Oakland, in Shorewood or Whitefish Bay.

I would like to object to the Class A Liquor & Malt license

filed for the location at 2865 N. Murray Avenue.

This property is in the middle of a residential area, and thus it is not a good location for a business selling liquor and vaping supplies. There are many families in this neighborhood, with about 40 children on between the 2800 and 3000 blocks of Prospect, and about 50 children between the 2700 and 3000 blocks of

Stowell. (These are just neighbors on the surrounding blocks, and there are obviously many more children in the surrounding area.) I think this may be seen as a college area, but there are many children here, and we do not want them growing up with this type of business within a couple blocks of their home. Obviously, we do not want them tempted to buy these products, and I know that some of these businesses are selling liquor and vaping products to minors.

We have a plethora of liquor and vaping stores in this area that are within a few blocks of this location, so this business is not needed here:

As an eastside parent and resident, I patronized the Bikesmith several times to purchase bike accessories and request a bike tuneup in the business formerly located at the now-vacant 2865 N. Murray Avenue commercial address.

The neighborhood has a full array of vape and alcohol suppliers and this location does not need one more. Any neighborhood vaping needs can be easily serviced at one of the following locations:

- Bambam's Smoke Shop & Hookah Lounge (3116 N. Downer Ave.)
- Blue Dream Vape & Smoke Shop (3473 N. Oakland Ave.)
- The Glass House Vape and Smoke Shop (2334 N. Farwell Avenue)
- Knuckleheads CBD & Vapes (2949 N. Oakland Ave.)
- Milwaukee Vapor (3470 N. Oakland Ave.)
- Purple Haze Smoke Shop (1653 N. Farwell Avenue)
- Shirazi Market (2864 N. Oakland Ave.).

These seven vape vendors all are located within minutes (on foot or on bike or by car) of 2865 N. Murray Avenue, in addition to three nearby establishments that carry malt liquor products and are located within one mile of 2865 N. Murray Avenue (Gilbert's on Oakland and Downer Wine & Spirts). Indeed, Parkside Liquor & Grocery (2700 N. Murray Ave.) carries BOTH liquor AND vaping products and is located just two blocks south of 2865 N. Approximately fifty children live in the 2700 to 3000 blocks of Stowell Avenue, and that's just a small sample of our eastside-family population. As city officials and entrepreneurs, can you honestly tell us that our children need another vape or alcohol vendor in their neighborhood?

I know for a fact that some of the above establishments sell <u>unregulated</u> Delta 8 THC gummies. Reckless driving and intoxication are a dangerous combination. Our neighborhood is saturated with vape-and-liquor vendors. Let's find a healthier and more diverse way to contribute to the commercial and cultural vibrancy of Milwaukee's east side.




City Concentration Map

- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
