OBJECTION TO COMMITTEE FINDINGS OF FACT, CONCLUSIONS OF LAW
AND RECOMMENDATION

ISSUE 1: MOTION TO SUPPRESS ANY STATEMENTS, MOTIONS, OR
VOTES OF THE ALDERMAN OF THE 14TH DISTRICT.

Competitive Ventures, LLC, hereinafter referred to as licensee now appears by its Attorney, Andrew P. Arena hereby files these written objections in the above referenced matter. The first objection involves a motion, which was filed by the licensee for the Alderman of the 14th District to be removed from the Committee, or for recusal. This motion was based on *Marris v. City of Cedarburg*, where the Supreme Court held that it is a violation of due process to have a person, who has demonstrated a pre-judgment of the issue be involved as a fact finder. In response to this motion Alderman Zielinski voluntarily left the Committee and came to the other side of the table and announced that he was going for non-renewal of the license at the fact finding hearing, and at the Common Council meeting if necessary. As a matter of fact and law there is clearly a bias and pre-judgment that is clear in the record. Pursuant to this recusal the Alderman of the 14th should still be removed from the Council for this matter. The Alderman represented his constituency at the hearing and decided that his recusal was in their best interest. The Milwaukee Code of Ordinances only allows the licensee and any complainant to the renewal five minutes to

address the council, if they file a written objection by the set dead line. Unless the Alderman of the 14th District has filed such a written objection he is time barred from addressing the Common Council pursuant to the Cities own ordinance at Chapter 90-2-d-2.

Wherefore, the Licensee, moves this honorable body to deny the Alderman of the 14th to address the Council in this matter, to make any motions in this matter, and to have a vote on any item concerning the renewal of the Licensee.

OBJECTION TO FINDINGS OF FACT

The Licensee objects to the recommendation of the Committee concerning the amendment of the plan of operation to exclude the deck as part of the premises. This is a tavern and restaurant that serves a full menu of lunches and dinners. To have such a restriction would create a competitive disadvantage to this business, as there are two very similar places within one block of this location, and one of them does have an extensive outdoor seating area. It is the Licensee's position that less drastic amendments to the plan of operation could be implemented that would result in the Licensee's business to have a chance to survive. The Licensee as was stated at the hearing does not have speakers or play any music on this deck. The Licensee has a digital video and audio recording system that captures the entire seating area and surrounding property. The Licensee could close the deck at a reasonable time for food and beverage service such as at 9:30 or 10:00 p.m. The Licensee has employed security to be on the deck during business hours and would continue to do so in the event that the plan of operation is amended to allow the extension of the premises on the deck.

The Licensee objects to any reference to a police report in this matter. Items in the police report concerned citations that were dismissed in Court with findings that there were no

violations of law as to the operation. As part of the notice there was an allegation that the Licensee was involved in a collusive agreement concerning the operation of the location. This allegation was investigated by the Police License Investigation Unit and the result was that there wasn't enough evidence to issue a citation. As this was an allegation created by a neighbor who has demonstrated a willingness to fabricate and a desire to get the establishment closed at all costs, it hardly is an item worthy of any further consideration. There was no evidence that Christina Elliott was not the sole decision maker, and not the sole beneficiary of the profits. There was testimony by license clerks concerning statements made by the licensee that were misconstrued, and actually in the same statement contradicted. This particular license clerk filed a statement in the file that acknowledged that the alleged operator told Christina Elliott in the license division office that all the decisions were up to Christina Elliott. When pressed this license clerk stated that based upon a neighborhood complaint she got the impression that there was a collusive agreement.

On this issue the Committee, based on statements made in the motion, and by the chair that there wasn't adequate proof to discipline the license based upon the allegation of a collusive agreement. There was no witness that stated they had made observations from inside the tavern that validated that Christina Elliott was in fact not operating the business. There were no business records or proof presented. There was discussion that an owner of a business has a right to hire people to do tasks and do things to run the business, but it is not proof of a collusive agreement. This issue was truly a red herring, and was designed to create a reason for non-renewal, when in fact there was no evidence of fights, violence, or any violations of any City Ordinance before the Committee. There was a citation issued for use of the deck, which was

dismissed by the Court, after the City Attorney conceded that the deck had an extension of premises, and the citation was based upon an improper order by the Department of Neighborhood Services. As a placard was issued for the deck, due to a view that the Board of Zoning Appeals granted a special use permit for an outdoor volleyball court and deck, it was determined that this placard was illegal. The special use was granted for an outdoor recreation area. The application mentioned the deck, however, the zoning of Howell avenue in this area would allow the deck without a special permit. The end result was that the City took action that caused the licensee to not use the deck until the first week of September.

The fact that the deck was not used for the entire summer and volleyball was not played voluntarily by the licensee actually demonstrates that the neighbors complaints about noise were incredible. Items in paragraph 3 of the findings of fact and 5A concern the testimony of three neighbors. Two of these individuals were married and live in a property on the lot line on the old volleyball court. This lot line is divided by a 10 foot high wood fence, that this neighbor described as blocking her view, unless she went right up to the fence and looked through gaps in the wood. This neighbor complained about noise in a general sense without any specific dates, a written journal, or any other proof that any disturbance occurred. This neighbor is known as Kelly Murphy, who is an individual that has demonstrated a desire to get the location closed for many years. This neighbor's position is so strong that it is not hard to believe that she would embellish and make things up. This neighbor claimed that she couldn't see the deck or bar from her home, but on the other hand she called the police to report people on the front side of the establishment with alcohol on the sidewalk. This statement is a complete fabrication because she would have to see this activity through a fence and raised deck. This individual called the police

with such regularity that the Captain of the District testified that he knew who she was and that the complaints caused him to order close monitoring of Jersey's. As a result when Kelly Murphy made a complaint there was an Officer close by that responded usually in a matter of minutes. One such occasion was 9/14/10 when a noise complaint was made at 1:03 and the squad Linda Conrad arrived at 1:06 and found the complaint to be baseless and issued no citations. Kelly Murphy claimed that she couldn't use her yard or house because of noise and profane language, but admitted that she walked her dog at the front door. She has called the police for vehicles parked without registration tags and for any other issue she can report. All of these things were investigated by the Police Department and citations were never issued.

The husband, Mr. Murphy, joined in the testimony and claimed the noise was so bad that he couldn't be in his garage. These people have a swimming pool on their driveway, and constantly walk by the location looking for something to report to the police. The Licensee testified that she waives at these individuals regularly, yet they claim they never saw her at Jersey's, but only at last year's renewal hearing, thus, they know who she is. They admitted they walk their dogs by the location, after the Licensee stated she saw them walk by.

A third neighbor complained about people parking in front of her house. She also claimed that people were sitting on her porch. She could not prove these people were patrons of Jersey's and there was no call to the police to report this alleged trespass. This woman actually testified to the exact same thing during the last renewal of the license. The three neighbors all testified in a general sense. There were no journals, dates, or any proof that substantiated their claims. The three individuals claimed they had peace only when the location was closed. If the business creates that much of a disturbance one would think that a lot more than two households

would have come forward to testify. Their stories are completely incredible due to the fact that the location did not use the deck for 9 months including the entire summer and there was no volleyball played. Also, four Police Officers that work in the area and actually go in the location regularly directly refuted the claims.

As evidence the Licensee presented one neighbor that owned property right next door to Jersey's and rented to three residential tenants upstairs. It was her testimony that there were never noise or litter problems, and that her tenants never complained. This witness stated that her and her partner were often at work until very late hours sometimes past 11:00 p.m.

As further evidence that the two neighbors objecting based on noise are incredible the licensee called as witnesses three police officers and the Captain of the District. All of these officers described Jersey's as a place that had no problems with unruly patrons or excessive noise. Due to the calls of the neighbor and requests from the Alderman the Police had a tavern squad do business checks at least three times a week, and sometimes the checks were done every day. On two occasions tavern checks were done twice in one night. These Officers stated that they understood the noise ordinance and always approached from 50 feet away, and they could not hear noise. All the Officer's testified that they never issued a citation for noise, and they didn't think that the business had a noise issue, or unruly patrons.

Officer Tyler Kirkvold testified that he was assigned to the tavern squad and that he was requested by his district supervisors to check on Jersey's on a regular basis. This Officer went to the location on routine tavern checks 15 times. This Officer investigated the use of the deck and found the license stated that there was an extension of premises. Based upon a complaint of the neighbor, Kelly Murphy, he was sent back the next day to write a citation for a violation of the

DNS order and then he wrote a subsequent citation for an use of the deck without a liquor license. This Officer was asked to communicate directly with the Alderman of the District and he did e-mail him that the citations were issued. This Officer also testified that the location is not a problem location. Noise is not unreasonable, and no citations for noise or any other violations were written to Jersey's. He also testified that his job is to do checks at all of the taverns in the district, and usually goes to a tavern approximately once every three weeks. However, Jersey's had a business check every three days.

Officer Kristopher Maduscha testified that he went to the location doing checks 17 times. On 3/23/10 he went to the location two times 45 minutes apart and on 5/15/10 he was there twice in three hours. The Licensee submitted over 40 C.A.D reports that indicate the tavern checks were done after 11:00 p.m. and that the investigations revealed no violations.

Officer Linda Conrad testified that she is a patrol officer and her patrol area is Howell Avenue and the area that Jersey's is in. She stated that her Supervisor's wanted her to check on Jersey's for unruly customers. She testified that there wasn't a noise problem or a problem with unruly customers. On a September evening she responded to a complaint made by Kelly Murphy within moments and found no patrons on the deck making noise. This Officer also testified that there is no problem with cars parking illegally or creating a problem. She stated she would give parking tickets if that was the case. This Officer also testified that she did not observe disorderly, or unruly customers on the street or in and around Jersey's. She also acknowledged that the deck had no speakers, and did not play any music outside at night or ever. She was also aware that the location had its customers park in a WE owned lot, and a bank lot pursuant to an agreement that Jersey's had with those companies.

Captain Young from the Police District also testified that due to complaints of the neighbor known as Kelly Murphy and the Alderman there was a policy to review the operations of Jersey's.

Due to time the Licensee was unable to have several key witnesses testify, that included actual neighbors that would have refuted the two households that complained in a general way. Additionally, the Licensee only answered a couple of questions by members of the Committee, but was not allowed to testify on her own behalf.

The Licensee affirmatively states that there is no proof that she does not operate the business. She submitted as evidence a video of a story done by WTMJ 4 giving her an award for cleanliness, wherein she is seen in the location and at work. This story is done without notice, so she could not arrange to be present because she was told they were coming ahead of time. She has never been issued a noise citation and several noise complaints were found to be baseless by the Milwaukee Police Department. The Licensee has been granted a Class B License in the past and initially the Council found that she met the legal requirements to be issued such a license. Since there are no violations of law and actually overwhelming supportive testimony by the Officers of the Milwaukee Police Department assigned to investigate this business the license should be renewed. The Licensee also begs that a motion be made and entertained that would modify the plan of operation to include the deck, and if necessary to include the deck with reasonable limitations.

The Committee's recommendation was based on a motion of Alderman Kovac for a renewal with a warning letter and the amendment of the plan of operation to remove the deck as part of the premises based upon the neighborhood objection.

The neighborhood objection based upon the above statements does not provide adequate proof or a record that should be the basis of the removal of alcohol from the deck from the plan of operation.
