This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 08/21/18 at 2:27pm, Milwaukee Police were dispatched to 6798 W. Appleton Avenue (American Inn Motel) for a dead on entry complaint. Officers interviewed the owner of the motel who was cooperative during the investigation and supplied officers with video surveillance of the time surrounding the incident. The owner also informed the officers that when he is away from the motel, he constantly watches the security cameras from his telephone and has an ID scanner which he is going to install at the check-in counter. This device will record who rents from him in order to keep a "banned" list for himself and other motels in the area. Detectives determined that the death investigation was not suspicious and the cause was undetermined at the time of this report. An Incident Report was filed (172330108)
- 2. On 01/12/19 at 3:00pm, a subject walked into the Third District to report his vehicle was stolen. Investigation revealed that the subject was staying at a hotel, with a female, whom he only knows by first name, at 6798 W. Appleton Avenue. The subject fell asleep and when he woke up, noticed that the female and his vehicle were missing. The subject stated that the female rented the room, so police called and retrieved the females information from the front desk employee.

- 3. On 05/09/19 at 6:16am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a welfare check. Upon arrival, officers observed a female on the sidewalk waving her arms and making noises. The hotel manager led officers to the females room where they found the door open and suspected narcotics inside. The female was conveyed to the hospital.
- 4. On 07/13/19 at 7:30pm, Milwaukee Police were dispatched to 6766 W. Appleton Avenue for an accident. Investigation revealed that after the accident occurred, the vehicles moved to 6798, W. Appleton Avenue where an argument ensued with the driver of one of the vehicles pulling out a gun and pointing it at the other driver. A hotel employee was able to provide surveillance footage of the incident.
- 5. On 12/19/19 at 10:03am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a shooting complaint. Upon arrival, one of the occupants in the room stated that she and her boyfriend were playing with a gun and it went off striking the victim, rendering him pulseless/not breathing. Investigation revealed that the occupant/suspect had been renting the room for the past two weeks and the victim was a daily visitor to the room and had been staying on a nightly basis. The occupant was arrested for her involvement in the incident.
- 6. On 01/01/20 at 4:00am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a sick/injured complaint. Upon arrival, officers interviewed the caller/manager who stated that he received a call at the front desk from one of the occupants in the hotel saying that they heard a weird noise from the room directly below them. The manager went to the room to investigate and after receiving no response from the hotel room door, the manager opened the room to find the occupant unresponsive, so he called police. The subject, who still had a syringe in her arm, received three doses of NARCAN and was transported to the hospital. Inside the room there were various items of drug paraphernalia.
- 7. On 02/20/20 at 1:31pm, Milwaukee Police conducted a meeting at the Seventh District with the applicant regarding the high calls for service and the shooting which occurred on 12/19/19. The applicant told police that he is now requiring identification for all guests staying in the room and if they catch anyone doing anything "suspicious" they would be put on a "Do Not Rent" list. This list is shared with his other hotels and the surrounding hotels in the vicinity. Other policy changes are that employees are going to require identification from persons seen entering a room more than once and he will now employ a security guard who will monitor the property. The applicant said that he and his wife will start splitting time between his other hotel and he was advised to come up with additional plans to combat the issues at his properties.
- 8. On 05/14/20 at 3:30am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a sexual assault complaint. Investigation revealed that a female was abducted, taken to the hotel, and was sexually assaulted. The subject was able to go to the front desk and use the phone to call police.

9. On 07/07/20 at 10:43pm, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for an over dose complaint. Officers met Milwaukee Fire Department Medical in room #205. Medical personal was performing Advance Circulation Life Support (A.C.L.S.) on a white female; the female's boyfriend was also in the room. After several attempts the A.C.L.S. was unsuccessful and a time of death was given. Officers turned over the investigation to Sgt. Baker of the Criminal Investigation Bureau.

- 10. On 07/11/20 at approximately 1:22pm, Milwaukee Police were investigating an overdose complaint at 6731 W. Keefe Ave. Officers spoke with the victim's friend who was at the scene. The friend stated that prior to the overdose, they stayed at the American Hotel, located at 6798 W. Appleton Ave. Officers spoke with the manger on scene that provided officers with pertain information, such as vehicle, renter and check out information.
- 11. On 09/06/20 at 12:11am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a trouble with subject complaint. Officers spoke with the agent who stated that he was trying to have three long stay room renters vacate the hotel. The agent explained that his license is set to expire at 09/06/20 by 11:59 pm. The agent stated that he notified the renters that they would have to make other accommodations, but they are refusing to leave. The agent further stated that he has a license renewal hearing on 09/08/20. Officers spoke with the renters who stated that they have nowhere else to go and were recently notified to leave. Officers requested a supervisor to the scene who stated that the renters could stay until the hearing 09/08/20, however if the establishment's license is not renewed they would have to vacant the location.
- 12. On 12/05/20 at 11:37am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a trouble with subject complaint. Officers spoke with the manager who stated that a renter in room 105 is refusing to leave after check out time. Officers spoke with the female who stated that she was diagnosed with Corvid and that 211, was supposed to pay for her extended room stay. Investigation determined that her quarantine was over and that 211 made no such accommodations for the subject. The female was conveyed away from the location by the officers.
- 13. On 04/17/21 at 6:12pm, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a Battery DV complaint. Officers spoke with the victim who stated that her boyfriend had struck her in her hotel room. The victim stated that the suspect left the scene after also hitting the manager. Shortly after speaking with the victim, she left the location prior to officers finishing the investigation. Officers spoke with agent was cooperative and provided officers with suspect check in information. The manger also stated that he only observed verbal arguing nothing physical, and asked both parties to leave the hotel.

- 14. On 05/29/21 at 4:52pm, Milwaukee Police were dispatched to 6789 W. Appleton Avenue for a welfare of citizen complaint. Investigation revealed that a couple, who met on the app "Meet Up" were going to the movies but had been in the hotel "cuddling" when the female half could not stay awake. She told officers that she was given three Percocet's by an unknown male and did not want to answer anymore questions. The subject was conveyed to the hospital by the Milwaukee Fire Department. The front desk clerk gave officers photocopies of the subjects who rented the room and said they checked in on 05/28/22.
- 15. On 09/26/21 at 3:02pm, Milwaukee Police were dispatched to 6789 W. Appleton Avenue for a shooting complaint. Investigation revealed that the applicant had called the police on a group of subjects who refused to leave the outside of the premises earlier in the day but they kept returning throughout the day. On the third occurrence, the applicant was walking inside to, again, call the police and he heard shots being fired. One subject was shot in the leg and the applicant was extremely cooperative and provided police with video surveillance regarding the incident. The incident started when two parties picked that location, through Facebook, to meet and fight.

16. On 05/15/22 at 1131am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for an overdose complaint. Investigation revealed that an employee was knocking on all the doors telling occupants that it was time to check out when he received no answer from the victims door. When he opened it to check on the subject he found him on the floor not breathing. He called for help and a subject, from the next room, began CPR and he called police. Milwaukee Fire Department arrived on scene and revived the subject with Narcan. The subject was conveyed to the hospital. The subject told officers that he went to the hotel and brought drugs from a random person at the hotel.

We responded to a Welfare Citizen call for service at this address from "Moses." "Moses" stated that he was calling for a welfare check for his female friend who he identified as "Chloe." "Moses" stated "Chloe" was given pills by an unknown male and "can't stay up." We arrived on scene and spoke with Priscilla KOEHLER (w/f, 08-17-1997) who resides at 537 N Military Drive, Fond Du Lac Ave. KOEHLER initially identified herself as "Chloe" but later stated her legal name. KOEHLER stated that on 05-28-2021 she arrived at the the American Inn by an unknown means and given 3 Percocets by and unknown male. KOEHLER stated that she does not know how she got to the motel but just woke up there. KOEHLER stated that she admitted that she knew who gave her the pills as "Blackie." KOEHLER stated that she did not want to answer any more of our questions because she was going in and out of consciousness. It should be noted that KOEHLER was conscious during our entire interview. KOEHLER jus repeated that she wanted to go home and would not cooperate with our investigation.

Approximately 3 minutes into our interview. a black male exited the bathroom after putting on his shoes, the male identified himself as James SIMM B/m, 06-20-92. Simm stated that he met "Chloe" on the Meet Up app for a date. I asked SIMM what this date entailed and he stated that they were going to go to the movies. I asked SIMM why he was still at the motel and not at the movies. SIMM stated that he and "Chloe" were "cuddling and that's It." I asked KOEHLER out of earshot of SIMM what SIMM's purpose was and stated that they were just cuddling.

Milwaukee Fire Department Med 1 responded to the scene and conveyed KOEHLER to St Joseph's Hospital (5000 W Chambers St.) Prior to securing the room I observed a pair of pink floral panties soaking in the sink and several wet towels on the floor. Also inside the motel were several boxes of cereal and snacks and an approximately 3 gallon bucket of cheddar cheese balls on the dresser.

KOEHLER called her mother "Sara" at 920-960-0705 to tell her what happened. PO OSSANNA was given the phone by "KOEHLER. Sara stated that KOEHLER has been gone since Thursday and had contact with her both yesterday and today. Sara stated KOEHLER gave multiple addresses for her location including her Trafficking Advocate. SARA stated that KOEHLER did tell her the truth of her actual whereabouts at the motel. Sara stated that her KOEHLER has a restraining order against an Individual named James CARTER. Upon further investigation It was determined that KOEHLER had a valid protection order but has not been served to James CARTER as of today's date.

I spoke with the employee in the front office identified verbally as Nirmal SIEDHU (w/m, 11-17-1995). I asked SIEDHU who rentaled out room 217. SIEDHU gave me to photocopied papers with KOEHLER's ID and a Wisconsin State ID card bearing the name Patrick Deshawn BILLS (b/m, 09-14-1996), possibly "Blackie." BILLS was not on scene. SIEDHU stated that the couple checked in at 8:41 pm on 05-28-2021.

On Sunday, September 26th, 2021 at approximately 3:02 P.M., my partner P.O. Jamie RODENKIRCH and I were dispatched to a Shooting complaint at the address of 6798 W Appleton Ave located in the City and County of Milwaukee near the American Inn Motel.

Upon arrival, I was able to meet with the victim identified as Shemeah A CAMPBELL (B/F,6/14/85) who stated she had arrived at the American Inn Motel (6798 W Appleton Ave) where her daughter who is identified as Skye R. RODGERS (B/F,05/29/01) was located. CAMPBELL stated there was a fight that had occurred between some individuals and that she was helping break up the fight. CAMPBELL stated the fight was broken up and they began walking away from the general area when hearing multiple shots were fired. CAMPBELL stated she was shot in the leg regarding.

While on scene, I was also able to speak with RODGERS regarding the incident. RODGERS stated CAMPBELL and her were sitting on the corner watching a fight between two gay males occur. RODGERS stated one of the gay male's brother had pulled out a firearm and began shooting. RODGERS stated some of the individuals had went into the address of 6721 W Keefe Ave #1 and the other half had got into a white colored sedan and fled in an unknown direction. RODGERS stated everyone fled from the area and CAMPBELL had stated she was shot. RODGERS stated one of the shooters is related to a "CAPRINDESS" who is a B/M, approximately 5'05", dark complexion, heavy build, short hair cut, last seen wearing a white tank top beater, light colored ripped white jeans.

While on scene, I observed that CAMPBELL suffered a GSW to the left leg. CAMPBELL is also currently pregnant.

The American Inn Motel (6798 W Appleton Ave) has video surveillance regarding the incident. 4 casings recovered at this time. CIB is responding.

While on scene, we were able to speak with the owner of the American Inn Motel (6798 W Appleton Ave) identified as HARJINDER SINGH (W/M, 4/15/65) who stated there was a group of individuals that arrived outside his business at approximately 9:00 A.M., on 9/26/21. SINGH stated he contacted police regarding. SINGH stated the group had left the location and then returned once again at approximately 11:30 A.M. - 12:00 P.M. SINGH stated the group had left once again. SINGH stated the group had arrived back at the location a third time at approximately 2:45 P.M. with more individuals that began to verbally arguing. SINGH stated he told the individuals to leave the location and a physical fight had broke out. SINGH stated as he was walking into the location to contact police regarding, he heard multiple shots fired. SINGH stated he did not see or hear anything, but had video surveillance regarding the incident.

While on scene, SINGH was extremely cooperative and provided C.I.B. and police personnel with video surveillance regarding the incident.

While on scene, Detective ELGERRITH was able to interview one of the individuals regarding the incident identified as Skye R. RODGERS B/F 05/29/01.

RODGERS stated that her ex-boyfriend Dominique A. JONES B/M 05/04/97 damaged her property earlier in the day, at which point she retaliated and damaged some of his mother's property. RODGERS stated

that she then received a message through Facebook to come to the incident location to fight Isis S. FERAS B/F 04/29/99, who is the sister of Dominque. After their fight was complete another fight broke out between Caprindess M. JONES B/M 02/12/92 and another B/M. Caprindess is the brother of Dominque and Isis. During their fight several people displayed their firearms. RODGERS described suspect #1 as a B/M, 24 years of age, 5'05, 210lbs, dark complexion, short afro, beard, wearing a white tank tee shirt and blue pants, armed with a silver firearm. RODGERS stated she observed at least four other B/M's with firearms, but had no further suspect information. RODGERS stated after the shots were fired she ran off, and received a call a short time later informing her, that the victim (her mother) had gotten shot.

On 05/15/2022, at 1131 hrs, Squad 7141, PO Chad STILES and Squad 7120, PO Reggie CARTHEN, responded to 6798 W Appleton Ave #212 for an overdose, and was monitored by Squad 7112, Sgt. Robert CRAWLEY.

I responded in marked Milwaukee Police Department Squad Car#582, in full Milwaukee Police Department uniform, both equipped with Axon Body camera.

On arrival, I met Lt. ROSS from MFD Engine 34 and Lt LUCHT from MFD Med 13 working on a subject later ID'd through hotel records (WI DL photocopy) as Michael S KLEINHANS, W/M, DOB 03/19/1965, of 13150 Gremoor Dr, Elm Grove, WI 53122, phone 262-259-2281, who had not been breathing, had pinpoint pupils and was suspected of overdosing. An IV was started in his right foot and he was revived with Narcan and became more responsive. He was transported to St Joe's ER Room 18, where he was admitted to the care of Dr. STULL, MFD LT Ross stated the located white powder on the west nightstand and a glass pipe in the bed, and his belongings were in the nightstand drawers.

Hotel employee, Marlon G MOULTRIE, B/M, DOB 02/02/1979, phone 414-243-4108, stated he was knocking on room doors to advise renters that it was 11AM checkout time. He stated that there was no response and went in to find KLEINHANS on the floor, leaned up against the bed, not breathing. He stated that he called for help and a female next door started CPR. He stated that he was provided instructions by MFD dispatch until the ambulance arrived. Hotel records show he checked in on 05/13/22.

I recovered a small amount of white chunky powdery substance on the west nightstand, a rolled up dollar bill with power residue, and a glass pipe from the bed. While gathering KLEINHAN'S property from the hotel room to go with him to the hospital I located a chore boy in the top drawer of the west nightstand. There was only enough powder to complete one narco pouch test #207, which tested positive by PO Tim TOTH for cocaine base. There was not enough of the substance to test for other drugs or to inventory. I placed the dollar bill on MPD Inventory #2207636 and the choreboy and pipe on MPD inventory #22017634. I am unable to determine possession of these items at this time.

Upon arrival to the ER, KLEINHANS stated that he used to do opiates in his 30's. He stated that he has been on Huber the last year and has been clean. He stated he got his license back and was driving between Milwaukee and Chicago for work. He stated that he is currently on disability and not working.

He stated that he does not have any mental health concerns. He stated that he went to the hotel and bought drugs from a random person at the hotel. He stated that he did not have that person's name or phone number. He stated that he had been doing cocaine and then used heroin to slow himself down. He stated that he did not want treatment and this was just a mistake. He declined to talk to the peer recovery coach and stated he didn't need it.

He is currently on probation for felony theft and possession of narcotic drugs. I contacted WI DOC who issued a warrant for him to be taken into custody after hospital discharge and for treatment. This plan was approved by D7 A/Lt Sgt DUNKLEY.
