Dear Alderman Perez,

Thank you for taking the time to review my issue. and moved to the Walkers Point area last summer and have thoroughly enjoyed living in such a growing, vibrant and diverse community. However, around Thanksgiving time a new establishment opened called "Hex" nightclub. It seemed as though the club would be a nice fit and provide an alternative to a part of our community that may have been underserved in the past. The Hex owners even rented a storefront from the owner of our current residence which is on South Fifth Street in Walkers Point. Unfortunately, the club Hex seems to have grown at a pace which the owners were possibly unequipped to deal with. While only open on certain days of the week, the crowds have been enormous, and as we have come to see, very unruly at times, especially at closing. the club, and his buildings selling point was always how quiet it was. All this has now changed. At closing time there are frequent arguments between patrons, and between patrons and staff, that can be heard all the way down the block. But it's not the noise that brings me to write you. The previous month has brought gun violence to this block where there was none before. Last night there was a series of gunshots just outside blasts. The Milwaukee Police Department, to their credit, has always responded quickly and with determination to locate the perpetrators. I'm sure these troublemakers are in the minority, but it only takes one stray bullet to change the course of someone's life, not to mention the shooter. This has happened three times in the last month just after closing time at Hex. I felt it was my

duty to report this problem before it escalates. I'm sure Milwaukee PD will verify my claim and concerns. Anything you could do to help would be much appreciated.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/14/22 at 1:30am, Milwaukee Police conducted a license premise check at 715 S. 5th Street. The only violation observed was the officers observed people smoking inside the establishment. The applicant was cooperative.
- 2. On 03/04/22 at 12:34am, Milwaukee Police conducted a license premise check regarding a parking complaint at 715 S. 5th Street. Officers interviewed a Milwaukee Parking Enforcement Supervisor who stated he heard that the tavern charges patrons to park on the public street. Officers did observe cones blocking off a parking space and security for the establishment stated that they were the businesses cones and picked them up when asked by police to remove them. Officers interviewed the applicant who was cooperative but he stated the cones were not the property of the tavern. He said that they do not charge people to park in the street and blamed a subject across the street for the rumor. The subject across the street said he parks vehicle in a private lot and the cones belonged to the tavern at 715 S. 5th Street.
- 3. On 03/18/22 at 1:27am, Milwaukee Police were monitoring the taverns in the 700 block of S. 5th Street when they observed a large crowd in front of 715 S. 5th Street. The crowd was arguing loudly, pushing, shoving, and some were being restrained by other patrons. Additional

squads were called to disperse the crowd and the patrons left the area driving recklessly. A walk through of the tavern revealed a group of patrons still arguing and an odor of burnt marijuana. Security told officers that when they turned on the lights in the tavern a female started a verbal argument with her boyfriend. The applicant was on scene and cooperative.

4. On 04/16/22 at 2:29am, Milwaukee Police, while on patrol, heard gunshots coming from the 500 block of W. National Avenue. When the arrived in the area, they were informed by a witness that people were shooting in front of 715 S. 5th Street. Officers tried to enter the establishment but found the door locked and after several attempts, that applicant opened the door for police. While inside, officers observed workers cleaning up debris from the floor and the applicant told officers that two females engaged in a fight and were escorted out of the tavern. When staff member were asked if they heard any shots being fired, they said they did not see or hear anything. Officers later found casings in the street and on the sidewalk in front and to the south of the establishment. The applicant and staff were cooperative.

On Monday February 14th, 2021 at approximately 1:30 AM my partner and I along with Squad 2482 PO SANCHEZ conducted a tavern check at 715 S. 5th St Hex Nightclub. While walking to the establishment I could smell the odor of burnt marijuana emanating from inside the nightclub. There was one unarmed security guard at the door and another armed security guard patting down patrons before entering the night club. Upon walking into the dance floor area I observed a black, male, wearing, a dark colored clothing lighting up a what I believed to be a marijuana cigar. I pointed my flashlight at the subject and observed the subject holding a lit cigar. A security guard observed me and I advised him that a unknown subject was smoking inside the establishment. The security guard walked towards the subject but we lost sight of unknown subject due to the crowd.

The DJ stopped the music and the patrons were asked to leave because it was bar close. We didn't ask anyone to stop the music or close. I counted approximately 200 patrons leave the nightclub. I spoke with the owner who was identified as Eric T. WHITELAW (B/M, 04/28/74), and security who was in charge of counting how many patrons were let in and no one knew if someone was counting patrons. Later in the investigation a security guard brought a counter to me and stated there was 150 patrons inside. Tavern capacity is 299.

During a walk through of the nightclub I observed several burnt marijuana cigars on the tables and floor of the club.

WHITECLAW stated he was not aware patrons were smoking inside the nightclub.

WHITECLAW was cooperative and advised of violations I observed. I observed the tavern licenses in plain view and it they were up to date. No other violations where observed.

On Thursday, March 4th, 2022 at 12:34 AM we conducted a tavern check at 715 S. 5th St, Hex Nightclub, regarding a complaint received through parking enforcement.

We spoke with a City of Milwaukee Parking Enforcement Supervisor Klaran WALLACE, Squad 920. WALLACE stated Friday, 2-25-22, at approximately 12:00 AM he was on patrol in the 700-block of S. 5th St. WALLACE advised us a patron of Hex Nightclub asked if they could legally park on the street in front of Hex. WALLACE stated he advised the citizen that they were allowed to park there. WALLACE stated that the patron was shocked, and stated to him that Hex charges \$100-\$150 to park on the public street. WALLACE stated that every weekend he observes Hex as well as Walker's Lounge use traffic cones to reserve parking spaces on the public street for paying customers. WALLACE sated he then forwarded this complaint to District 7 Officer Timothy TOTH.

On arrival we observed security guards for Hex had one single car length parking space blocked off with cones. We spoke with a security guard who stated that they were the club's cones. The security guard had another security guard remove the cones from the street. We asked to speak with the licensee, identified as Eric T. WHITELAW (B/M, 04-28-1974), who was on scene and cooperative.

We did make entry into the nightclub, my partner and I both could smell a strong odor of marijuana coming from within the nightclub.

We then spoke with WHITELAW outside who denied the traffic cones were placed there by the club, or security. WHITELAW stated that they do not charge anyone to park the street, and blamed an individual across the street stating he is the one that charges people to park on the public street.

We spoke with this subject, identified by WI DL as James PERRY (B/M, 12-17-1975). PERRY stated Hamburger Mary's, 730 S. 5th St, allows him to park vehicles in their private parking lot. PERRY stated that he receives "tips" to guard people's vehicles from being broken into. PERRY stated the cones blocking traffic were Hex's, and that it's not him that is charging people to park on the city street.

On Friday, March 18th, 2022 at 1:27 AM we were monitoring taverns in the 700-block of S. 5th St. Both Officers were equipped with Axon Flex body worn cameras.

I observed a large quantity of patrons in the front entrance to Hex Nightclub, 715 S. 5th St, arguing loudly. Some of the patrons were pushing and shoving each other, and some were being restrained by other patrons. I called for additional squads to assist with crowd control. After the additional squads arrived the crowd slowly dispersed. As patrons left the location in vehicles I did observe patrons driving in a reckless manner as they left the area.

We then conducted a walk through of the tavern there was a group of patrons still arguing with security inside. I could smell the odor of burnt marijuana from inside of the tavern. Security stated everything was fine until they turned on the lights in the establishment when a female started a verbal argument with her boyfriend. I did observe broken glass scattered on the floor where the patrons were arguing with security.

I spoke briefly with the licensee, Eric WHITELAW (B/M, 04-28-1974), who was on scene and cooperative. No tavern violations were observed.

equipped with an AXON Body Worn Camera, which captured this investigation.

On Saturday, April 16th 2022 at approximately 2:29 A.M., Squad 2488 Officer POWELL and I (While in full duty Milwaukee Police Uniform operating a marked Milwaukee Police Squad 546 equipped with operating emergency lights and audible siren) were patrolling the 400 block of W. Virginia Street which is located in the City and County of Milwaukee, WI.

My partner and I heard several gunshots discharged from the approximate location of 500 W. National Avenue. My partner and I approached from S. 6th Street due to the high volume of traffic exiting northbound on S. 5th Street. Upon reaching the intersection of S. 6th Street and National Avenue my partner and I were flagged down by numerous citizens stating that subjects were discharging firearms in front of Hex Nightclub which is located on 715 S. 5th Street in the City and County of Milwaukee, Wisconsin.

Upon arrival at the intersection of S. 5th Street and W. National my partner and I observed several subjects exiting Hex Nightclub. My partner and I approached the nightclub and attempted to gain entry but, the front door was locked and the time of attempted entry into the club was approximately 2:30 A.M. After various attempts of announcing that we were police the manager of the building who was identified at WHITELAW, Eric T (M/B, 4/28/1974) opened the front door.

My partner and I made entry into the nightclub and observed numerous workers cleaning up debris on the floor. When asked, WHITELAW stated that two females engaged in a verbal and physical fight. We were informed that staff split the argument up and escorted one of the females out of the nightclubs front door. The second female was allowed to stay inside for a few minutes before being escorted out the back door to prevent further confrontation.

When asked about the shots fired staff members all stated that they did not hear or observe any subjects with a firearm. After conducting the tavern check my partner and I conducted a grid search which resulted in the discovery of casings directly in front and to the south of the location in the street and on the sidewalks. There were also casings located throughout the street. Nothing appeared to be struck or damaged by the gunfire.

There was only one citizen who called the police regarding these incidents and it was not Hex Nightclub.

WHITELAW and staff were cooperative when inside with providing the tavern licenses which were properly posted in an easily observable area above the main bar. WHITELAW stated they do not have any working security cameras at this time.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 09/07/2022 at 11:20 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
