NOTICE OF PUBLIC HEARING

PLEASE NOTE: A zoning change is being considered for the property within the boundary shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because your property address is within 200 feet.

DEAR PERSON OF INTEREST:

The Common Council has referred File Nos. 220489 and 220490 to the City Plan Commission (CPC) for recommendation. These files relate to the Second Amendment to the General Planned Development, GPD, known as Arena Master Plan to allow changes to the zoning standards for Block 3 of the GPD and adjacent lands, and the change in zoning from GPD to a Detailed Planned Development, DPD, known as Block 3 - Arena Master Plan, Phase 1 for development of a music venue and associated elements on a portion of 1001 North Vel R. Phillips Avenue, on the west side of North Vel R. Phillips Avenue, north of West State Street, in the 4th Aldermanic District.

In 2016 a GPD known as the Arena Master Plan was established for the entire Deer District and serves as a zoning master plan for future development within the district. A multi-story music venue is being proposed for a portion of Block 3 of the master plan, which is a permitted use. The venue will entail an approximately 4,000-person capacity room, smaller 800-person capacity room, meeting and event spaces, outdoor balcony, rooftop patio and other uses ancillary to the operation of a music venue. As part of this development, land to the west of the new building will be utilized as a service drive and to the north will be outdoor plaza space. An amendment to the GPD is necessary to modify the design standards for Block 3 as well as acknowledge the service drive to the west in lieu of a public street. The DPD approves the details of the music venue development, including the site plan and building design. A zoning change will be necessary in the future for development of the balance of Block 3. **Please refer to the reverse side of this notice for map details.**
