The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/24/19 at 4:26pm, Milwaukee Police were dispatched to 9717 W. Appleton Avenue for a battery D.V. complaint. Investigation revealed that a Battery-Domestic Violence took place and the hotel had a valid license.

- 2. On 11/23/21 at 2:47am. Milwaukee Police were dispatched to 9717 W. Appleton Avenue for an overdose compliant. Investigation revealed that the Milwaukee Fire Department had revived a subject who was overdosing with Narcan. The subject stated that he took "2 hits" from his glass pipe, found on the bed next to him, and that he had overdosed once or twice before. The subject refused any further medical and was driven home by his girlfriend who had called 911. The subject was issued a citation for possession of drug paraphernalia.
- 3. On 12/23/21 at 4:32pm, Milwaukee Police were dispatched to 9717 W. Appleton Avenue for a trouble with subject compliant. Investigation revealed that a guest had the front desk call police because he had been battered by the person he was staying with. When police interviewed the subject, he stated that he did not wish to press charges but police were unable to wake up the other party who was laying on the bed. The Milwaukee Fire Department was called and the subject was conveyed to the hospital for treatment. The applicant said he did

- call the police to report the disruption and was able to provide police with a copy of the subjects Drivers license.
- 4. On 01/13/22 at 5:30pm, Milwaukee Police were dispatched to 9717 W. Appleton Avenue for an overdose compliant. Investigation revealed that the Milwaukee Fire Department had revived a subject who was overdosing with Narcan. The subject stated that he took one Percocet and the only thing he remembers is returning to the room. The girlfriend said that the subject began acting strange and fell to the floor, so she started throwing water on him and called police. The subject refused medical.
- 5. On 04/30/22 at 4:20pm, Milwaukee Police were dispatched to 9717 W. Appleton Avenue for an overdose compliant. Investigation revealed that the Milwaukee Fire Department had revived a subject who was overdosing with Narcan. The subject stated that he did not take drugs and the caller had left before police arrival.
- 6. On 06/15/22 at 5:06am, Milwaukee Police were dispatched to 9717 W. Appleton Avenue for a shooting compliant. Investigation revealed that there was no shooting at the establishment but two subjects were taken into custody for outstanding warrants. One of the subjects had NARCAN administered to them because they were overdosing while in the officers squad.
- 7. On 07/26/22 at 10:48am, Milwaukee Police performed a CPTED at 9717 W. Appleton Avenue. Suggestions made to the applicant were; put lighting on the rear of the building, place "No Loitering" signs on the exterior of the building, clean up garbage daily, request CAD calls made to the property from the Open Records Division, and fill out a standing complaint form to have on file at the Fourth District. The applicant was very cooperative.

On Tuesday, November 11/23/21 at 2:47 AM, Squad 4330 (PO REED and I) responded to 9717 W. Appleton Ave #6 (Port Motel) for an overdose call. It should be noted that both officers were in full duty uniform, equipped with AXON body-worn cameras ACTIVATED while operating a marked Milwaukee

Police Department vehicle.

Upon arrival, officers arrived on scene with MFD Engine 4, Med 16 of Green shift with Lt. McCarthy who stated that they had administered 1mg of Narcan to the victim later identified as Steven R. ANSELL (M/W 05-01-95). It should be noted that officers observed in plain view on the bed, an opaque, glass pipe approximately 9cm in length with black and brown burn marks.

Upon regaining consciousness, ANSELL stated that he had purchased what he believed to be crack/cocaine "several hours before." ANSELL would not disclose whom he purchased the crack cocaine from, only that he took "2 hits."

After having his vital signs checked, ANSELL declined further medical services and stated that he would have his girlfriend Abigail R. RAKOWSKI (F/W 02-20-95) drive him. ANSELL stated that he had overdosed "once or twice before."

Officers spoke to RAKOWSKI who stated that she did not know who ANSELL purchased the crack cocaine from. RAKOWSKI stated that she had observed ANSELL conscious and "talkative..." 10 minutes prior to calling 911 at approximately 2:20 A.M. Officers placed the pipe under MPD Inventory. ANSELL was issued citation number 0681X4FB2P for drug paraphernalia was placed under MPD inventory 21045537.

At the time of police response the business agent, Upesh C SHAH, was not present or notified. See business agent tab for more details on SHAH.

INITIAL INVESTIGATION

Thomas-Baldwin, Shirley 030929

This report is written by P.O Shirley Thomas-Baldwin assigned to District 4, Early Power Shift. On December 23,2021 at approximately 5:35 P.M., while in full duty uniform, equipped with an Axon bodyworn camera activated, and in a marked squad, my partner P.O. Larray Johnson and I were dispatched to Trouble With Subject Complaint (Later determined to be a Sick and Injury Complaint), located at 9717 W Appleton Ave room #5 in the City and County of Milwaukee. Squad 4213 SGT., Kevin PANFIL, also was informed.

Upon arrival, on 12/23/21 at approximately 5:45 P.M., I observed the listed location to be at the Port Motel. I observed a male and female (later identified as Gary BEAMON (m/b,08/21/59) and Karrisa M. WALKER (F/B,09/14/91), inside of Room #5. The window curtains were open in room 5. I observed WALKER lying face down on the floor inside the room and BEAMON on the bed appearing to be sleep inside the room. My partner and I then knocked on the window and the door in an attempt to check the subjects welfare. After several attempt to get the subjects attention, BEAMON eventually woke up. BEAMON was observed to be slightly incoherent and confused at police presence. Once BEAMON was fully aware of police presence he explained to police he requested the front desk staff to call police because WALKER had battered him because she was intoxicated. BEAMON stated WALKER was now sleep and everything was ok. BEAMON stated he no longer desired police services as he stated several times WALKER was ok. I then went to check the welfare of WALKER. WALKER was observe breathing but unconscious and numb to officers touch. I observed several pill bottoms (Acetaminophen, Cyclobenzaprine, Ibuprofen and Lidocaine patches) open and lying on the floor inside the motel room. I observed a liter of Paul Masson and several empty beer cans lying inside the room. Officers then alerted Dispatch the need for medical for WALKER.

BEAMON stated he and WALKER are only "drinking buddies" and met a couple days ago at St. Benedict the Moor Shelter. BEAMON stated he and WALKER are not in an intimate relationship and are only associates. BEAMON stated he did not which to pursue any criminal charges against WALKER at this time. BEAMON stated he did not battered BEAMON during their altercation.

Milwaukee Fire Department (MFD) Engine 4 Blue shift and Med 16 arrived on scene at approximately 6:02 PM. MFD administrated Narcan on WALKER however, WALKER still remained unconscious. At approximately 6:21 PM., MED 16 transported WALKER to St. Joseph Hospital to be further medically treated. Walker was admitted to Ascension SE Wisconsin St. Joseph Hospital at 7:20 PM., in the medical Care of Doctor Adar. At this time Medical Staff advised Police they believed WALKER had overdosed with unknown drugs.

P.O JOHNSON spoke to WALKER's sister Darrisa F. WALKER (f/b,3-3-94) and advised her of the above listed incident. Darrisa stated her sister have been using unknown drugs for approximately 1 year. Darrisa stated her sister "hides" the truth a lot and she is unware of any known medical conditions WALKER may have.

I spoke to the owner Upesh SHAH (06/18/61) who was located on scene inside the Port Motel main office area. Upesh advised police he called to report an unknown black female being disruptive in the motel lobby. Upesh stated there was also a verbal altercation that took place inside room number 5 between the same unknown female and BEAMON. Upesh was able to provide police a copy of BEAMON Wisconsin driver's license.

This report is written by P.O. Brent TURNCH, assigned to District Four, Late Power Shift, Squad 4440.

On Thursday, January 13th, 2022, at approximately 8:37 P.M., while in full duty uniform, equipped with an Axon body-worn camera activated, and in a marked squad, my partner, P.O. Jacob AWOLOA, and I, were dispatched to an Overdose Complaint at Port Hotel located at 9717 W Appleton Ave., #3 in the City and County of Milwaukee.

Upon arrival at approximately 8:41 P.M., officers met the Milwaukee Fire Department (MFD) Captain PONDER, Green Shift. Captain PONDER stated that they were dispatched to the above location regarding an Overdose. The subject, later identified as Marcus D FORD (M/B, 11-12-79), was unconscious and not breathing when (MFD) initially arrived. (MFD) administered Naloxone (Narcan) unknown amount intravenous into FORD's left arm.

Once the Narcan was administered, FORD regained consciousness and began to breathe.

INTERVIEW OF THE VICTIM MARCUS D FORD:

Officers interviewed FORD, who stated that at approximately 5:00 P.M., he and his girlfriend Ashley M FORD F/W, 09-27-86) checked into the Port Motel. FORD stated that they exited the motel and returned at approximately 7:30 P.M.

FORD did not state where they went but stated that he took one Percocet 30mg through nasal between 5:00 P.M - 7:00 P.M. FORD stated that he only remembers returning to the motel room and taking a shower.

MFD and officers advised FORD to go to the hospital however he refused.

End of statement.

INTERVIEW OF THE GIRLFRIEND ASHLEY M FORD:

ASHLEY stated that after returning to the motel, FORD sat on the bed and asked for a cigarette. ASHLEY stated suddenly, FORD began to act strange and not alert. ASHLEY

stated that she attempted to get FORD's attention however, he appeared frozen. ASHLEY stated she tried to get FORD to walk to the bathroom, but she could not get him to walk.

ASHLEY stated that FORD fell onto the floor, and she got a bucket of water from the bathroom and splashed it onto him. Ashley stated that after splashing water onto FORD, he remained unresponsive.

ASHLEY stated that she contacted 9-1-1 and splashed water onto FORD again in an effort for him to regain consciousness.

On arrival, officers met with Milwaukee Fire Department Engine 4, green shift, Captain Mack DONALD who was with the subject, Mario T. ROBERTS (B/M, 03/16/87). MFD stated ROBERTS was in the room unconscious and not breathing. MFD stated they administered 2mg of narcan to ROBERTS which he then became alert.

ROBERTS was suspected to be overdosing on an unknown drug, possibly heroin due to the CAD comments given by the caller who was not on scene. ROBERTS was adamant that he has not taken any drugs and advised officers he did not know what happened or who called for medical attention.

Upon arrival and during the investigation, it was determined that this was not a shooting. I made contact with Karen A. MCDERMOTT (W/F, 05/17/1989) who stated that no was shot and she was about to have sex with her boyfriend. MCDERMOTT stated that she was scared when police arrived at the location and that is why she did not answer her door. MCDERMOTT originally stated that her name was Samantha R. SPOKE (W/F, 09/13/1988) MCDERMOTT was identified by P.O. Justin RAVELY (squad 4390) from a previous incident of an overdose.

MCDERMOTT's boyfriend was subsequently identified as Mario T. Roberts(B/M, 03/16/1987).

A wanted check of MCDERMOTT revealed that she had a Waukesha County Sheriffs warrant. MCDERMOTT was taken into custody and placed in the rear passenger compartment of our marked MPD squad car. While MCDERMOTT was in the rear passenger compartment, she became unresponsive to officers speaking with her. I opened the back door and MCDERMOTT still was unresponsive but was breathing. I started to administer sternum rubs to get MCDERMOTT to respond to officers. After several sternum runs, MCDERMOTT continued to be unresponsive to officers. I took MCDERMOTT out of the rear passenger compartment of the squad car and laid her on the ground to administer more sternum rubs or if needed chest compressions.

MCDERMOTT continued to be unresponsive from the sternum rubs. MCDERMOTT was taken out of handcuffs and placed on her side in an attempt to get her to breathe easier. MCDERMOTT was administered 4mg of narcan inter nasally and MCDERMOTT did not respond much to the narcan.

I continued to perform sternum runs on MCDERMOTT and she would respond a slightly but then would become unresponsive again. P.O. KELLER administered a second dose of 4mg of Narcan internasally. MCDERMOTT became more responsive and was able to speak with officers after the second dose of Narcan.

MFD med 16 arrived on scene and started to check MCDERMOTT's vital signs. MCDERMOTT was a lot more responsive after the second dose of Narcan. Med 16 conveyed MCDERMOTT to St. Joseph's Hospital.

MCDERMOTT was admitted at St. Joseph's Hospital at approximately 6:16am and was treated by Dr. GRACE.

While in custody, Waukesha PD was notified of the active warrant. Waukesha PD stated that they will not be coming to sit with MCDERMOTT at the hospital. P.O. KELLER issued MCDERMOTT a citation for obstruction due to her not being forthcoming about her information upon police contact.

MCDERMOTT was released at the hospital.





Re: Report of the Renewal Application of Upesh Shah, Agent for Rima Corporation USA for a Hotel/Motel License located at 9717 West Appleton Avenue in the City and County of Milwaukee, Wisconsin ("Port Motel").

FINDINGS OF FACT

- 1. Upesh Shah (hereinafter the "Licensee") is the holder of Hotel/Motel license for the Hotel/Motel located at 9717 West Appleton Avenue in the City and County of Milwaukee, Wisconsin ("Port Motel"). Said license expires at midnight on July 27, 2022.
- 2. An application to renew said license was filed with the Office of the City Clerk on May 23, 2022.
- 3. Pursuant to Chapter 85 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, this matter was referred to Milwaukee Police Department for investigation.
- 4. On July 5, 2022 the City Clerk provided timely notice to the Licensee pursuant to Chapters 85 and 275 of the Milwaukee Code of Ordinances of the neighborhood objections. The matter was scheduled for a hearing on the objections on July 19, 2022, commencing at approximately 9:20 a.m. in Room 301B of the third floor of City Hall. At that date and time, the Licensee appeared with counsel, Attorney Michael Maistelman at the hearing, and admitted receipt of the notice of hearing.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. The Licensee was present along with Attorney Michael Maistelman.

Individuals also present:





- B. Lydia Hernandez said that her daughter died on the premises due to a drug overdose on April 26, 2021 and that this establishment is the site of crimes like drug and human trafficking and that she does not know why there is no police report about her daughter's death but that she is opposed to renewal.
- C. Cathy Taylor said that this establishment has been a nuisance and that it was her niece who passed away in that motel and that she is in objection.
- D. Whitney Miranda said that she stayed at the hotel after the passing of her cousin just to observe and that she saw drug transactions and that the establishment is not safe because people come and go and they are loitering around with no security on the premises. She also took issue with the physical upkeep of the establishment.
- E. Attorney Maistelman asked Miranda when she stayed there and if she called police to report her observations.
- F. Miranda said that she stayed one or two months after her cousin's passing. She further said that she did not call the police and that she was there to observe what the hotel was about and that she saw a room next to the check in area full of ladies.

Individuals also present:

- G. Alderwoman Dodd said that she wanted to give the condolences to Mrs. Hernandez and that she is concerned about why this item is not on the police report and asked if there is a record of the call.
- H. Sgt. Velasquez said that there is a call for service for a drug overdose on April 26, 2021.
- I. Mr. Cooney said that the incident is not shown on the last year report either.
- J. Alderman Spiker asked Attorney Maistelman if his client acknowledges that the overdose happened at the hotel.
- K. The Licensee said that yes, it happened.
- L. Alderman Spiker asked if the staff reported the incident.
- M. The Licensee said that it was another guest who reported it.
- N. Alderwoman Coggs said that human and drug trafficking are common issues for hotels in the City and asked the Licensee what has been done about it.



- O. Attorney Maistelman said that they do not take cash as a form of payment, that a state ID is required, licenses plates are checked and a quick CCAP check is conducted.
- P. Alderwoman Coggs said that a training is recommended for the staff to be aware of any suspicious activity and how to address it.
- Q. Alderman Spiker agreed that a training is needed and advised the Licensee to get in touch with other hotels to check what are they are doing.
- R. Beer Shah the Licensee's son said that they are trying to implement a "do not rent" list of people not allowed in the hotel and that they are sharing this list with other hotels in the area in order to set up a network to address this issue.
- S. Alderman Spiker asked if there has been any other drug overdose case.
- T. Beer Shah said that it never happened before and that the person who died never showed signs of being in trouble.
- U. Alderwoman Dodd said that she is still concerned about the fact that the Licensee did not call the police and that the Licensee knew that this family was going to show up at the hearing without doing any outreach. She added that it is concerning that the Licensee does not know if the police showed up and that based on the information that we are getting at this Committee, the Licensee has not shown signs on even reaching out to the family.
- V. Attorney Maistelman said that the problem is that we do not have a police report and that he cannot put up a plan to defend his client without it. He also stated that nothing has happened within the last year and that the Committee should discipline everyone with the same criteria as other hotel licenses that have experienced the same situations or worse.
- W. Alderwoman Dodd said that she appreciates that Attorney Maistelman tried to make a case for his client and that the difference is that a mother who lost a child in front of the Committee instead of the police report and that if this item would have shown up on last year police report, there would have been disciplinary action.
- X. Alderwoman Dodd moved nonrenewal based on the Licensee and public testimony. (Prevailed 3-1).



CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 85 and 275 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Upesh Shah who holds a Hotel/Motel License for the premises located 9717 West Appleton Avenue in the City and County of Milwaukee, Wisconsin ("Port Motel") has not met the criteria of Chapters 85 and 275 of the Milwaukee Code of Ordinances, to renew the Hotel/Motel License. The Committee finds the aldermanic and public testimony as stated above to be true as stated above.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Hotel/Motel License held by Upesh Shah for the premises located at 9717 West Appleton Avenue ("Port Motel"). The Committee based its recommendation on the Aldermanic and public testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, zero (0) noes, one (1) excused, and one (1) abstaining recommends that the Hotel/Motel license of Upesh Shah for the premises located 9717 West Appleton Avenue in the City and County of Milwaukee, Wisconsin ("Port Motel") not be renewed based on the aldermanic and public testimony.

Said nonrenewal is effective July 28, 2022.

Additionally, because the License will expire on or about 7/28/22, the City has agreed to issue my client a provisional license.

Please respond immediately if any of the above is not accurate.

Dear Common Council Members,

I am addressing the License Committee's July 14, 2022, recommendation for you not to renew the hotel/motel license of Port Motel located at 9717 W. Appleton Ave.

You should not accept the License Committee's recommendation for the following reasons.

- (1) The Committee did not provide the Licensee with any police reports, yet the majority of the discussions at the Committee revolved around what took place on or about April 26, 2021. Because the April 26, 2021 overdose ("OD") took place 15 months ago, my client's recollection was not as accurate, and he did not have the benefit of refreshing his recollection by using the police reports. We are not sure why the Committee deprived the Licensee of those police reports as the Licensee was able to obtain those police reports on his own within 36 hours after the Committee hearing by simply doing a public records check with the Milwaukee Police Department ("MPD"). This failure of the Committee deprived the License of his due process rights.
- (2) The Committee has always taken the position of progressive disciple. Yet, only two hearings before Licensee's hearing was the hearing of the SJP Motel, LLC, located at 7012 W. Appleton Ave, only a few blocks from the Licensee's location. The police report in the SJP Mote, LLC meeting had one overdose resulting in one death, one overdose resulting in hospitalization, and one incident of a robbery with a gun. Despite these significant incidents, the Committee unanimously voted to recommend renewing SJP Motel, LLC's License with only a warning letter.

As far back as the License Department has records, the Licensee's License has had his License renewed on the consent agenda, except at the July 14, 2020 hearing, in which after the Committee hearing, the Committee voted to recommend renewing License's License. See the attached email from Jim Cooney, the License Division Manager.

Based upon these facts, the Committee's recommendation to non-renew Licensee's License was arbitrary, capricious, and inconsistent with its policy of progressive discipline nor with its earlier recommendation for SJP Motel, LLC, whose record was much more significant.

- (3) Licensee does not speak English well. His daughter was present during the April 26, 2021, OD bit, not at the July 14, 2022, License hearing. Licensee's daughter was not aware that her presence would be needed at the Committee to respond to the Committee's questions because, among other things, there were no place reports provided to Licensee regarding the April 26, 2021, OD. As the Committee could not base their recommendation not to renew Licensee's License, the Committee only relied upon the testimony of three witnesses. They did not have first-hand knowledge of many of the statements they made. Based upon the failure of the Licensee to respond to specific questions from the License Committee, the License Committee, based upon the three witness testimony, voted to non-renew the License. Attached hereto and incorporated herein is Licensees's daughter's affidavit. The affidavit answers the questions of the Committee.
- (4) Licensee cannot be responsible for the fentanyl epidemic that is occurring throughout Milwaukee and the country. In MIlwaukee alone. See https://www.jsonline.com/story/communities/west/news/wauwatosa/2022/03/22/milwaukee-county-drug-overdose-dashboard-track-time-location-demographic-information/7073430001/

If the City non-renews the licenses of all establishments where drug overdoses have taken place, many, many establishments would not be open.

For the foregoing reasons Licensee requests that you not follow the recommendation of the License Committee and provide discipline commensurate with the above facts.

- 1. I make this affidavit based upon my personal knowledge.

This report is submitted by P.O. X.LUNA assigned to District Seven Day Shift. On Wed. 4/27/22 I (squad 7122) was dispatched to 7012 W. Appleton Ave. Room#5 (CAPITOL MANOR MOTEL), which is in the City and County of Milwaukee, for an overdose complaint.

Upon arrival I observed MFD with the victim, later identified as Timothy M. COPENING b/m 1/30/71. MFD Captain J. FRANZ informed me that he administered 5 doses of Narcan to COPENING. I observed that COPENING was awake but still very much under the influence of whatever illegal narcotics he put in his system.

I looked around the room but did not observe any illegal narcotics or drug paraphernalia of any kind in the room. MFD was able to move COPENING to the Med Unit. During this time I asked Captain J. FRANZ if he observed any illegal narcotics in the room upon their arrival. FRANZ informed me that they did not observe anything, but that there was a white female at the location upon their arrival.

FRANZ informed me that she stated she did not know COPENING, but yet was gathering clothing, that appeared to belong to COPENING, and placing it outside next to the door. I went into the parking lot and onto the sidewalk searching for the female but did not observe her anywhere on the premises or in the immediate area.

I spoke with the owner of the motel, identified as Gary S. PATEL w/m 6/1/76. I asked PATEL if he had any information on the person that checked into Room #5. PATEL informed me that COPENING checked into the room approximately 2 days ago as a single occupant. PATEL stated he did see a white female that was hanging around the room, but she did not check in with COPENING. PATEL stated he noticed this morning that MFD and the Police were at Room#5 and figured something happened. I informed PATEL that COPENING had used some illegal drugs and that it would probably be in his best interest not to rent a room to COPENING again in the future.

copening was conveyed to St. Joseph's Hospital by MFD MED UNIT#16 where COPENING was admitted at 10:09 am and treated by Doctor Jason STASZKO. I was informed that at this time it was unknown what illegal narcotics COPENING took but that COPENING was in no immediate danger of dying from the illegal narcotics. I was also informed it would be several hours before COPENING would be in any condition to make any statements as to what he took.

Alderwoman Dodd, I just got off the phone with ACA McNally and this email confirms Jack and my conversation.

As I stated, there are police reports from the overdose that took place on April 26, 2021, despite LIU reporting to the Committee that there were no reports. (See attached)

As you will see, and as MPD told me on the phone, there are additional reports regarding this overdose that MPD cannot release because it is an active investigation.

I am also asking MPD for other records that they might have, when they have come to the Motel, which should show that my clients have always cooperated with MPD.

I have also requested records from the Milwaukee Fire Department regarding this overdose to shed light on what transpired on April 26, 2022.

As I also stated, I met with the entire family this morning at the hotel to discuss the facts surrounding the overdose.

The licensee's wife and daughter also live at the motel and they provided me with additional information about the overdose, that they had first hand knowledge of, but that the licensee did not, that would have answered many of the questions that the Committee had.

I will be preparing an affidavit documenting this.

Lastly, as I mentioned my client has three long term tenants, some of which have lived at the motel continuously for almost 20 years. As we discussed and agreed, state statute would govern how and when these tenant's could be removed which could conflict with whatever decision the CC makes.

I am also copying Jim O and Jim Cooney.

This report was written by P.O. Seth HORST, assigned to District 4, Early Shift.

On Monday, April 26th, 2021, at approximately 9:08 p.m., Squad 4231 (P.O. Seth HORST and P.O. Jesse SAENPHONPHAKDEE) were dispatched to the Port Motel at 9717 W Appleton Av, located in the City and County of Milwaukee, Wisconsin for an Overdose Complaint. This investigation was completed by uniformed officers, operating a marked squad, with body worn cameras activated.

This investigation was monitored by Sgt Jermel WILDER (Squad 4411), who was on scene during this incident.

This location is a multi-unit Motel with a single room containing a table, bed and television, with a bathroom on the other side from the entrance. This incident occurred in unit #4, which is located on the south side of W Appleton Av facing eastbound. This unit is 4 doors from the lobby of the motel.

Upon arrival, we met with MFD who advised that the patient they were treating was not breathing and did not have a pulse. MFD advised she was pulse-less and not breathing at the time of their arrival. MFD then advised the subject did have a pulse but was not breathing on her own.

I met with the caller on scene, Tyrese S STEWART (m/b) who stated that he is fro	m Appleton,

I met with Destiny V WRIGHT (f/b who was also on scene, standing outside of unit #4. WRIGHT stated that she had been called by STEWART and was there to see if her friend was okay. WRIGHT stated she had no knowledge of what occurred.

STEWART stated he went to take a nap when CHEEKS was showering and getting ready at approximately 7:00 p.m. STEWART stated he did not observe any drugs and did not see CHEEKS use any drugs before he went to sleep. STEWART also denied using drugs himself.

STEWART stated that CHEEKS is known to use Heroin, Xanax and Percocet recreationally but did not see any in the room. Officers did not observe or locate any drugs or drug paraphernalia in the room while on scene. It should be noted that the cause of CHEEKS loss of consciousness is unknown at this time pending lab results.

MFD Engine 4, Med 16, Green Shift led by LT MCCARTY provided medical attention to CHEEKS and transported her to Froedtert. MFD advised that CHEEKS was not breathing on her own but did have a pulse. My partner, P.O.SAENPHONPHAKDEE rode with Med 16 to Froedert where CHEEKS was admitted to the Trauma Unit at 9:46 p.m and treated by Dr. LUKENS.

Officers attempted to locate CHEEKS phone on scene, but could not be located by officers. When asked, STEWART and CHEEKS's mother, Lydia M. HERNANDEZ (f/w), who arrived on scene after receiving a phone call, both stated they did not have the phone and did not know where the phone was. HERNANDEZ was advised to contact officers if she does locate the phone.

As of this time, CHEEKS is in the Trauma room of Froedtert and is still not breathing on her own, but does have a pulse. CHEEKS is currently on a ventilator.

An Incident Notification was created by myself and reviewed by Lt Raymond BRATCHETT. Lt BRATCHETT advised this investigation is ours to handle and to write a Sick/Injured report.
