

On 11-11-21 at 9:17 p.m., we responded to a shooting that was located at N. 27th St. and W. Atkinson Ave., to handle the license premise reports regarding the Hotspot store, located at 2643 W. Atkinson Ave. This store's video captured the incident, we also were able to download the video from the store.

Upon arrival, we met with store security, Deroyce CARTER (b/m 02-16-87) who was operating the cameras. He was able to show me some of the cameras that captured the incident. He was also showing other officers who were reviewing the video who some of the people in the store were just before the incident occurred. While speaking with CARTER, the store owner / agent Nael JABBAR (a/m 07-27-78) began to speak to me about the cameras. Other officers who were in the store stated that JABBAR also could show what cameras captured the incident.

JABBAR took me to where he keeps the DVR drive for his cameras and showed me the cameras that would have captured the incident. He also stated that there was a camera from a store that he also owns across the street, Baba's Grill, located at 4383 N. 27th St., which captured the incident.

The cameras that he showed me from the Hotspot Supermarket are as follows:

Camera #3- Is located just inside of the store, facing west, towards the main entrance doors. These are the only doors that are accessible by the customers of the store and capture people entering the store.

Camera #5- Is located on a west exterior wall of the building, facing west/northwest, towards the intersection of N. 27th St. and W. Atkinson Ave. This camera also captures the north / south sidewalks of both the east and west side of N. 27th St.

Camera #6- Is an interior camera, on the west wall of the store, facing in an easterly direction. This camera captures the interior of the store, as well as the customer checkout /cash registers.

Camera #12- Is an interior camera that is attached to the main entrance doors of the store, facing east. This camera captures the faces of those who are exiting the store.

Camera #15- Is an exterior camera that is located on the north side of the building and is facing in northwesterly direction along W. Atkinson Ave., capturing the 2600 block and the intersection of N. 27th St. and W. Atkinson Ave. This camera also captures the northeastern and southeastern corners of N. 27th St. and W. Atkinson Ave.

Camera #32- Is an interior camera that is located between camera #3 and camera #12. This camera is attached to the north wall and faces south in the store.

The times stamps of these cameras appear to have the correct time, adjusted for day light savings.

JABBAR then took me across the street to Baba's Grill and showed me the recorded video from the following video camera:

Camera D9- Is an exterior camera which faces a southeasterly direction, towards the Hotspot Supermarket (2643 W. Atkinson Ave.) The camera faces the entrance, intersection and the sidewalks on both the eastern and western sides of N. 27th St., just south of W. Atkinson Ave. It should be noted that the time stamp on this camera is 1 hour a head of current time and was not adjusted due to day light

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
