
Dear Ms. Sims:


We have received your claim in the amount of \$1,511.16, relating to damage sustained to your door located at 4331 North 68th Street on March 2, 2022, when the Milwaukee Police Department (MPD) forced entry into your property.

Our investigation reveals that on March 2, 2022, MPD squads arrived at 4331 North 68th Street on March 2, 2022, in order to execute a search warrant. The warrant was based on probable cause that a felon in possession of a firearm was staying at your residence. MPD arrived and knocked on the door, announcing themselves several times. Getting no response, they forced entry into the house. The suspect was identified and arrested.

It is our view that the Milwaukee Police Department acted within the scope of their authority and within reason regarding their search warrant in this case. As such, there is no evidence that the MPD was negligent in this matter, and we are denying your claim. If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
