Dear Sir or Madam:

Ms. Verther Perry alleges that on February 9, 2022, at approximately 4:30am, she observed water leaking into her basement and pooling in the yard around her home located at 5034 N. 108<sup>th</sup> Street. Ms. Perry submitted a damage claim for \$5,550.73, for water source investigation, water extraction, and floor removal.

Milwaukee Water Works (MWW) records indicated that on February 9, 2022, at 4:49am, MWW received a report of a leak in the street, located west of N. 107th Street on W. Fairmount Avenue. An MWW investigator responded to the location, and at 6:43am, confirmed a break on the 8" water main on W. Fairmount Avenue. The investigator subsequently throttled the water main, which slowed the flow of water without turning it off completely. An MWW crew placed the main out of service at 11:00am, performed repairs to the main, and placed the water main back in service at 1:30pm.

On May 12, 2022, Ms. Perry filed her notice of claim, and our independent appraiser completed an inspection of her property and noted that the mitigation company hired by the claimant had already removed the damaged flooring at the time of inspection. The independent appraiser recommended total cost of repairs is \$5,097.58. Meanwhile, the claimant submitted another estimate from New Floors, Inc., for \$5,269.16.
