Hello,

Thank you for your prompt response! Yes, it could be said that the additional competition would be beneficial, but LiveNation has a consistent history of damaging local venues in the cities in which they open their own property. Firstly, since LiveNation manages entire tours as well as venues, they can (and almost always do) choose to have the artists they manage perform in their own venues as opposed to pre-existing local/small venues. Many smaller acts who are looking for exposure opt to open for larger acts, and if these larger acts are managed by LiveNation and exclusive play LiveNation-owned venues, this pressures those smaller artists into only playing those venues as well.

Additionally, coming out of the COVID-19 pandemic, many independently-owned small venues cannot afford to keep ticket prices low, but LiveNation is a large enough corporation that they can. LiveNation, Ticketmaster, SiriusXM, and Pandora have combined under Liberty Media, a conglomerate with a combined net worth of billions of dollars. The combination of their financial wealth and their influence on media would allow them to selectively promote LiveNation venues/tours and leave small venues in the dust.

Finally, LiveNation has historically refused to do business with venues that refuse to use Ticketmaster. Ticket buyers and performers generally tend to dislike Ticketmaster due to their incredibly high service/processing fees (for context: I bought a \$210 ticket on Ticketmaster to see a band in March and, with fees, paid over \$250). Ticketmaster's success comes from their decision to pander to venues, instead of performers or concertgoers, by paying them a share of these outrageous additional fees. This strategy has allowed them to outperform competitors that promise a more user-friendly experience and minimal fees. Performers can try to fight against the unfairly expensive tickets on Ticketmaster, but if they want to play the LiveNation-owned venues that are getting so well promoted, they have little choice.

I completely understand the perceived benefits of the construction of a LiveNations-owned venue in Milwaukee, but given their predatory and shady business history, it's more than likely that Milwaukee's independent small venues would suffer as a result. This post from the Department of Justice has more information regarding Ticketmaster and LiveNation's past of violating their agreement to "refrain from monopolistic
