#### To The License Committee

On behalf of the North Teutonia Avenue businesses and neighbors, the following <u>objection</u> shall be entered with regard to the renewal of the license for the Penthouse Lounge at 3621 N. Teutonia Ave. One or several members of the ad hoc association of businesses and neighbors in the North Teutonia Ave area would like to provide testimony by phone or internet at the hearing scheduled for Tuesday, Sept. 27, 2022 at 1:45 pm.

The basis for the objection to the renewal of the license is grounded in two main concerns: 1) Penthouse's failure to comply with the limitations imposed on its license; and, 2) A stream of complaints/concerns from the neighborhood residents.

### FAILURE TO COMPLY WITH THE LICENSE COMMITTEE'S LIMITATIONS

The license issued to the Tanisha Kelly of the Penthouse Lounge excludes the following activities:



# LATE NIGHT PATRON TRAFFIC

Please note that the Penthouse Lounge has a highly active late-night patronage, Monday through Sunday. Based on the reports from the neighborhood, the activity ramps up *after 3 or 4 a*m. Also, many local residents have complained about an increase in the late-night loitering, loud arguments, and regular fights among the Penthouse Lounge patrons. The activity is frequent, but too transient for an effective police report. Nonetheless, neighbors have expressed that they often feel "unsafe" when working (commercial business owners) and/or returning home (local residents) later in the evenings as a result of the unpredictable behavior of the Penthouse patrons. There are several "women owned" businesses located on North Teutonia Ave. and safety is a primary concern.

## DAMAGE TO PROPERTY

The Nehr building is located to the immediate north of the Penthouse property; and has been subject to shootings, loiterers and other supplemental late night activity as a result of the Penthouse patrons.

12/17/21	A red/burgundy SUV was parked on a neighbor's lot and caused approximately \$2500 in damage to property. The vehicle was associated with the Penthouse Lounge. Ms. Kelly was informed and a police report was created.	Reimbursement was promised by Penthouse Lounge but never paid.
12/18/21	Daily problems with patrons/owners of the Penthouse Lounge parking in the loading zones. These areas are marked with signs but disregarded.	Unresolved.
2/16/22	An inspection by the CPU unit finding that the Penthouse Lounge was operating outside of the parameters of their license. Two citations were issued to the owner. DNS was scheduled to conduct zoning inspections.	Resolved.
2/24/22	Report received about bullets being fired into a neighboring building of the Penthouse Lounge. A report was made to the police.	Resolved.


### **COMPLAINTS RECEIVED: November 2021 through Present**

3/4/22	An inspection of the Penthouse Lounge resulted in another citation from MPD and multiple violations from the DNS.	Resolved.
3/17/22	Complaints made by neighbors about the increased trash left in the area around Penthouse lounge. Businesses in the area were forced into doing "morning clean ups" in order to keep the neighborhood free of debris caused by the patrons of Penthouse Lounge.	Unresolved.
4/3/22	Additional neighbor complaints about the safety in the neighborhood as a result of the numerous fights of the patrons of the Penthouse Lounge. On several occasions gunfire resulted along with broken glass in the middle of the street. Also, complaints that the owners of Penthouse encourage their patrons to park on the lots of the church and an open field across from the bar.	Unresolved.
6/14/22	Additional complaints from neighbors about daytime pool parties at the Penthouse Lounge. Women arrive in scantily clad bathing suits and provocative clothing. After hours fights and shootings are becoming common in the evening hours.	Unresolved.
7/4/22	Complaint about fireworks being deployed at the Penthouse Lounge location. Click <u>Here</u> and <u>Here!</u>	Unresolved.
7/6/22	Penthouse Lounge advertises its pool party. See Appendix, Item III.	Unresolved.
8/10/22	Penthouse Lounge tells customers to park on the lot across the street from the venue. This was never approved by the owner of the lot. See Appendix, Item II.	Partially resolved. In later August 2022 the owner of the lot put up an iron-rod fence to keep cars off of the lot.


