Chief Norman:

Please be advised that I represent Harjap Hospitality Group, LLC and have been given a copy of your September 6, 2022 letter and asked to respond.

To my clients' knowledge, the sixteen police calls referenced in the letter were all involving Tanika Triblett and/or Mike Triblett, her husband, and/or accomplices of the two.

As the police department is aware, my clients have claimed that these individuals have committed numerous crimes on their property, including theft, breaking and entering, destruction of property, attempted sale of drugs, harassing personnel, assault and battery, etc. My client has called the police in most of the 16 incidences in your letter in an attempt to have these people removed from the premises and charged with a crime. The Police Department stated they will not do the same, because my clients apparently do not have a hotel license. As a result, these individuals have continued to commit crimes, and the police have been continually called.

Whether my clients have a hotel license or not, I do not believe is a reason for the police not enforcing the Milwaukee Criminal Code. If these individuals were removed from the premises in early August when the police were first called, the remainder of these police contacts would not have occurred.

My clients have previously implemented all possible manners to keep crime down at the premises, including (i) installing no loitering signs, (ii) installing no trespassing signs, (iii) installing a security system, (iv) employing security personnel, (v) have a standing order to remove trespassers with the Milwaukee Police Department, (vi) etc. Unfortunately, the above referenced individuals have damaged the security system by breaking all the cameras (repeatedly) and by assaulting security personnel, resulting in the security personnel not wanting to troll my clients' premises.

My clients' personnel have initiated a temporary restraining order against these people, along with an eviction proceeding which they have hired me to prosecute.

My clients are unaware of anything else they can do to stop the criminal activities of these two people and their accomplices, other than what they have done, and are doing; which includes notifying the police of criminal activity. As such, they do not believe they have a "nuisance property". If you would like a sit-down meeting with my clients and/or myself, please advise.
