## **DEAR PERSON OF INTEREST:**

The Common Council has referred File No. 220628 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Regional Business, RB1, to Industrial Light, IL1, for the property located at 8120 West Brown Deer Road, on the north side of West Brown Deer Road, east of North 85th Street, in the 9th Aldermanic District.

This zoning change was requested by Menard, Inc. to allow the expansion of self-storage on the site, which is a Special Use in the IL1 zoning district. **Please refer to the reverse side of this notice for map details.**
