## Security Plan for 2900 West Lisbon LLC Store at 2900 West Lisbon Avenue

- 1) There are three (3) No-Loitering Signs, two (2) on the front of the building, one on each side of the main entrance door. One (1) No-Loitering Sign (Milw. Ord 106-31-1-A) has been installed on the eastside of the building, off of 28<sup>th</sup> Street.
- 2) There is one (1) No-Trespassing Sign (Milw. Ord 110.10 State Status 943.4) on the westside in the front of the building citing the Wisconsin State Statue.
- 3) There are a total of 16 cameras on the property. Total costs \$5,000.00.
- 4) Five (5) flood lights have been installed on the building. One is on the westside of building, three (3) are on the front side of building, and one (1) is on the eastside of the building facing 28<sup>th</sup> Street.
- 5) The Owners pick-up trash around 8:00 am and around 6:00 pm. There are two (2) garbage containers in front of the building.
- 6) Inside the establishment, there are two (2) big mirrors enabling employees to view the entire interior portion of the store.
- 7) 2900 Lisbon LLC has recently installed a new floor within the establishment. Remodeling continues at the store.
- 8) L. Johns Services will monitor the cameras via a cell phone. L. Johns Services will stop by or drive by the store several times throughout the day. If L. Johns Services observes any loitering, then those persons will be asked to leave the property. The Milwaukee Police Department will be notified if those loitering refuse to leave the premises.

9) There will be monthly meetings between the Owners and Alderman Russell Stamper. The meeting will take place at the Alderman's office. There will also be monthly meetings between the Owners and a Milwaukee Police Liaison Officer. The purpose of these meetings will be to review the recent activities of the store concerning safety. L. Johns Services will also be present at these meetings.
