to call police. The employees were cooperative. The officers were able to access the video system but found the system has not been recording since June 2021.

This report is written by P.O. Jaimee WARNER, assigned to District 3, Late Power Shift.

On Thursday, November 11, 2021 at approximately 10:22 P.M., P.O. Brandon BUELOW and I responded to 2175 N. 35th St., a Clark Gas Station, located in the City and County of Milwaukee, regarding a **Shooting Complaint.**

Upon arrival, Squad 3240 (P.O. Robin STOIBER and P.O. Benjamin WRIGHT) and Squad 3282 (P.O. Maxx CZISKE and P.O. Brian YOUNG) and us checked the parking lot for a possible scene. P.O. CZISKE went inside of the gas station and spoke with the clerk, Balvir SINGH (m/w 1-12-1963) who stated he did not hear anyone shooting and there was no shooting that occurred in the parking lot. SINGH advised P.O. CZISKE that the exterior cameras do not work and the interior cameras are only a live feed.

The victim, Andre R. JAMES (w/m 6-1-1989) advised detectives that he went inside of the gas station prior to getting shot.

I printed out a Milwaukee Police Department booking photo of JAMES and showed SINGH. SINGH stated JAMES did not come inside of the store at all. An employee, Dijon M. THOMPSON-LARK (b/m 12-4-2001) was inside of the gas station cleaning up. THOMPSON-LARK stated he has been at work since approximately 8:00 P.M. and had not seen JAMES enter the store either.

Both SINGH and THOMPSON-LARK were cooperative with MPD.

This report is written by P.O. Taylor ZUBE assigned to District 3, Late Power Shift.

On listed date and time officers were dispatched to 2175 N. 35th St. (Brother's Petrol) for a shooting call for service.

Upon arrival victim; Jason D. HOWELL (b/m, 9-6-2000) was located inside gas station with a gunshot wound to his right wrist and left ankle.

Scene was located at 2175 N. 36th St. in the alley; 7 9mm Luger casings, 1 fragment and 1_{\odot} cartridge were located. A shotspotter was associated for 10 rounds in the alley (F81-746188)

Unoccupied vehicle was located with 1 bullet strike to the rear bumper parked on rear slab of 2175 N. 36th St.

HOWELL stated he was walking to the gas station located at 2175 N. 35th St. when he heard gunshots and felt pain. HOWELL ran back into gas station just prior to police arrival.

2 witnesses were on scene who work at gas station and were interviewed by detectives. Both workers were cooperative with the investigation.

Michael W. MCCLAIN (b/m, 5-25-81) stated he was working behind the counter when HOWELL entered the store and called police after HOWELL stated he was shot. MCCLAIN stated he has known HOWELL for awhile now because he álways comes into the gas station. MCCLAIN stated that HOWELL then returned alone between 10:45pm and 11:00pm and that he was sure of the time because it was right around the time that he normally begins to count his drawer in preparation to close the store at 12:00am. MCCLAIN stated that when HOWELL arrived there were three other subjects that were already in the store and had been inside for approximately 10 minutes. MCCLAIN described them all as younger black males, thinly built, between 5'8"-5'10" and that one was shorter than the rest possibly 5'6"-5'8". MCCLAIN stated that he didn't get a good look at them because everything seemed normal in the store. MCCLAIN observed HOWELL speak to the subjects but didn't seem like the exchange was confrontational and the three subjects left followed shortly after by HOWELL. MCCLAIN stated it was possibly 10 minutes later he heard four gun shots at which point he called his co-worked, Curtis A NALLS (b/m 1-2-80), up from the back of the store to go outside and see what happened. MCCLAIN said that NALLS was gone briefly before returning inside and stating that he didn't see anything. MCCLAIN stated approximately 5 minutes later HOWELL came running back in saying he was shot. MCCLAIN stated that he didn't see any of the subjects or HOWELL with a firearm while they were inside the store.

Curtis A. NALLS (b/m, 1-2-80) stated he was stocking shelves when MCCLAIN told him he heard gunshots and to go see what had happened. NALLS stated that he was stocking the coolers when three subjects entered the store that he has seen in the area frequently and that he knows to sell marijuana and that they are normally at the gas station daily toward the end of their store hours, approximately 9/10pm until 11:30pm. NALLS stated that Subject 1 is almost always armed and coordinates with the other two subjects to meet people in the alley and sell them marijuana and possibly other drugs. NALLS said that he doesn't give them problems or ask them to leave because he does not want confrontation since Subject 1 always has a firearm. NALLS stated he continued to work for approximately ten minutes when his co-worker, Michael W MCCLAIN (b/m 5-25-81) told him that he (MCCLAIN) had heard gun shots and asked him to go outside and see if something happened. NALLS exited the store and walked to the N/E corner of the business and looked west down W Garfield Ave an saw subjects walking on the south side of the street approximately 1-2 blocks away but that they weren't running or doing anything suspicious. NALLS stated that MCCLAIN had told him to check the alley while he was out there but did not want to go into the alley at night alone because it wasn't safe. NALLS then returned into the store and told MCCLAIN hat he didn't see anything and

returned to work. NALLS exited the store and walked to the N/E corner of the business and looked west down W Garfield Ave an saw subjects walking on the south side of the street approximately 1-2 blocks away but that they weren't running or doing anything suspicious. NALLS stated that MCCLAIN had told him to check the alley while he was out there but did not want to go into the alley at night alone because it wasn't safe. NALLS then returned into the store and told MCCLAIN hat he didn't see anything and returned to work. NALLS stated the subjects' faces were covered with COVID masks but he's seen Subject 1's face before and could identify him as the subject in the store with two firearms but that he did not see the shooting occur.

MCCLAIN stated he did not have access to the camera system, but we were able to gain access and found that the cameras inside the location had not been recording since June of 2021 so the individuals inside the sore with HOWELL were not captured on video.

I conducted a call history of this location and did not find any calls for service regarding subjects with guns or drug dealing.

This report is submitted by P.O. Alexander DEY, assigned to District 7, Early Shift, Squad 7240.

On Wednesday, August 2nd, 2021, my partner (P.O. Monica SOSA) and I were dispatched to an Entry to Auto complaint at the address 7605 W Center St(Blamer's Auto), located in the City and County of

The incident location is a mechanic shop. It has a main office with an adjacent attached 2 car garage to the left of it. The building faces East towards N 76th St. It has an open parking lot that is not secured. The vehicle was parked in approximate spot#3 if observed from left to right near the wooden fence of the open parking lot. The building is red, white and blue in color.

On scene, I spoke with reporting person/subject identified as John H BLAMER (w/m 03-13-63) who is also the owner of Blamer's Auto mechanic shop. BLAMER stated that he has victim identified as Robert M JAEGER's (w/m 04-07-77) vehicle identified as a red 2013 Hyundai Sonata Gls (WI: 975YJT) vehicle in his mechanic auto repair shop. BLAMER stated JAEGER's vehicle was towed their over the weekend, due to it having mechanical issues. BLAMER stated that the vehicle was parked in the business's parking lot, which is in an open space.

BLAMER stated that on Wednesday, August 2nd 2021, at approximately 8:00 am, he discovered in the "morning" that the vehicle's right front window had been damaged. BLAMER stated that he then observed that the ignition to the vehicle was damaged. BLAMER stated that there were no witnesses per the event nor surveillance on site.

On scene, I observed that the vehicle was inside the garage part of the business. BLAMER stated that he had moved the vehicle into the garage space to "work on it", including attempting to fix the ignition. I observed at this point that the front right window was damaged and that the ignition was still damaged. BLAMER stated that the vehicle was not taken probably due to the vehicle having mechanical issues.

I observed that there was no chance of latent prints due to the extended time of incident occurrence and the reporting person (BLAMER's) interaction with the vehicle after. P.O. SOSA took photographs of the scene and damage to the vehicle. I observed no surveillance in the immediate area and no chance of canvas due to no residential housing in viewing of the incident location.

BLAMER stated that he has not had similar incidents related to this at his mechanic shop before. BLAMER stated that he has insurance on his business through West Bend Mutual.

Due to the evidence of the ignition damage and the recent times of the surplus of vehicle thefts of Hyundai and Kias, it is assumed that the suspect(s) were attempting to take and operate the vehicle.

At 5:09 PM, my squad changed location to the address of 2560 N 75th St (Wauwatosa) to meet with the victim JAEGER. JAEGER was issued a PV-17. JAEGER stated that he has been a victim of this incident once before with the same vehicle at his residence address. JAEGER stated that this mentioned incident the suspects successfully took the vehicle and abandoned it shortly after.

BLAMER is the owner of the business and the reporting person.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
