On Monday, May 2nd 2022 at 5:13 PM, my partner PO Luis RAMOS VARGAS and I, Squad 7223, were dispatched to a Battery complaint at 6171 N. Denmark St, located in the City and County of Milwaukee WI. Upon our arrival I met and spoke to the third party caller, Cha XIONG (F/A 08/19/1982) who stated her brother Naoli XIONG (M/A 7/11/1985) was assaulted on 04/30/2022 at 11:00 PM at the An Oxe Café located at 7411 W. Hampton Ave.

I met N. XIONG he stated was assaulted by multiple unknown actors at the An Oxe Café located at 7411 W. Hampton Ave on 04/30/2022 at 11:00 PM, he stated did not want to press any charges. C XIONG stated she took her brother to Froedtert Hospital on 5/1/2022 the admission time 10:07 AM, and treated by by Dr. Taylor SONNENBERG. N. XIONG suffered a concussion and an orbital fracture from his injuries.

C. XIONG showed me a video via social media the showed N. XIONG being assaulted by two unknown Asian males, suspect # 1 unknown A/M wearing a blue and white coat with blue jeans and a white shoes, suspect #2, unknown A/M wearing a black t-shirt and blue jeans, the video showed security staff trying to sperate the two unknown Asian males from assaulting the victim. I queried the address of An Oxe Café 7411 W. Hampton Ave, no calls were made to 911.

On Friday May 20th 2022 a 3:27 PM, I conducted a follow up investigation at An Oxe Café located at 7411 W. Hampton Ave . I met and spoke to the owner Sia XIONG (A/M 07/10/1973 who stated he did recall the incident on 04/20/2022 at 11:00 PM and was working at the time. S. XIONG stated the fight happened outside of the restaurant near the outdoor café he stated the victim was drunk his friends quickly picked him up and told An Oxe Café staff they would take him home.

S. XIONG stated he did not know that he had to call the police because the incident did not happen inside of his restaurant. I informed S. XIONG the any incident involving the patrons of his restaurant, both inside the restaurant and outside on his property i.e. parking lot and outdoor café, he must call the 911.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
