There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to

minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

To whom it may concern:

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 10/18/2022 at 10:10 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

- 3. On 03/27/2020 at 9:44pm officers observed Famous Smoke Shop/Cigar and Liquor Bar, 1213 E. Brady St, open for business. The officers went inside and observed the bar was selling grocery items from inside the shop. The officers spoke with the manager who stated they were only open selling the grocery items, which included Mac N. Cheese, toilet paper and instant rice. The officers advised that it appeared they were staying open for reasons other than selling grocery items and a PA33 report would be filed.
- 4. On 03/31/2020 officers responded to Famous Cigar Bar, 1213 E. Brady St, regarding the business being open in violation of the Governor's emergency order. The officers contacted the applicant who stated he was aware of the order and is in compliance. He stated he had contact with the Mayor's officer and was told he could operate the business to sell essential items. The applicant was advised the public could enter and conduct business but could not hang out on the property.

On Tuesday, August 2nd, 2022, at 10:48 AM, I, P.O. MATHEUS, Unit 1136, was dispatched to an entry at the Famous Cigar Shop at 1213 East Brady Street. Upon arrival I activated my body worn camera and written below is a synopsis of the interviews.

#### Interview of LESTER D. FONVILLE

Upon arrival I observed that the FAMOUS SMOKE SHOP was closed due to the entry. I observed that in the store were two employees, Manager ANDREW R. KLOSOWSKI, W/M, 07-25-1996 and Manager LESTER D. FONVILLE, B/M, 02-15-1963. I then interviewed FONVILLE, the caller.

FONVILLE stated that he arrived at work at 9:15 AM on Tuesday, August 2nd, 2022 and found the front door unlocked and slightly ajar. FONVILLE stated that he entered the business and turned on the lights in the back hallway. FONVILLE stated he went around the bar and found both cash drawers (one register on the east wall and one register on the counter) open and \$200.00 missing from each register. FONVILLE stated that he found \$34.00 in quarters, dimes, and nickels missing from a cigar box that had been under the cash register on the counter. FONVILLE stated that he also discovered missing from under the counter near the counter register a green bank bag (with the possible name of Associate on the bag) containing \$400.00 in bills and coins.

#### Interview of ANDREW R. KLOSOWSKI

I interviewed Manager ANDREW R. KLOSOWSKI, W/M, 07-25-1996 who stated that he arrived at work at 10:30 AM and was informed by FONVILLE of the entry and theft of money. cigar case on the south wall. KLOSOWSKI also pointed out a brass cross on the floor that had fallen off of a cigarette machine near the cigar case. I observed behind the cigar case a 54" x 28" window that was open.

KLOSOWSKI stated that he received a surveillance camera still photo from the owner, JOHN PIETTE, that showed the suspect to be a B/M wearing a black face mask and light-colored clothing. KLOSOWSKI, stated the person in the still photo is a photo of a B/M he knows as HENRY, a person that has come into the business in the past. KLOSOWSKI described HENRY as a B/M, 55 to 60 years of age, 5' 8" to 5' 10", slim build, medium complexion and bald head. LESTER FONVILLE stated that he had HENRY'S phone number which is 414-514-7000. KLOSOWSKI stated that HENRY (KLOSOWSKI does not know Henry's last name or address) had been a customer for the last three years. KLOSOWSKI stated that HENRY would come into the store and talk to the owner, JOHN PIETTE. KLOSOWSKI stated that he last seen HENRY in the business during the Brady Street Festival on Saturday, July 30th, 2022, at 9:00 PM. KLOSOWSKI and FONVILLE believe that HENRY might have lived at Arlington Court, 1633 North Arlington Place.

I sent KLOSOWSKI a evidence.com video invite and KLOSOWSKI uploaded three still photos of the suspect at 1:58 PM on August 2nd, 2022.

I asked KLOSOWSKI if the Famous Smoke Shop was willing to prosecute and KLOSOWSKI stated yes.

#### Interview of JOHN H. PIETTE

On Tuesday, August 2nd, 2022, at 4:10 PM, I called Famous Smoke Shop owner JOHN H. PIETTE, W/M, 07 -20-1968 and PIETTE stated that the video showed the B/M suspect appear in the store at the the south side of the business at 4:40 AM on Tuesday, August 2nd, 2022. PIETTE stated that the B/M took the money and exited the store through the front entrance at 4:42 AM.

I sent PIETTE a evidence.com invite for the video and as of 5:27 PM on Tuesday, August 2nd, 2022 and PIETTE uploaded the video at 9:02 PM on Tuesday, August 2nd, 2022.

PIETTE stated that he had talked to the B/M a week ago and that HENRY would talk about basketball. PIETTE stated that he had seen HENRY in the area for the last six to eight years. PIETTE described HENRY as a B/M, 50 years of age, 5' 05", slim build and clean shaven.

I asked PIETTE if he is willing to prosecute and PIETTE stated yes.

# Description of scene and description of video

The below described video was recorded by an interior camera that pointed toward the south wall.

On Tuesday, August 2nd, 2022, at 4:40 AM, the suspect forced open a 54" x 28" window on the south side of the Famous Smoke Shop at 1213 East Brady Street. The suspect climbed through the window onto the cigar cabinet on the south wall and surveillance video showed the suspect jump down from the cigar cabinet onto the floor. As the suspect jumped over the edge of the cabinet he broke off the wood molding on front of the cabinet which fell to the floor. The suspect also knocked to the ground a brass

cross that was on a cigarette machine that was next to the cabinet.

The suspect ran behind the bar/display counter and ducked out of view and removed a bank bag with \$400.00 from under the counter. The suspect came back into view and removed \$200.00 from the cash register on the counter. The suspect removed \$34.00 worth of coins from a 6 3/4" x 6 3/4" cigar box that was under the cash register on the east wall. The suspect then removed \$200.00 from the cash register behind the bar on the east wall. The video showed the suspect walk toward the front door while carrying a green bank bag with white writing on the bag under his right arm. The video showed the suspect walk out of view (and out the building).

The suspect in the video was a B/M with a bald head and wearing a white t-shirt, white shorts, light colored gloves and black facial mask.

On Wednesday, August 24th, 2022, at 11:58AM, while assigned to squad 1164, I conducted a License Premise check of Famous Smoke Shop (1213 E. Brady St.). On my arrival, the street was clear, and there were two small tables and chairs in front on the curb line in accordance with their license.

I spoke with two employees on site, identified as Aaron E. Willis (B/M 05/05/1980) and Anthony Wiener (W/M). Anthony had to leave before I could gather more of his personal information. I asked Anthony and Aaron if they were blocking off parking spots in front of their location with cones. Anthony and Aaron stated their boss asked them to place a cone in the street where the tables and chairs were, to prevent cars from parking near their tables. I advised them they will need to contact the City, and at this time, that is not allowed. Anthony and Aaron stated they will let their boss know, identified as the **Business Agent John PIETTE.**
