Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

I live 53202) on the from the bar "McGillyCuddy's" (1133-37 N Water St Milwaukee, WI

. Nearly every floor at the intersection of single night this summer (including weeknights) the bar plays extremely loud music with their outdoor DJ setup from approximately 9pm to 2am. This has cost me countless hours of lost sleep since the music is so loud I can hear it clearly in my apartment. I had contacted the Milwaukee Police Department several times about the issue with little help until finally an officer informed me that the bar has a "Public Entertainment Premises License" which makes them exempt from normal noise regulations. The officer told me to get in contact with my local Alderman. After some research I discovered that the regulations for this license stipulate hours of operation:

108-23. Hours for Public Entertainment

1. INDOOR PUBLIC ENTERTAINMENT. Indoor public entertainment shall be permitted as established by the common council in its approval of the licensee's plan of operation. 2. OUTDOOR PUBLIC ENTERTAINMENT. Outdoor public entertainment shall be discontinued no later than 10:00 p.m. Sunday through Thursday nights and no later than 12:00 a.m. on Friday and Saturday nights, unless a different time of discontinuation, either earlier or later, is established by the common council in its approval of the licensee's plan of operation.

If McGillyCuddy's has not established a different time with the city council then they have been in violation of their license. If this is the case I ask that they be penalized properly for the

infraction. If they are operating within their agreed upon plan of operation I ask for your advice on any other ways to resolve this situation since I have no other ideas.

I'd like to mention that I am taking this course of action not because I dislike the bar, the owner(s), customers, etcetera but solely because I have been unable to get the proper amount of sleep and it has become a great nuisance in my life.

I believe that "McGillycuddy's Bar & Grill" (1133-37 N Water St Milwaukee, WI 53202) is violating their Public Entertainment Premises License, specifically the section that stipulates:

1. INDOOR PUBLIC ENTERTAINMENT. Indoor public entertainment shall be permitted as established by

2. OUTDOOR PUBLIC ENTERTAINMENT. - 4. Corporate officer Jeffrey Kovacovich has an open warrant with the Muskego Police Department for Failure to Pay. N1072525.
- 5. On 06/24/13, at 12:45 am, Milwaukee police were dispatched to 1135 N Water Street for a Fight complaint. Police spoke with the bar manager, David Kuklin, who stated there were a group of females in the front area of the bar who were verbally arguing with each other for an unknown reason, when the fight became physical. Kuklin stated his security broke up the fight and escorted the females out of the bar. All parties fled prior to police arrival.
 - 6. On 12/15/2013 Milwaukee police responded to a fight complaint at 1135 North Water Street (McGillcuddy's Tavern). Investigation revealed that a fight took place inside the business and an individual who works as security was struck in the back of the head with a glass during the fight. The victim received 6 staples in the back of the head as a result of this incident. Milwaukee police incident report #133500003 filed.
 - 7. On 02/02/2014 Milwaukee police responded to a fight complaint at 1135 North Water Street (McGilluddy's Tavern). Investigation revealed two patrons of the business were involved in an altercation. Both patrons were cited.
 - 8. On 05/03/2014 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to McGillycuddy's Tavern (133-1137 North Water Street). The police aide was turned away when she could not provide proof she had turned 21 years of age.
 - 9. On 10/27/2014 Milwaukee police responded to a battery complaint at 740 West Wisconsin Avenue #103. The victim, James Newkirk, told officers he had been at McGillycuddy's Bar (1135 North Water Street) the previous evening (10/26/2015) and someone punched him in the face. Mr. Newkirk stated he was intoxicated and has absolutely no recollection of what happened. He further stated the manager of the bar gave him a ride to St. Mary's hospital where he was diagnosed with a concussion, a fractured right eye socket, and two broken teeth. Officers spoke to the general manager of the business, Tate Winckler, who stated he was aware of a fight the previous night because the manager told him about it. Mr. Winckler also told officers there are no working cameras inside the bar, that the manager was currently unavailable for interview and that no one from the business had called police. Milwaukee police incident report # 143000136 filed.

- 10. On 11/01/2014 Matthew Sokol walked into Milwaukee police district #1 to report that his wallet had been stolen from his rear pocket the previous evening while at McGuillicuddy's (1135 North Water Street). Mr. Sokol also told officers he had no idea who took it. Milwaukee police incident report #143050071 filed.
- 11. On 01/18/2015 Milwaukee police responded to a battery complaint at 1135 North Water Street (McGillycuddy's). The victim stated he was escorting an unruly patron from the business when he was punched in the face by another patron. Both patrons were apprehended and cited.
- 12.On 02/19/2015 Milwaukee police conducted a licensed premise check at 1133 North Water Street (McGillycuddy's) and provided Patrick Murthey was a packet of tavern related ordinances.
- 13.On 02/27/2015 a 19 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to McGillycuddy's (1133 North Water Street) but was denied when she could not produce proof she had attained the legal drinking age of 21.
- 14. On 08/08/2015 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to McGillycuddy's (1133 North Water Street) but was denied when she could not produce proof she had attained the legal drinking age of 21.
- 15. On 10/23/2015 Milwaukee police, while inside McGillycuddy's Tavern (1135 North Water Street) on a Code Red Deployment, were advised by a security guard that he had been stabbed. Investigation revealed two patrons of the business had been told to leave by security. One of the patrons dropped his right hand and thrust it back up, striking the security guard in the left side of his stomach. The security guard saw blood and realized he had a laceration to his abdomen. This laceration required 3 sutures. This same patron punched another security guard in the eye. Milwaukee police incident report #152970015 filed.
- 16.On 01/17/2016 Milwaukee police were flagged down by the manager at McGillycuddys tavern (1135 North Water Street) who stated there was a fight involving as many as 15 people at the business. Officers observed numerous subjects involved in a fight and cited 4 individuals for disorderly conduct.
- 17. On 02/04/2016 Milwaukee police conducted a training course at The Winchester (2321 North Murray Avenue) regarding the use and identification of fake driver licenses and other identification for gaining entry into taverns. A representative of McGillycuddy's Bar and Grill was present at this training.
- 18. On 10/15/2016 at 2:35am officers arrested subjects in front of McGillycuddy's tavern, 1135 N. Water St. The subjects were not related to the tavern but the manager assisted the officers with retrieval of video surveillance which aided the investigation.
- 19. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to McGillycuddy's, at 1133 N. water St. The Police Aid was denied by security at the door.

- 20.On 06/25/2017 officers observed two subjects being pushed out the front door at McGillycuddy's, 1135 N. water St. The subjects began fighting and it took several officers to stop the fight and arrest the subjects. A review of video surveillance inside showed the same two subjects fighting inside then being pushed outside.
- 21. On 07/23/2017 a subject walked in to District one to file a complaint of a battery that occurred at McGillycuddy's. 1135 N. Water St. The victim stated he was at McGillycuddy's with a female friend when a subject grabbed her arm. He stepped toward the subject and asked him why he grabbed her arm. The subject then punched him in the face. The bar separated the parties, sending one set to the front and one to the back. The manager stated he thought it was an argument and didn't realize anyone was hurt until after the parties left. The victim was treated at St Mary's hospital and the lacerations required 13 stitches to close. MPD report filed.
- 22. On 01/27/2018 officers were dispatched to McGillycuddy's, 1135 N. Water St., for a fight between three females. When the officer arrived the manager pointed out three females that where walking away. The subjects stated they were kicked out of the bar for no reason and one of the staff called one of the subjects a racial name. Since the subjects were not fighting each other they were allowed to leave. Later the officer learned that a staff member was hit with a thrown bottle while kicking out the subjects. The employee required 6 stitched to close a cut above his eye. There was no video that captured this incident.
- 23.On 03/05/2018 officers were dispatched to 1135 N. Water St for a battery complaint. The officers spoke with the complainant who was security guard at the establishment. He stated as he was kicking out a subject who jumped the fence the subject hit him with a closed fist. The subject was arrested and conveyed to the District.
- 24. On 03/31/2018 officers investigated a battery complaint at McGillyCuddy's Bar, 1135 N. Water St. The victim stated he was hit by another patron while he was inside the bar. The officers observed the video tape, which did capture the incident.
- 25. On 04/22/2018 officers were dispatched to a fight at 1135 N. Water St. The staff stated there was a subject, who threatened to shoot up the premise, inside refusing to leave. The officers spoke with the subject and were able to get him to leave. The staff stated they did not want to file a complaint and just wanted the subject to leave.

- 26.On 11/24/2018 officers investigated a battery at St Joseph's hospital, that occurred at McGillycuddy's bar, 1135 N. Water St. The victim stated he was in the patio area and was struck by a flying bottle which caused a laceration to his face. He stated he did not tell any staff members or police in the area and just went home. The victim stated he did not want a police report. The officer spoke with the manager at McGillycuddy's, who stated he was aware the police came in the night before but did not know about any incidents that night. He allowed officers to view the surveillance video, which did not show the incident.
- 27. On 11/29/2018 officers conducted underage tavern enforcement in District 1. An underage Police Aide attempted to gain entry to McGillycuddy's, 1135 N. Water St. The Police Aide was allowed entry and was served a Miller Lite at the bar. The bartender was identified and issued a citation.

- 28.On 03/31/2019 at 2:07am officers were flagged down for a fight at McGillycuddy's, 1135 N. Water St. The officers spoke with several people who stated they were punched by security while being escorted out after a fight. The officers viewed the video surveillance which did show the fight. They observed security break up the fight and escorting the subjects out but did not observe any security officer punch a patron. The staff was cooperative with the officers and handled the incident appropriately.
- 29. On 07/21/2019 at 2:00am officers were flagged down by security at McGillycuddy's, 1135 N. Water St, for a Trouble with Subject. Security pointed out a subject who attempted to punch them. The subject fled when the officers attempted to stop him. He was caught and issued citations.
- 30. On 08/14/2019 at 2:12am officers observed 5 people walk out of McGillycuddy's, 1135 N. Water St, after closing time. The officers entered and observed an additional patron exit the bathroom. The manager stated he thought it was okay to have patrons in after hours as long as they were not drinking. The manager was advised to have all patrons out of the building by closing time.
- 31.On 08/30/2019 at 11:51pm officers were flagged down by McGillycuddy's, 1135 N. Water St, for a Trouble with Subject. The officers observed security detaining subject. The investigation revealed the subject attempted to leave without paying for his bar tab. He was issued a citation and released from the district.
- 32.On 10/06/2019 at 10:38pm officers were dispatched to a fight at McGillycuddy's bar, 1135 N. Water St. The caller reported 20 people fighting both inside and outside the bar. When the officer arrived they observed a large fight that required 7 squad to be caller to restore order. The security cameras did capture the fight.
- 33. On 10/14/2019 at 9:45pm officers were flagged down for a Trouble with Subject complaint outside of McGillycuddy's bar, 1135 N. Water St. The security guard stated a subject was intoxicated and was kicked out for attempting to fight other patrons. The subject was locked out and damaged the door attempting to get back inside. The subject was cited for Disorderly Conduct and Damage to Property.
- 34. On 12/10/2019 officers conducted fake ID training for McGillycuddy's staff. About 15 employees were in attendance and learned how to prevent underage drinking.
- 35. On 03/20/21 at 2:18am, Milwaukee Police responded to a battery/cutting which occurred on the sidewalk in front of 1135 N. Water Street. Investigation revealed that a verbal altercation began outside the tavern and a subject stabbed another subject in the stomach three times requiring medical attention. During the incident, the tavern was empty of patrons and the owner of the establishment was cooperative with officers providing them with video surveillance which ultimately led to the subject's arrest. There were no tavern violations observed.

- 36. On 04/01/21 at 10:41pm, Milwaukee Police conducted a license premise check at 1135 N. Water Street. No violations were observed, the establishment was cooperative and appeared to be following all Covid guidelines.
- 37. On 09/04/21 at 2:13am, Milwaukee Police, while on foot patrol, observed a fight spill outside the vestibule of 1135 N. Water Street. Officers intervened in the altercation and investigation revealed that several subjects inside the tavern were harassing a couple of female patrons and a fight ensued between patrons. Security broke up the fight and had to physically escort them out of the establishment. Security acted with restraint while ejecting these patrons and were helpful with the police on scene dealing with the fight outside.
- 38. On 05/30/22, Milwaukee Police, while on foot patrol in the N. Water Street tavern area, were flagged down by citizens and told that there were subjects with guns on the patio at 1135 N. Water Street. While standing outside the patio area, officers observed citizen's dragging a subject out of the patio and onto the sidewalk. The group then walked away and out of eyesight of the officers. Officers then heard a gunshot and while investigating, began a foot chase with the subject described by the citizen as having the gun. The subject was apprehended and charged.
- 39. On 07/14/22 at 12:52am, Milwaukee Police, while monitoring the tavern district around N. Water Street and E. Juneau Avenue, observed a large fight outside 1135 M. Water Street. Investigation revealed that the fight started between two groups inside the establishment and continued outside after security escorted out. Employees were cooperative with the investigation.

On Monday May 29, 2022 I was assigned Code Red overtime at District 1 on squad 1443 with Police Officer Jamar LUCKY.

P.O LUCKY and I were assigned to North Water and East Juneau St for Code Red. P.O LUCKY and I started the shift at 7:00 P.M and were on the same street for the duration of the shift.

While assigned to Code Red we are asked to monitor bars, restaurants and other businesses. We often go inside of the businesses to show presence and to introduce ourselves.

While on Code Red we typically get out of the squad cars and walk our strip to keep busy and to again show presence.

P.O LUCKY and I were standing at approximately 165 E Juneau when we were approached by two male citizens who stated that there was approximately three black males in McGillycuddy's with firearms and it seemed as if their intentionally looking for trouble. The two citizens stated that they left the business to avoid trouble after seeing the incident a few weeks ago during the Milwaukee Bucks Playoff Game. Mcgillycuddy's is located at 1135 N water St, there is an indoor bar and an outdoor patio.

The two male citizens stated that all of the subjects with the firearms were on the patio, the citizens failed to give us detailing descriptions of the subjects besides black males. Once this information was received we passed it to the officers and sergeant that was assigned to code red on water and Juneau st.

At the time of the getting this information we didn't have much to work off of to find these subjects or do anything about it. P.O LUCKY and I took the limited information of we had and went over to the patio of McGillycuddy's to observe the business.

While outside of the business by the patio we noticed that for approximately two hours everyone that entered the business from the patio was able to show an id and just enter the patio. No one was pat down for weapons, no one was check with a wand, there were no metal detectors and no purses or bags were opened and looked into or felt to insure that weapons weren't being brought into the business.

P.O LUCKY and I were not sure of the policies or normal security measures that is in place at McGillycuddy's so we continued to stand and monitor the patio from the outside of the fence.

While monitoring the business a guy and his girlfriend approached P.O LUCKY and I and stated that there were multiple subjects in the business on the patio with firearms and they didn't feel safe so they were leaving. These two people stated that one of the subjects was a black male with short dreadlocks,

wearing a black hoody with a design on the front.

P.O LUCKY and I observed a subject matching that description, the subject was accompanied by another black male subject. While watching the subjects we didn't see a firearm or anything that resembled a firearm so we had no reason to make contact with the subjects.

P.O LUCKY and I went to the front door of Mcgillycuddy's Where we were met by a guy who stated he was the manager of the business and asked us if everything was alright. We told him that we were going to do a walk through at the business because we have gotten several complaints about subjects in the business with firearms.

One of the subjects who was described as being in possession of a firearm had left the business through the front doors and later returned. While there we personally didn't see anyone in possession of a firearm. The manager was also informed that no one was being checked at the door.

We didn't get much help from the manager as the security continued to just let people come into the business without doing anything. P.O LUCKY and I didn't get the managers name during the process. Later while still on Code Red P.O LUCKY and I were with approximately four more cops by the patio of McGillycuddy's when we heard a lot commotion followed by a guy being pulled out of the business fence by a male and female citizen. The individual that was being pulled out was observed to be wearing one shoe, he had jewelry in his hands and the front neck portion of his t shirt was stretched out as if there was some sort of physical altercation, these people were later victims of 1st Degree Reckless Endangering Safety.

During this incident the security never flagged us down or asked for assistance in any kind of way. The victims all walked away together so we didn't stop them. Once they were out of the business there was no further incident for us to respond, and no one approached us or stated they wanted to report anything.

The victim that appeared to had been in a physical altercation was upset and was stating "Okay, watch this watch this" as he along with the two people who came out of the bar with him began to walk east bound on East Juneau St.

The victims began walking east bound on Juneau St and then north bound on N Water St. As the subjects were walking on Water St, we observed approximately five to six subjects yelling at the victims. The victims continued walking north bound on N Water St as the other subjects were still yelling at them and walking north bound as well.

P.O LUCKY and I along with the other officers began to look at both parties of people as the victims were walking away on North Water St and the other party continued to yell and try to antagonize them. Due

to the subject statement as "watch this" and the other party trying to engage them we figured there was going to be a problem.

P.O LUCKY, P.O Jazzmin KING, P.O De'Shon NASH and I began to walk north bound on North Water St behind both parties to solve any issues that might occur. P.O Zachary LATAWIEC and department issued horse started going east bound on east Juneau St.

While we were walking I observed a black male wearing a black hooded sweater with writing on the front and writing on the back that says "anti-social club" black jeans, and black gym shoes along with another subject running towards the victims. The subject running had both his hands in his front hoody pocket; he was later verbally identified as Amarri M. CARTER (b/m, 6/21/01).

The victims turned around and observed CARTER and another subject running behind them so they all began to run. I then informed the other officers that one subject had his hands in his pockets while chasing the victims.

P.O LUCKY and I began to walk towards where the subjects were running, we then started to jog and as we were approaching we heard what sounded like a single gunshot coming from N Water St and E Knapp St.

While running and activating our body cameras we approached the corner of E Knapp St and observed an officer talking to an unknown black male. That black male pointed to the east and stated "them right there, they shooting".

P.O LUCKY and I rounded the corner we observed CARTER and another subject who was later identified as Samual G. RODATOS (w/m, 10/13/93) walking on the south side of the street going east bound on Knapp St.

P.O LUCKY yelled "hey stop police" as CARTER and RODATOS began running. P.O LUCKY ran after RODATOS as I went after CARTER.

While chasing behind CARTER I yell "hey hey, get on the ground" as CARTER continued running in attempt to avoid arrest. I gave CARTER several commands to get on the ground as ran away from me, twice while running CARTER looked back at me and continued running.

During the foot pursuit of CARTER he looked back at me and picked up speed, showing that he wasn't willing to stop. Carter continued running south bound in Milwaukee School of Engineering fenced in parking lot. P.O LATAWIEC and his horse were coming directly towards the way that both CARTER and RODATOS were running.

CARTER noticed the horse coming his way and began to slow down, he then started looking around for an exit route at which time he didn't have any. CARTER then stopped put his hands up and was given orders to get on the ground. CARTER was handcuffed and then searched before being placed in a marked squad car.

Later during this investigation it was revealed by the victims and suspects that this incident stemmed from something that occurred at Mcgillycuddy's.

It was later revealed that the suspects were in fact armed with firearms in Mcgillycuddy's and it was revealed that the subjects were also drinking alcohol in Mcgillycuddy's.

The subject stated that 2 groups of patrons began to argue inside the tavern and began pushing each other before being escorted outside by security. Once outside the 2 groups began fighting each other.

I was able to watch surveillance video inside the bar that showed the 2 groups involved begin to argue/push each other inside the tavern before being escorted out of the tavern. I also observed the physical fight that occurred just outside the front door of the tavern.

Security quickly intervened and attempted to stop the fight from occurring inside the tavern and ejected those involved. Bar staff was cooperative with the investigation into this incident.
