There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

LICENSED PREMISE REPORT - HOMICIDE INCIDENT

This report is being written by PO Stephen COLWELL, assigned to District Five, Early Power Shift, Squad 5266.

On 9/23/22 at 12:23 PM, squads were dispatched to the Community Tire Service shop at 844 W Atkinson Ave after a 911 call was placed stating a male subject was shot in the leg and head. The caller later reported a second subject had been shot in the shoulder. A witness on scene stated an unknown male subject arrived on scene and was standing outside of the business making threatening comments indicating something was about to occur at the location. This unknown male subject then went inside the tire shop and discharged a firearm multiple times, striking both victims inside the tire shop while they were working. The suspect then fled the location on foot. The victim shot in the head and leg was transported to Froedtert Hospital and treated for his injuries. The second subject who had been shot in the shoulder was pronounced deceased on the scene by the Milwaukee Fire Department at 12:53 PM. The business was conducting business during their normal business hours when this incident occurred. Multiple casings were located inside the business.

On Friday, September 23rd, 2022, at 2:33 PM, I conducted a business check at Community Tire Service located at 844 W Atkinson Ave, City and County of Milwaukee. This business check was conducted following a homicide incident which occurred at the location on 9/23/22 at 12:23 PM. (CAD: 222660753)

I spoke to a male subject, identified as Latrelle NMN GRICE (B/M, 12/12/1981), who stated he is the owner and operator of Community Tire Service. GRICE stated he operates five tire shops in the City of Milwaukee. GRICE stated the above location has three full time employees. GRICE stated he frequents this location often but he is not on site full time.

GRICE stated the hours of operation are as follows:

- Monday-Saturday 8:00 AM 6:00 PM
- Sunday 10:00 AM 4:00 PM

GRICE stated the location does not currently have any interior or exterior cameras but he plans on installing cameras as soon as possible. GRICE stated the license for the property is for "Light mechanic" work.

A search of issued licenses for the location show this business has a "Junk/valuable metals, salvage

vehicle parts, waste tire" license, which was issued on 9/22/2020 and expires on 9/30/2022. The listed agent on the license application was a Michael L GRICE (B/M, 8/4/1957).

The exterior of the business appeared to be well maintained and was free of excessive litter or debris.

Latrelle GRICE was cooperative with police and the investigation.



The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 11/9/2022 at 11:20 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
