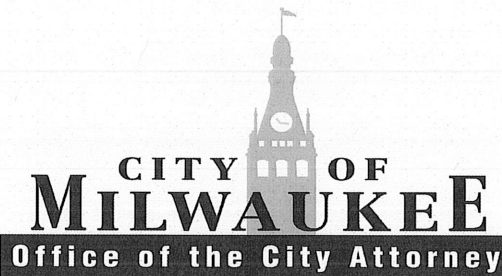


Dear Council Members:


Enclosed please find a proposed resolution authorizing the contingent borrowing necessary for payment of the settlement amount regarding the claims asserted by the plaintiff in the above-noted case against the City of Milwaukee and DPW, as well as authorizing the settlement of said case. We respectfully request that the enclosed resolution also be referred to the appropriate committees for review.

On July 11, 2018, plaintiff Bradley Seubert was riding his bicycle on the Hank Aaron Trail. Mr. Seubert fell as his bike slid out from under him while traveling over a crosswalk that had been repainted and embedded with glass beads by DPW earlier that day. Mr. Seubert sustained personal injuries, wage loss and property damage as a result of this accident.

Because settlement in this matter is deemed expeditious, we recommend payment of the proposed settlement amount of \$50,000.00, and have enclosed an appropriate resolution for your convenience.
