Your Class B Tavern and Public Entertainment Premises License Renewal Applications as agent for "2579 Teutonia LLC" for "Vibe Lounge" at 2579 N TEUTONIA Av.

There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings in City Hall is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of East Kilbourn and North Water Street. Parking tickets must be validated in the first floor information booth in City Hall.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 12/03/20 at 7:58pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. The reason for the check was because officers knew the establishment did not have a license and on 12/02/20 they observed a number of vehicles parked out front and the lights and televisions were on. Police were not able to perform a premise check on that date because they were flagged down for an assignment. When officers entered the establishment, they observed six people inside, multiple televisions on throughout the tavern, music playing, and a multi-colored strobe light functioning. Officers interviewed the owner who stated that he was open for business and when he was told that he did not have a license yet, he became uncooperative and defensive. The owner said that he was emailed the license and called the alderman requesting that he email them again. When advised that he needed a paper copy of the license, the owner became defensive and asked why he was being told he needed a license and what requirements he needed to be met. Officers told him he would have to contact the city licensing division to find out what requirements had to be met and the owner said that he will have a license next time they meet.
- 2. On 02/19/21 at 9:47pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. Officers observed numerous vehicles, some illegally parked, and two lines outside the front door. Due to the large crowd, officers asked security outside, on two different occasions, if they could speak to the owner, but the owner did not come outside to speak with officers. Officers monitored the crowd and at tavern close, they roughly counted 519 people

exiting the establishment using a hand-held counter (tavern capacity is 160). Due to a shooting in the area, officers were unable to make contact with the owner. The applicant was cited.

- 3. On 03/06/21 at 11:49pm, Milwaukee Police, along with the health department, conducted a license premise check at 2579 N. Teutonia Avenue. During the interaction, officers conducted a walkthrough and observed patrons not social distancing and not wearing masks. They interviewed security and ask how many patrons were inside and security told officers that they had counted 500 patrons (capacity of 160). After leaving the location, health department officials told officers that they would be issuing citations for standing, masks, social distancing, and over capacity totaling around \$12,000 (no citations could be found in the system).
- 4. On 03/15/21 at noon, a meeting was held at the Third District Police Station with the applicant of 2579 N. Teutonia Avenue. The meet was held because of the capacity issues and the owner of the business was not cooperating with police. The applicant said the manager of the establishment is named "Rob" (he does not know his real name and pays him through pay applications) and that the owner only owns the building, not the business inside, and should only be contacted when there is a maintence issue. The applicant was unsure of the security companies name but said that he has at least one security guard there at all times. When asked about the overcapacity, he said he was unaware of the issue but would make changes and would be at the location more often. The applicant was told he would be cited for the overcapacity on 02/20/21 (no citations could be found in the system).
- 5. On 03/18/21 at 9:48pm, Milwaukee Police conducted a license premise check at 2579 N. Teutonia Avenue. Upon arrival officers made contact with the front door employee who advised them who the manager was and they asked both of them the identity of manager "Rob". They told officers that the dayshift manager was named "Ron" and that he works sometime in the morning. The manager was asked if he knew the capacity of the tavern and he told officers that it was 260. When told that it was 160, the manager became defensive stating that it was "updated" today.
- 6. On 03/19/21 at 1:09pm, Milwaukee Police conducted follow-up regarding the manager named "Rob". The business appeared to be closed but a maintence worker answered the door and said that the only manager he knows is "Doug".
- 7. On 03/20/21 at 12:52am, officers observed a large number of vehicles, several illegally, parked on the street surrounding 2579 N. Teutonia Avenue. There were also 20-25 vehicles circling the area, blocking traffic, trying to find a place to park and 20 people standing outside the front entrance waiting to enter the tavern. While parking enforcement was handling the illegally parked vehicles, one officer, with the squad and body camera activated, started counting the patrons leaving the establishment and afterwards went inside to finish the count. While inside, the manager of the tavern refused to allow them to walk to the rear of the tavern to count the patrons still inside. The police left the tavern and ended up with a final count of 169 patrons (capacity 160).

- 8. On 03/21/21 at 1:53am, Milwaukee Police were dispatched to Mt. Sinai for a shooting victim. Investigation revealed that the victim was waiting in line to enter the tavern, located at 2579 N. Teutonia Avenue, when she got into a verbal argument with another subject. After finding out that the tavern was not letting anyone else inside, she walked back to her vehicle where she again was confronted by the suspect who shot her twice. Another squad was on scene and said the manager was cooperative with officers.
- 9. On 03/27/21 at 11:43pm, officers observed a large presence of vehicles parked, some illegally, outside the address of 2579 N. Teutonia Avenue. Parking enforcement was advised, security for the tavern was notified, and several patrons moved their vehicles. Several parking citations were issued.
- 10. On 04/25/21 at 12:30am, Officers observed approximately 200 vehicles parked surrounding 2579 N. Teutonia Avenue which is the only establishment open in the area. Officers also observed 10-15 people standing outside the tavern waiting to get in. Officers tried to enter the establishment but the front entrance was locked and security outside did not know why the door was locked. Someone eventually unlocked the door and when officers entered, there was a "smoky haze" inside which was later determined to be smoke emanating from cigarettes/cigars. While inside the tavern officers observed numerous 20oz empty bottles of Hennessy laying around, baggies of marijuana, cigarette buts, loose tobacco, and cigar wrappers on tables. The basement was checked and the breaker box for the building had wires exposed which could be a fire hazard and the only other exterior door to the tavern was locked and the courtyard it exited to, had a fence which was chained and padlocked. The applicant was contacted and told his establishment was 105 people over capacity.

Investigation revealed that the uncooperative caller said the incident happen inside the tavern located at 2579 N. Teutonia Avenue. Officers interviewed security who said that an altercation did happen inside the establishment and the female said the male had a firearm. Both subjects were escorted out, the male subject was searched, and no firearm was recovered. Security was cooperative.

### INITIAL OBSERVATIONS

On Sunday November 14, 2021 at approximately 1:13AM while on routine patrol in the area of N. Teutonia Ave. and W. Clarke St. P.O. STEINBERG and I (Squad 3465) observed approximately 145-150 vehicles parked on N. Teutonia Ave. and W. Clarke St. surrounding Vibe Lounge (2579 N. Teutonia Ave.) which is the only open establishment in this area at this time of night. Based on this observation and knowledge that Vibe Lounge has a listed capacity of 160. I contacted and requested multiple squads and Sgt. DECLEENE (Squad 3313) and advised her I wanted to conduct a count because I believed them to be over capacity.

and N Teutonia Ave. I positioned my squad facing southbound on N Teutonia Ave which our AXON squad camera was activated and captured the East wall and rear exit door of the establishment. I activated my Axon Body Worn Camera and approached the front door to the establishment where at least two security guards were posted outside. Security outside the front door, later identified as Kathleen NMI WILSON(b/f, 10/15/1976) stated they were at 175 people inside the bar. WILSON also stated that security inside the door was using a clicker to keep track of the number of patrons. As we entered the bar contact was made with the manager, Dominque NMI JONES(b/f, 06/25/1985). JONES stated she did not know where the counter was however security was suppose to be using one. At no time during the investigation was a counter presented to me. I advised JONES that we would be conducting a capacity check and that patrons needed to exit the front door.

It should be noted that as police entered the establishment numerous patrons exited upon seeing police enter. P.O. STEINBERG and I stood at the front door of the establishment as patrons exited. I counted the number of patrons as they exited both out loud for my body camera to hear as well as on a hand held clicker. As we were counting SGT DECLEENE advised me that patrons were exiting out a rear door located on the East side of the building. Sgt. DECLEENE was not able to count but estimated at least 30 patrons exited the side door. Per Vibe's occupancy license they have a **total capacity of 160** which includes their employees. Once all patrons had exited the establishment I entered to finish counting the employees left inside. I ended with a **total count of 168** patrons and employees. This does not include the patrons that departed out of the side door. I later reviewed squad camera footage and definitively observed 70 patrons exit the side door possibly more which the door was partially obstructed by a vehicle. **168 patrons and employees that were counted on the clicker plus the 70 counted on squad camera total 238 which is 78 persons over their capacity limit.** 

I advised JONES that a citation for over Capacity would be issued.

This report is written by Police Officer Demetrious HUDSON assigned to District 3 Modified Early Shift.

On Wednesday, November 17th, 2021 at approximately 3:19 PM, my partner Police Officer Kurt KEMNITZ and I (Sq: 3272) conducted a License Premise check at the location of 2579 N Teutonia Avenue (Vibe Lounge), which is in the City and County of Milwaukee, Wisconsin. We assisted the Department of Revenue agent Georgeann King in the License premise inspection who also conducted the field report and inventory report.

Upon arrival, the front entrance to the location was unlocked. We entered the location and were greeted by the maintenance man identified as **Thomas L. Marshall (B/M 01/28/1976)**, hereinafter referred to as Marshall. Marshall stated he was the only person on scene and he is the maintenance man and was doing dishes in the kitchen. We asked Marshall could he contact the license, **Reginald Butler (B/M 04/05/1958)**, hereinafter referred to as Butler. MARSHALL stated he was unable to reach Butler by phone.

#### Observations:

I observed multiple bottles of alcohol behind the bar and beer in the coolers below. I observed a black wire storage with multiple alcohol bottles locked away. I observed the majority of the liquor bottles behind the bar with pour caps on them. While checking the bottles, I observed some alcohol bottles with dead bugs contained inside with other unidentified things floating inside. The bottles that were contaminated were confiscated by DOR Agent KING.

We observed a slush machine with standing slush flavor inside. We asked Marshall when was the last time a new flavor was made and MARSHALL stated approximately every other day, so two days prior to the inspection. MARSHALL stated they pour liquor inside the machine and it freezes to make slush.

I observed 5 gambling machines along the west wall of the business.

In the rear of the location, I observed hookah stands with the hose attached. We located multiple hookah flavors which were confiscated by DOR AGENT KING. It was reveled Vibe lounge doesn't have a valid tobacco license.

On the rear wall behind the bar was multiple licenses. I checked the validity of the licenses and revealed the following:

### Arrival of BUTLER:

BUTLER arrived and stated he recently underwent cataract surgery and it was hard seeing. BUTLER stated he orders all the product for the bar and no one else is in control of that task. KING asked BUTLER for the invoices at which point BUTLER pulled out crumpled invoices which dated back to May 2021. BUTLER stated those were all the invoices he could find. KING asked BUTLER where was he buying his product and Butler stated "Badger." I know from my experience that Badger is located on 1812 W. State Street, in the City and County of Milwaukee and is titled, "Badger Distribution of Milwaukee LLC."

KING asked Butler when the last time he went to purchase product from Badger and BUTLER stated he went sporadically since July. King stated she called the owner of Badger and the owner stated BUTLER hasn't been to their distribution in months. BUTLER denied the claim and stated he has been recently.

Behind the bar was a Quest Card that had a receipt for products. BUTLER stated he used the card to purchase food for the bar. This card had a name on it of Maurice Lathan. The card number was 5077-0850-4093-9306. This card was confiscated by DOR agent KING.

In the dumpster outside of VIBE lounge were multiple Hennessey Boxes with the address of 10722 W. Hampton Avenue, not addressed to 2579 N. Teutonia Avenue. BUTLER asked where these boxes were located and was informed they came from his dumpster. Butler stated he had no knowledge how the boxes got there and doesn't go to other liquor stores to purchase alcohol.

The Department of Revenue agent KING confiscated all alcohol on the premises that did not have invoices, 35 hookah tobacco vape pens due to the location not having a tobacco license. This field report and DOR inventory report was placed on Milwaukee Police Department inventory #21045359

This concludes my report.

On Sunday, April 10th, 2022 at approximately 11:48 PM, squad 3465 (P.O. Joseph BINTER and I) were dispatched to 2579 N. Teutonia Avenue (Vibe Lounge), in the City and County of Milwaukee, WI for a tavern violation. While enroute to the dispatched location, P.O. BINTER spoke with the caller via cell phone.

The caller, identified only as "Shaniya", stated that she had just left Vibe Lounge. The caller stated that she observed several of her daughter's friends entering the establishment. The caller stated that the several subject appeared to be under age, but was not able to provide specific identifying information for the subjects. The caller stated that 2 of them were approximately 18 years of age, one was approximately 15 years of age, and 1 approximately 17 years old. The caller stated that she believed the subjects were entering through the use of fake ID cards.

Upon arrival, I spoke with one of the employees, identified as John T. GORE (b/m, 10-21-1989). GORE stated that he works the front door area as a security guard. GORE stated that no one under age the age of 21 is permitted to enter the establishment. GORE stated that everyone's age is verified with a state identification card. On Sunday, June 19, 2022, my partner (P.O. Lauren MAROWSKY) and I were conducting a Tavern Check at 2579 N. Teutonia Ave. (Vibe Lounge), which is located in the City and County of Milwaukee, in the State of Wisconsin.

While we were monitoring Vibe Lounge, we were parked in our marked Milwaukee Police Squad vehicle facing southbound on the 2600 hundred block, approximately 100 feet from the front entrance to Vibe Lounge. At approximately 2:04 am, as we were monitoring the bar, numerous patrons were exiting, when we observed a black male, later identified as Lashaun D. HUDSON (B/M 8-24-1982) walking towards the front entrance, with what appeared to be a concealed firearm in his right front pants pocket. As HUDSON was walking towards the bar, I observed a long black item coming from his right pants pocket, which I believed to be an extended magazine belonging to a firearm.

I observed and heard a unreasonably loud argument between HUDSON and a security guard to Vibe Lounge, who was identified as Wesley T. WALKER (B/M 1-3-1981). Due to my distance, I was unable to make out the exact words of the argument but heard WALKER say "you were being disrespectful," referring to HUDSON. HUDSON was within approximately 2 feet of WALKER while the argument was taking place and it seemed to be very animated between both HUDSON and WALKER. WALKER then started to raise one of his hands over his head, motioning us to come over. At the same time two unknown black females were walking past P.O. MAROWSKY and myself, when they stated "you need to get him, he has a gun," P.O. MAROWSKY asked the unknown black females if the black item hanging out of his pocket was an extended magazine and they confirmed it was.

As we approached HUDSON from behind, I observed 2 individuals run westbound on W. Clarke St., away from Vibe Lounge, while ducking their heads. Due to numerous citizens outside of Vibe Lounge at that time, not knowing how many more citizens were still inside, and fearing it will escalate into a shooting, P.O. MAROWSKY immediately took HUDSON into custody and placed him into handcuffs, while I retrieved the handgun with extended magazine from his front right pants pocket. The handgun was identified as a Black 9MM Canik TP9SF, Semi-Automatic handgun with a black extended magazine (Serial # 20AT30729). The Cankik TP9SF had 1 unfired brass Geco 9mm Luger cartridge chambered with 26 unfired brass GFL 9mm Luger cartridges, 1 unfired brass hollow point Hornady 9mm Luger cartridge, and 1 unfired brass hollow point SIG 9mm Luger cartridge in the magazine.

Before entering our Milwaukee Police Squad vehicle, HUDSON stated "I got another on me," referring to another firearm. P.O. MAROWSKY inquired about the firearm whereabouts and HUDSON stated "right here," while thrusting his pelvis forward and moving his head in a downward direction towards his

waistband.

A search incident to arrest took place by both P.O. MAROWSKY and myself, where P.O. MAROWSKY recovered a black Bersa SA Thunder 22 Semi-Automatic handgun with a black magazine (Brown handle and Black slide, Serial # B81634) from HUDSON's waistband. I located 1 unfired brass hollow point Win 9mm Luger cartridge, 1 unfired brass GFL 9mm Luger cartridge, 1 unfired brass PMC 7.62x39mm cartridge, 1 unfired brass 7.62x39 cartridge in HUDSON's right front pants pocket.

I spoke to WALKER regarding the incident. WALKER stated that at approximately 12:30 am on Sunday, June 19, 2022, HUDSON was escorted out of the bar by him. He stated that another security guard, observed him on stage by the DJ near the VIP section of the bar. The security guard kicked him off the stage and the two of them began to have a verbal argument. WALKER explained that due to another security guard with HUDSON, WALKER intervened and was the one to start escorting him out of the bar. While leaving HUDSON stated "I'm leaving mother fucker, I'll knock you the shit out." WALKER stated that he was inside the bar, when bar patrons notified him that HUDSON had returned with a gun. WALKER stated two other security guards handled that situation and made HUDSON leave the area. WALKER stated when HUDSON left, "some people," stated shots were fired. WALKER stated he didn't know if it was HUDSON or not. When I was trying to confirm what was said WALKER changed it to "he shot outside," and that was the reason he started to wave us down because he saw the gun in his hand and he shot outside. WALKER stated he did not hear the shots because he was in the bar. It should be noted that the Milwaukee Police Department received no shotspotter assignments or shots fired calls.

Approximately 1 hour later, WALKER stated HUDSON returned to Vibe Lounge and wanted to talk to him. According to WALKER, HUDSON wanted to know why he was kicked out earlier in the night and kept grabbing the handgun with the "extendo," referring to the handgun we recovered with the extended magazine. WALKER stated HUDSON grabbed it from his right front pants pocket and told him to take it, which is when he started to wave us over. WALKER stated HUDSON never threaten him with the gun but was scared because he did not know what he was going to do with it.

WALKER kept repeating that HUDSON pulled a gun out and tried to hand it to him. He stated that he was aggressive while talking but wasn't "threatening shit," but kept his hand on the gun. WALKER stated that if he was carrying a gun he would of "bop bop," because he was scared.

I asked WALKER if I could speak with the other security guards about the incident but when he attempted to locate them, they were no longer on scene. During my investigation, WALKER multiple times stated someone was filming him and asked if we can move her away. When I asked if he wanted to go inside Vibe Lounge to speak with us he kept refusing and stood outside. After I debriefed with my supervisor for approximately 10 minutes, I attempted to gain entry into Vibe Lounge to see if they have video surveillance, however it was all dark inside and locked up. I knocked on the door multiple times and no one let me in.

This report is submitted by P.O. Adam GONZALEZ, assigned to District Three, late shift.

On Saturday, July 2, 2022, my partner (P.O. Juan OROZCO) and I conducted a Tavern check at Vibe Lounge, which is located at 2579 N. Teutonia Ave.

Upon arrival, I observed approximately 100 vehicles in the immediate area of Vibe Lounge. Numerous vehicles were parked on N. Teutonia Ave in both the 2500 and 2600 block, as well as 1300 block on W. Clark St. I also observed several vehicles parked in a grass vacant lot on the northeast corner of the intersection of N. Teutonia Ave. and W. Clarke St.

Once inside, I requested to see the clicker to the business, which had a count of 181 patrons inside. It should be noted that Vibe Lounge's capacity is set at 160 patrons, which includes employees. I made contact with Dominique JONES (b/f 6-25-1985) who identified herself as the manager. I asked if JONES to see where she keeps her alcohol and she escorted me to a metal cage, which had numerous different types of liquor. JONES then showed me receipts from Badger Distributing of Milwaukee, located at 1812 W. State St. JONES stated all the alcohol they purchase for the night comes from Badger Distributing.

While looking at the receipts Kevin L. JONES (b/m 11-11-1972) approached me upset because he believed we were targeting his business. JONES identified himself as the owner to Vibe Lounge and questioned why we were asking to see proof of where the alcohol was purchased and believed we were going to confiscate it. I told JONES, I was satisfied with everything that was shown to me regarding the purchases of alcohol and that I would not be confiscating it. I assured him, I can not legally take the alcohol even if I determined a violation had occurred because that is the job of the ATF. I advised JONES we were only there to make sure things were operating correctly so Vibe Lounge can succeed without any problems. I did asked JONES why the clicker said 181 patrons were inside, but JONES stated that he keeps it running for anyone who has entered throughout the night and that it does not take into account people that have left the establishment. While conducting my investigation, I observed at least 20 individuals in the first room, with approximately 5 employees and at least 100 individuals in the back room. Their was numerous amount of space to walk around the establishment and I did not feel like it
