This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- On 09/22/2020 officers conducted a Safety and Security meeting at The Hampton Inn, 1200 W. College Av. The applicant stated the door lock at 11:00pm and you need a key to enter. The property does not have exterior security cameras but did update the parking lot lighting. The hotel does not have on sight security but does have a roving patrol. The applicant stated he has noticed an increase in loitering since the start of the quarantine. The applicant was given the district phone numbers and advised to call with any issues.
- 2. On 01/01/21 at 1:46pm, Milwaukee Police were flagged down for an auto theft at 1200 W. College Avenue. Investigation revealed that the victim, who was a guest of the hotel, gave his vehicle keys to his mother-in-law and she took the vehicle without his consent. A report was filed.
- 3. On 01/01/21 at 10:53pm, Milwaukee Police were dispatched to 1200 W. College Avenue for a trouble with subject complaint. Investigation revealed that a subject was in a room and was not a registered guest. The male was conveyed to a hospital and no violations were made by the business.

- 4. On 01/06/21 at 6:22pm, Milwaukee Police were dispatched to 1200 W. College Avenue for a property pick-up. Upon arrival, officers interviewed the manager who stated that a subject had property inside a room but had a balance due regarding his stay. Prostinak stated that he uses the name Nick for security reason and that he stays at the hotel several nights each month. Prostinak further stated that on Wednesday morning, 11-24-2021, at approximately 6:30-7:00 a m, 11-24-2021, while he was out of his room, # 334, the night audit person for the hotel, entered his room without permission.

Prostinak stated that he does Marketing work and stays at the hotel several times per month. While at the hotel he became friendly with the night audit girl, who is also staying at the hotel because the person she lives with (boyfriend) has Covid. She is identified as Stewart-Funk, Shayna Marie, w/f, 06-20-92, 3925 W Iowa Terrace, Greenfield, WI. 414-550-6556, who is staying in room # 330, Hampton Inn.

As it turns out Prostinak and Stewart-Funk had some kind of relationship break down and Prostinak did not want her in his room at all.

Upon follow up with Stewart-Funk, we knocked on room # 330 and found that she was in her room with another male, identified as Kasian, Dylan Rey, w/m, 06-23-92, 12450 W Ohio Drive, New Berlin, WI., works at Wendys, West Milwaukee WI.

Stewart-Funk stated that she gave her key fob to Kasian in order for him to enter into room, # 334. When asked why? She said that he dropped his key card when walking in the hall and it slid under the door of room # 334. So Kasian used her key fob to open the room door and get the key card that slid under the door.

Further investigation revealed that nothing was missing from room # 334 and Prostinak just wanted a report of this incident taking place.

All parties involved have some type of relationship. There is no possible way a key card would slide under a room door. The floor seal to door / floor is much to tight and the key would need to be forced under.

It should also be noted that Prostinak was asked not to return, once his stay was up on 11-25-2021.

On Monday, May 23, 2022, at 6:02AM, Squad 6350 (myself in full duty uniform, equipped with BWC, and operating a marked MPD squad #607) was dispatched to a Theft of Vehicle complaint at 1200 W. College Avenue (Hampton Inn Hotel), in the City and County of Milwaukee, Wisconsin.

Upon arrival, I spoke with the caller, Michael C. LYPEN (W/M, 07-08-89), who advised me that he had rented the vehicle that was taken from Thrifty/Hertz Car Rental out of Chicago O'Hare Airport.
