When the officer arrived they could hear loud music coming from inside. The officers were able to enter the business and observed a bar with liquor bottles on a shelf. The officers asked to see the owner and a subject came up stating he rented the hall for the night. When the officer located the business license on the wall, he was approached by the applicant. The applicant stated he opened the location as a Soul Food catering business but has been renting out the hall due to financial hardship. The applicant
- 2. On 03/16/2022 at 7:45pm officers conducted a license premise check at 837 W. Historic Mitchell St. The officers spoke with a female who stated she rented the hall for her birthday party the following night. She stated she emailed a subject named Lamount to rent the hall and was advised she could use the kitchen and bring in her own alcohol. She stated she had to provide a deposit to Lamount in case anyone drank alcohol in the bar. The officer did not observe any licensed posted but was able to locate the food license behind the bar.

3. On 03/19/2022 at 7:59pm officers conducted a license premise check at 837 W. Historic Mitchell St. The business was closed but there were people inside. The officers made contact with the people inside and spoke with a subject who stated they were there cleaning up from her birthday party on 03/18/2022. She stated she rented the hall for \$3,500 but was refunded \$1,500 for not using any of the alcohol that was provided by the establishment. The officer observed several bottles of alcohol and tobacco hookahs inside the bar. They observed a food license posted above the bar.

On January 29th, 2022, at 03:34 am, Squad 2351, PO Jordan YOUNG and I, responded to 837 W. Mitchell St., for a noise nuisance complaint.

While enroute to the location I contacted the complainant who stated she wished to be anonymous but stated she wished to complain on the business located downstairs from her apartment which is a food catering establishment but its known to have "after set parties" on the weekend that usually end around 5 am.

Upon arrival I could hear loud music being played while I was still in my squad car. As I exited the vehicle I approached the location and observed a sign on the wall that read "Milwaukee Unified Soul Food".

I approached the door which was locked but moments later an unknown male approached the door and opened it. As I entered the business I observed approximately 20-30 people inside the business.

I observed a bar in the corner of the room with what appeared to have approximately 20 open liquor bottles on the shelf, and 10 unopened liquor bottles in a fridge under the bar. There was also a cash register with a bowl that read "tip jar".

On the shelves by the bar was approximately 5 unopened/opened boxes of swisher cigars and approximately 20 lighters which appeared to be for purchase.

As people began to leave the location I spoke to ROBINSON, Traveon D. (B/M DOB 04-08-1984), who stated he was having his birthday party at listed location. He further stated he rented "the hall" just for the night.

I asked him who he rented it from but he refused to say. I made multiple attempts to locate an owner/manager of the location but was unsuccessful at the time.

I observed the listed location to have a kitchen which was being operated at the time by (2) unknown males.

When I located the License Permit I was approached by HOWARD, Andre D. (B/M DOB 02-04-1977), who stated his wife owns the business. Be advised HOWARD was in the vicinity and heard myself asking the whereabouts of the owner when I first entered the establishment.

HOWARD began to say him and his wife opened the location as soul food catering business but was "losing the location" due to financial hardships.

HOWARD stated he opens the place up as hall so he can make money on the side but claimed he doesn't sell liquor.

I located the Business License on the wall which identified the location as a "Food Dealer Restaurant". It further identified HOWARD as the business agent. The hours listed on the permit read 12:00 pm - 9:00 pm, for both Fridays and Saturdays.

The effective date for his license is 06/16/2021 and expires on 06/15/2022.

This completes my report.

On Friday, March 19th, 2022 at 7:59 PM we conducted a tavern check at 837 W. Mitchell St, Milwaukee Unified Soul LLC. Both Officers were equipped with Axon Flex body worn cameras.

On arrival the business was closed but there were people inside of the establishment. We made contact with someone inside, identified as Laynicke F. GRANT (B/F, 02-05-1984), who stated she was cleaning up from a party she had hosted on 3-17-22 at the location. GRANT was previously on scene at a tavern check we conducted on 3-16-22 at the same location filed under MPD IR#22-075-0170. GRANT originally stated that she was charged \$10,000 to rent the venue for her private event.

GRANT stated that she had originally booked the venue on a phone application. GRANT stated that she was charged \$3,500 to rent the venue, and refunded \$1,500 for not using any of the alcohol that the venue was willing to provide for that price. GRANT stated that she had emailed the point of contact for the venue that we had conducted a tavern check previously, but that she had not gotten a reply. GRANT stated that they provided the food for the event and their own alcohol.

The only license visible inside of the premise was the food dealer license posted above the bar, and no capacity sign is posted within the building. Several bottles of alcohol and tobacco hookahs were still inside of the location. A check of City of Milwaukee Licenses revealed the only license listed for Milwaukee Unified Soul LLC. is a food dealer license stating the location would be acting as a restaurant.

The licensee, identified off the license as Andrell D. HOWARD (B/M, 02-04-1977), was not on scene, and I was unable to reach him by the phone number provided.



Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
