I am at a disadvantage with respect to Employment because I have experienced a pattern of underemployment as my pay has been below the median income. I've also experienced non-achievement regarding getting promotions for the past positions that I have held.

Enclosed is a spread sheet (Document 1-titled CAA Earnings 1973-2019) that I have prepared using my Social Security Earnings record. This shows my total years of employment from 1973 through 2019.
