The CITY hereby quit claims and conveys to Grantee, on an AS IS, WHERE IS basis, the following described facilities (the "Facilities") subject to all defects, known or unknown, discovered or to be discovered, and without any warranty or representation express or implied:

There are 18-inch, 15x22-inch and 30-inch diameter public main combined sewers and appurtenances (Facilities) located in Parcels 1 and 2 of Certified Survey Map (CSM) No. 2944, a recorded CSM in the Southeast one quarter (S.E. ¼) of Section 10, Township 7 North, Range 22 East, in the City of Milwaukee, County of Milwaukee, State of Wisconsin, more particularly described as follows:

Beginning at a combined sewer manhole located 210 +/- feet north of the northerly line of East Hartford Avenue and 194 +/- feet west of the southeast corner of parcel 1 of said CSM, Said manhole to be included in this conveyance;

Thence, south 100+/- feet to the center of a second combined sewer manhole;

Thence, south 100+/- feet to the center of a third combined sewer manhole;

Thence, south easterly 50 -feet along center line of combined sewer to a combined manhole located in East Hartford Avenue, said manhole not included in this conveyance and also being the end of this conveyance.
