This report is authored by P.O. Thomas BURMEISTER, assigned to District 7, Early Shift.

On Sunday, December 19, 2021, at approximately 6:42 PM, P.O. Michael BUDZISZEWSKI and I, Squad 7240, were dispatched to the address of 8210, located in the City and County of Milwaukee, for an Overdose complaint.

Upon arrival to the address of 8210 W Capitol Dr, P.O. BUDZISKEWSKI and I met with Sgt. Trent LITTLE, Squad 7212, and Milwaukee Fire Department Engine 22. In addition, P.O. BUDZISZEWSKI and I made contact with Jack W WERNER (W/M 5-23-1977). WERNER had fallen face first out side of the business of 8210 W Capitol Dr. Personnel from Engine 22 found WERNER unresponsive upon their arrival, and administered Narcan.

P.O. BUDZISZEWSKI and I spoke with WERNER continuously stated he did not know how he got to the gas station, does not remember taking any substances, or seem to have any recollection of recent events. WERNER also refused medical multiple times, as both police officers and firefighters stated the importance to WERNER that he receive medical attention.

WERNER contacted his mother, Karen J WERNER (W/F 6-12-1955), who arrived on scene and picked WERNER up in an older 4 door vehicle bearing WI auto plate ABJ1640.

I spoke to a few employees inside the gas station, who all stated they are unsure of how WERNER got to the location. One of the employees I spoke to was Satwinder SINGH (A/M 4-01-1966).
