Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, lilegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

As incidents occur please make sure to dial emergencies into 911 and non-emergencies into 933-4444.

Regarding King Rainbow Foods, I would also suggest that you make sure that the Licenses Division is aware of the concerns at the establishment (I have copied them on this email too). It is likely that they are licensed through the City of Milwaukee and will be subject to renewal.

Please let me know of any additional questions, we will gladly work with our partners at MPD District 3 to try and address the root causes of the problems in the area.

Alderman Stamper,

Residents of and in the

re extremely disheartened by the recent and increasing violence in our neighborhoods community. Alderman Stamper, can you address the following?

The gun violence in various neighborhoods in the Lindsay Heights community:

- 1) the killing of a transgender person in a vacant building locate in the 2300 block on Tuetonia
- 2) the killing of the young woman on 17th and wright
- 3) the shooting on 15th and North avenue in the 2300 block
- 4) the shooting at the SDC building
- 5) the random shootings that occur in neighborhoods in Lindsay Heights

The violence and general mayhem have created neighborhoods that are unsafe for homeowners, taxpayers, and voters:

- 1) the stabbing incident which took place at Kings Rainbow Foods
- 2) Individuals double park in the middle of the street; blocking traffic

- 3) open drug selling on many of the streets in Lindsay Heights including the following areas: 17th and Miencekee, 14th and North avenue, 2100 block on 12th near the Liquor store, 2600 on 19th, and 16th and Locust
- 4) Open prostitution on north specificlly at 14th North and at 1801 W. North

Sunshine Park-is called a park, but it lacks the funding. The Sunshine Park space has turned into a cesspool. In Carver Park and in Johnson Park residents use the parks daily, and the parks are cleaned regularly.

The mayhem created in Sunshine Park has affected the quality of life of residents living on 14th and 15th street. And, in Lindsay Heights in general:

- 1) human waste in Sunshine Park
- 2) rats feed on the garbage
- 3) families of raccoons feed on the garbage
- 4) sexual intercourse occurs in the Sunshine Park. Residents have found condoms
- 5) open drug use occurs in Sunshine Park
- 6) in general, no homeowner, taxpayer, and voter that I know uses Sunshine Park

The mayhem created by King Rainbow Foods:

- 1) open drug selling occurs in front of the store, in the parking lot, and in cars parked in front of the store
- 2) illegal dumping of cooking oil on a city vacant lot
- 3) sidewalks are blocked by drug sellers and drug users soliciting
- 4) why is King Rainbow Foods open at 5am. The hours are not in line with the needs of the residents

The mayhem created by the vacant AutoZone store:

- 1) open drug selling and drug use in the lot
- 2) the condition of the lot which contains trash, human waste, and condoms

Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
