This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/21/07 at 3:00 pm, Milwaukee police were dispatched to 4302 W Capitol Drive for a Shooting complaint. Investigation found a patron was pumping gas when he was approached by three actors who shot the victim once to the stomach. The actors fled the scene. The victim died as the result of his injuries. Employees of the gas station were cooperative during the investigation.
2. On 08/11/07 at 3:33 pm, Milwaukee police were dispatched to 4302 W Capitol Drive for Trouble With Subjects complaint. Officers spoke to the cashier, Shamsheer Singh, who stated a subject was panhandling on the gas station lot since 1:30 pm and was refusing to leave. Officers located the subject and found he had an outstanding warrant. The subject was also issued several citations.

3. On 06/16/08 at 10:23 pm, Milwaukee police were dispatched to 4302 W Capitol Drive for a Fight complaint. Officers located a 16 year-old male juvenile being held inside the station by two adult males who were the owners of the business. The owners were identified as Harvinder Singh and Lakhbir Singh. One of the owners and well as the juvenile was observed to be bleeding from head. Investigation revealed the juvenile had been at the gas station earlier in the day and had some sort of a disagreement with one of the owners with the juvenile breaking out the glass from the entrance door to the gas station. The juvenile fled after committing the property damage. Police were called and did respond to that incident. At approximately 10:20 PM the juvenile returned to the gas station and walked around inside as if he were shopping. The two owners, Harvinder SEHRA and Lakhbir SINGH, observed the juvenile and attempted to detain him for police. A violent struggle ensued as they tried to keep the juvenile inside the store. Harvinder SEHRA had armed himself with a box cutter. During this struggle, the juvenile received lacerations from the box cutter. The juvenile was forced into an office where he was held against his will until police arrived. A check of CCAP revealed no charges were issued to any of the owners or the juvenile.

4. On 08/28/08 at 4:58 am, Milwaukee police were dispatched to 4302 W Capitol Drive for a Trouble With Subject complaint. Investigation found a patron was in an argument with the gas station attendant, identified as Harvinder Sehra, when Sehra accused the patron of stealing a soda. Sehra came from behind the counter and pepper sprayed the patron. A check of the stores video surveillance found that the patron entered the station with a soda in his hand. Sehra was issued a citation for Assault & Battery. The video did not show Sehra pepper spraying the patron but Sehra did admit to using pepper spray because he feared for his safety. A check with Municipal Court was done to locate the citation, but it could not be found.

5. On 10/01/2016 a 17 year old, working in conjunction with Milwaukee police, was able to purchase a pack of Swisher Sweet cigars from the cashier at 4302 West Capitol Drive (Capitol Citgo). The applicant was advised that a M.A.R.T.S. enrollment letter would be sent.

6. On 10/01/16, Milwaukee police were working the WINS Tobacco Initiative and had an underage student enter 4302 W Capitol in attempts to purchase tobacco products. The student was able to purchase a pack of Swisher Sweets without being asked for ID from the clerk who was identified as Jarnair Singh. A letter was mailed to the agent to enroll in the MARTS program. The agent did enroll, however, failed the Mystery Shopper inspections on December 22, 2016, January 20th, 2017, and February 22nd, 2017. A citation for the initial violation was mailed to Lakhbir Singh.

7. On 04/23/17 at 5:00 pm, Milwaukee police observed an auto parked at one of the gas pumps at Citco Gas located at 4302 W Capitol Drive with a plate that did not list to the auto. Police conducted a field interview in which the driver attempted to flee police. Investigation revealed a passenger was in possession of an AK47 pistol while sitting in the passenger seat (later determined he was a convicted felon), who also tried to flee as well. Both subjects were placed into custody and upon searching them; officers recovered 8.97 grams of marijuana from a pocket of the driver. Officers spoke with a clerk at the station and were able to obtain video surveillance of the incident.

8. On 09/18/21 at 11:09pm, Milwaukee Police were dispatched to 4302 W. Capitol Dr. for an armed robbery complaint. Officers observed video of the incident that took place within the gas station. The victim was robbed at gunpoint at the front counter of the gas station. The suspect removed the victim's gun from his waistband and fled the area on foot. The video showed the victim loitering around the business prior to the occurrence of the incident. The employees of the gas station did not call police even though the incident took place in front of the counter where two employees were standing.
9. On 10/28/21 at 7:05pm, Milwaukee Police Officers of District #7 took a walk in robbery complaint, which occurred at 4302 W. Capitol Dr. The victim stated that she was in her vehicle near the air pump of the gas station with her purse on her lap. An unknown suspect approached her driver side window and demanded her purse. The victim feared for her safety and gave the suspect her purse. The suspect then fled the area on foot.

10. On 02/08/22, officers were dispatched to 4302 W. Capitol Dr., for a Welfare of Citizen. On arrival a wanted check was conducted and the subject was taken into custody.
 11. On 02/11/22, officers were dispatched to 4302 W. Capitol Dr., for a Strong Arm Robbery. Investigation revealed a citizen was in the gas station paying for items, when a suspect came from behind and forcefully removed a firearm from the citizen's waistband. Employees were cooperative and provided video surveillance of the incident.
 12. On 05/25/22, officers were dispatched to 4302 W. Capitol Dr., for a Shots Fired. The caller stated they heard two shots coming from the area. Employees were cooperative and provided video surveillance, however, did not contact police regarding the incident.
 13. On 07/26/22, officers were dispatched to 4302 W. Capitol Dr., for a Shots Fired. Investigation revealed a shooting had occurred, while the victim was pumping gas at the pump. The employees did not call the police, however, were cooperative and allowed officers to view video surveillance of the incident.
 14. On 08/22/22, officers had a meeting with the agent who agreed to submit an abatement plan regarding several violent incidents at the location.

On Tuesday, July 26, 2022 at 10:17am while assigned to Squad 7120, P.O. Adam LUEBBE and I, were dispatched to a Shots Fired Investigation along with Squad 7141, P.O. Ryan HUCK, in the area of N Sherman Bl and W Capitol Dr.

During the investigation P.O. LUEBBE located 4 bullet casings and 2 bullet fragments in the parking lot of 4302 W Capitol Dr. This location is a Citgo Gas Station (Sehra Sons LLC). While at the location we were informed by Dispatch that a Shooting victim had arrived at Froedtert Hospital. The victim stated he was shot while pumping gas at the gas station after exchanging words with another vehicle at the gas pumps.

P.O. LUEBBE spoke with Lakhbir SINGH (w/m, 04-13-61) who arrived at the location after police arrival. SINGH allowed P.O. LUEBBE to watch the video and video evidence was recovered from the location.

This shooting occurred in the parking lot of the business and no part of this incident occurred inside of the business. No calls regarding the shots fired was called in by anyone from the business.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.


