Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This bar operates and advertised themselves as a Strip club on social media.

Neighbors have repeatedly complained and provided videos of bad behavior stemming from overserved clients and intoxicated clients.

One video shows a man shooting a gun in the air.

Another video shows a man defecating on a tree.

A third video shows a man wandering into her yard and neighbors telling him to leave.

Other videos show things like fireworks going off across the street and people yelling and playing loud music outside her house.

Neighbors complained to the city and police for years, but have not see any changes.

Additionally, The news has reported on this and that did not promote changes at the business.

This is clearly a nuisance business and does not belong in our neighborhood. I encourage the city to revoke the licence and shut down this nuisance business. The owner has failed to address concerns and be a productive member of this community.





On Wednesday, November 3, 2021 at approximately 9:51 PM, while assigned to Squad 7468, PO Adam RUSCH and I responded to the address of 4750 N Hopkins St regarding an Overdose complaint.

which occurred at approximately 9:45p.m.

Upon arrival we observed the injured/sick person, later identified as, Robert DOUGLAS (B/M 05/22/1964) laying on the ground near the stage area. DOUGLAS's eyes were rolled into the back of his head and there was no movement from his chest indicating he was not breathing. The Milwaukee Fire Department arrived on scene and immediately began life saving measures. MFD used two milligrams of Narcan putting one milligram into each nostril. After multiple chest compressions and the issuance on Narcan, DOUGLAS became stable and began moving around. MFD asked DOUGLAS multiple questions to confirm his comprehension, which DOUGLAS answered. DOUGLAS refused to go to the hospital or any further medical treatment and was released from the scene.

WILLIAMS (B/F 11/22/1985), stated she was bartending this evening and observed DOUGLAS on the ground. WILLIAMS stated she did not observe DOUGLAS use/take anything.

The owner of Gold Diggers, Michael RAY (B/M 04/27/1978, was on scene and cooperative. RAY stated he was standing near the east side of the bar area when he heard a loud thud. RAY stated he then observed DOUGLAS on the ground. RAY stated he did not observe DOUGLAS use/take anything that would have affected his demeanor. RAY further stated DOUGLAS did not have any alcoholic beverages prior.

On Tuesday, September 13, 2022 at 9:55 p.m., Squad 7469, consisting of myself, was dispatched to 4750 N. Hopkins St. to investigate a shot spotter complaint, which stated three rounds at the location, with a FLEX Number 81-861517.

While on scene, I was approached by Justin Shirley (b/m, 02-16-88), who stated a security guard had been robbed at 4750 N. Hopkins St. by three black male individuals. Shirley stated the three suspects ran and got into a purple BMW SUV with a possible plate of ATV3015. Shirley stated the BMW SUV fled southbound on N. 37 St. in the 4700 block until they approached N. Hopkins St. and one of the occupants of the BMW SUV began discharging a firearm. Shirley stated he as well as three other individuals were standing in the parking lot of 4744 N. Hopkins St. when this occurred. Shirley stated he noticed the Ultimate Auto Shop had been struck three times by gunfire. Twice to the service door, and once above the service door. From where Shirley was standing, he was in direct line of fire from where the shots were being fired from.

l spoke to Michael Ray (b/m, 04-27-78), who stated he was also standing in the parking lot of 4744 N. Hopkins St., when this incident occurred. Ray stated he could not tell who was shooting, but knew the shots were coming from the purple BMW SUV. Ray stated this all stemmed from his security guard getting robbed near the front of the business. Ray is the owner of "**Gold Digger's**", a strip club located at **4750 N. Hopkins St.** Ray was cooperative with the investigation, and allowed me to see surveillance video. However, the cameras do not capture the incident, it only captures when the purple BMW SUV arrives, parked at approximately 4755 N. 37 St., which is the rear of 4750 N. Hopkins St. and approach the front of the business. A short time later, three unknown suspects are seen running back to the BMW SUV, scrambling to get inside of it. As the SUV is trying to flee, it strikes one of the suspects, causing him to drop a cell phone in the street. Camera 9 was the only camera that captured this portion of the incident. The times were 9:31:43 p.m. to 9:32:10 p.m.

I went into the street and located the cell phone. The security guard, who did not give me his name, stated the phone in the street was his, and that he merely lost it. The security guard stated nothing had occurred and he was not robbed of anything. The security guard of "Gold Digger's", a strip club located at 4750 N. Hopkins St. was less than cooperative in this investigation.

The Owner, Michael Ray was cooperative.

The security guard, refused to admit that he had been robbed and was not cooperative during our investigation.
