I received E-Notify for this violation on Nov 30, 2022 at 1:53 Am, and I highly aware it and took action right away at Nov 30, 2022 at 5:31 Am, I contacted tenant to clean up the litter and debris, they cleaned up it right away to prevent get the fine. I received paper letter notice few days after, it stated it posted on 11/29/2022. But the clean up order from city was back to 11/29/2022 12:00 Am, it's not after 24 hours notice posted.
