The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/03/2014 Officers conducted underage tavern enforcement. At 11:13pm an underage Police Aid gained access to Pourman's at 1127 N. Water St. through the front door. The Police Aid then ordered, paid for and obtained a Miller Lite from the bartender without being asked for ID to verify her age.

2. On 07/27/2014 at 1:50am officers conducted a tavern check at Pourman's, 1127 N. Water St. The officer asked the employee at the door stated there were about 60-65 patron in the bar but did not have a counting device. The officer conducted a count of patrons and upon reaching 100 called for a supervisor. The supervisors responded and closed the bar by controlling the exits. The patrons were videotaped and counted as they left. The total was 119 patrons. The business has a total capacity of 79.

- 3. On 08/19/2014 the applicant had a meeting with Asst. City Attorney Nick DeSiato, Sgt. RADEN, and Capt. THIELE. The applicant stated he has added more security on Saturday nights and they would have a clicker for counting people as they entered. He has roped off an area in front of the bar in order to keep an orderly line and separate the people waiting to get in the bar from people loitering on the sidewalk. The applicant stated he will also look into more cameras. The applicant was advised to contact Code RED officers if he was having issues he could not control with his personnel. ACA DeSiato went over concerns regarding the overcapacity issue and stated his recommendation for the citation to be reduced.
- 4. On 02/03/2015 Milwaukee police responded to a battery complaint at 1127 North Water Street (Pourman's tavern). Investigation revealed a subject, that appeared intoxicated when he entered the business, was asked to leave. This patron refused and was ultimately escorted out of the establishment by the applicant and another patron. During this incident, the intoxicated patron fell to the ground injuring his shoulder. This patron was cited for disorderly conduct and trespassing.

- 5. On 08/07/2015 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, was able to enter Pourmans tavern (1127 North Water Street) unchallenged. Once inside, the police aide was able to purchase a Corona beer from the bartender.
- 6. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Pourman's, 1127 N. Water St. The Police Aid was able to enter because there was no security at the door. The Police aid order and was served \$10.00 worth of alcoholic beverages from the bar.

7. On 11/29/2018 officers conducted underage tavern enforcement in District 1 at Pourman's, 1127 N. Water St. The bar passed the check.

8. On 10/06/2019 at 2:02am officers were flagged down for a fight at Pourman's, 1127 N. Water St. The officers observed several people leaving the area but no one would speak with the

officers. The officers spoke with the manager of Pourman's, who stated there was a fight on the patio by the DJ booth. He stated security was able to break up the fight and get everyone out of the tavern. The manager was cooperative with the officers and stated the officers could check back later in the week to see if there was video of the fight.

9. On 07/23/2020 at 11:30pm an officer observed the front door to Pouman's, 1127 N. Water St., propped open. The officer stated the open door caused the music to be very loud outside. the officer advised security the door must be closed at 10pm. The applicant approached officers to ask why the door should be closed. The applicant was also advised the door needed to be closed at 10pm. About 20 minutes later the applicant approached the officers and asked if the rule was new because other bars in the area had their doors open. The applicant was advised it was a city ordinance that required the doors be closed at 10pm. The officer then provided a copy of the ordinance to the applicant.

10. On 03/01/21 at 8:13am, Milwaukee Police conducted a license premise check at 1127 N. Water Street. No violations were observed.

- 11. On 02/04/22 at 12:04am, Milwaukee Police were dispatched to 1127 N. Water Street for a trouble with subject compliant. Upon arrival officers observed the subject in the doorway of the tavern threating staff and refused to leave the location when asked by police. The subject was arrest and issued citations. Security and staff showed restraint and were very professional.
- 12. On 07/30/22 at 7:45pm, Milwaukee Police conducted a license premise check at 1127 N. Water Street. No violations were found. The manager was helpful with providing the information requested by officers.
- 13. On 08/14/22 at 1:08am, there was a large fight inside the tavern at 1127 N. Water Street. Several squads responded to the fight and were able to separate all parties involved. While security was pushing the parties outside, an unknown subject dropped a firearm on the sidewalk. All parties involved left the location and the firearm was inventoried. Per the tavern's license, security are supposed to wand those seeking entry with metal detectors.
- 14. On 09/30/22 at 12:29am, Milwaukee Police were dispatched to 1127 N. Water Street for a fire compliant. Investigation revealed that a patron knocked over a hookah pipe and it started a couple of rags on fire. 911 was called and the patrons were evacuated from the tavern. Employees tried to extinguish the fire but were unable to. The Milwaukee Fire Department arrived and put out the fire. It was estimated to be \$7000 worth of damage.
- 15. On 10/17/22 at 12:23am, Milwaukee Police responded to 1127 N. Water Street for a battery compliant. Investigation revealed that a patron, who was refusing to leave the tavern, battered the manager and security supervisor. Employees did everything they could to handle the situation in a professional manner and were cooperative during the investigation. The patron was issued citations.

On Friday February 4th, 2022 at 12:04 am, I was working with PO Robert WATTS 018677 on Squad 1431 when we were dispatched to Pourman's Bar located at 1127 N Water St. We were notified that Quentin T. WILLIAMS (B/M 09-12-96), was back at the bar causing a disturbance. WILLIAMS was there the previous night and was removed for his behavior and level of intoxication. He was threatening to staff, went back to the front and attempted to throw a planter through the windows.

When we arrived WILLIAMS was standing in the doorway threatening security staff again, he had his phone out stating he was waiting for the owner, and a lawyer because he was going to sue the bar. PO MICHALAK 019738 and PO Kevin ZAVADIL 026360 (Squad 1420), arrived to our location and also attempted to get WILLIAMS to leave the area. WILLIAMS refused and was subsequently arrested and issued citations for disorderly conduct and resisting arrest.

Pourman's Security and staff showed restraint and were very professional dealing with WILLIAMS.

On Sunday, 08/14/22 at 1:08am, there was a fight inside the tavern at 1127 N Water St (Pourman's). Several squads responded to the fight and were able to separate all the parties involved. The fight originated inside the tavern near the front door and involved several subjects. During the fight the security for the tavern were able to push the parties involved out front door and onto the sidewalk. During this time, one of the subjects involved in the fight dropped a firearm onto the sidewalk in front of the door to the tavern. Squads on scene observed the firearm fall to the ground but were not sure who dropped it. All the parties involved left the location before the owner could be located. PO's Roy CAUL and Hunter TUSCHL (Squad 4470) recovered the firearm and inventoried it for safekeeping.

Per the tavern's license, security at the tavern are supposed to wand those seeking entry with metal detectors before entry into the tavern.

I was able to speak with the manager on duty, Keenan SUMLIN, and advised him that a tavern report would be filed regarding this incident.

This report is typed by P.O. Shahriar SOLATI, assigned to District One, Late Shift, Squad 1341.

On Friday, 9-30-22, at 12:29am, I was dispatched to a Fire complaint at 1127 N. Water St. (Pourman's), in the City and County of Milwaukee.

Upon arrival, I spoke with Battalion Chief POLLACK (#1) who stated that they were called to a structure fire at 1127 N. Water St. on 9-30-22, at approximately 12:15am. POLLACK stated that the fire originated in the back closet area, west side of the building, first floor. POLLACK stated that the fire did not even meet the criteria of a 1 alarm. POLLACK stated that the damages were \$7,500 for the structure and \$0 for the contents. POLLACK stated that the fire was not suspicious in nature.

I then spoke with the General Manager, Kamisha C. MCNEALEY (B/F, 2-21-91), who stated that she was behind the bar, on 9-30-22, at approximately 12:15am, when she was alerted that an unknown bar patron had accidentally knocked over a hookah pipe and it started a couple of rags on fire. MCNEALEY stated that she then called 911 and coordinated the exit of all bar patrons.

I then spoke with the head of security, Keenan L. SUMLIN (B/M, 1-19-89), who stated that on 9-30-22, at approximately 12:15am, he was at the front of the bar (east side entrance) when he heard the DJ make an announcement about a fire in the back. SUMLIN stated that he looked back towards the back of the bar and saw smoke. SUMLIN stated that he then ran to the back of the bar and observed flames near the corner closet area. SUMLIN stated that he then helped to coordinate bar patrons exit the establishment.

I then spoke with security officer Seth T. COCROFT (B/M, 8-4-86) who stated that on 9-30-22, at approximately 12:15am, he was at the front of the bar (east side) when observed smoke in the back of the bar. COCROFT stated that he then stood in the front doorway as to not let any other individuals into the bar. COCROFT stated that when he was alerted that there was an actual fire in the back, he then The second s

I then spoke with security officer Christopher L. BURRELL (B/M, 5-9-78) who stated that on 9-30-22, at approximately 12:15am, he was in the back of the bar (west side), by the DJ booth, when he saw smoke coming from the closet area near the DJ booth. BURRELL stated that he went down in the basement to try and see where the smoke was originating from. BURRELL stated that he back upstairs and grabbed a fire extinguisher and began to spray it at where he believed the smoke to be emanating from. BURRELL stated that he began to see flames and that the fire extinguisher was having no affect. BURRELL stated that he believed that an ember from one of the bar huka pipes had fallen off and had gotten beneath the floor boards.

I then spoke with bar manager, Alexis A. MAGAW (W/F, 2-6-98) who stated that on 9-30-22, at approximately 12:15am, she was behind the bar when she heard the DJ make an announcement that they needed water in the back for a fire. MAGAW stated that she then looked towards the back of the bar and observed smoke. MAGAW stated that she then began to fill buckets of water with ice and take them to the back and give them to security officer BURRELL in attempts to combat the fire.

I then spoke with bartender Earnest R. ZAZUETA (H/M, 11-2-94) who stated that on 9-30-22, at approximately 12:15am, he was behind the bar when she heard the DJ make an announcement that they needed water in the back for a fire. ZAZUETA stated that she then looked towards the back of the bar and observed smoke. ZAZUETA stated that she then began to fill buckets of water with ice and take them to the back and give them to security officer BURRELL in attempts to combat the fire.

I then spoke with bartender Carrie L. COLEMAN (B/F, 11-1-90) who stated that on 9-30-22, at approximately 12:15am, she was behind the bar when she heard the DJ make an announcement that they needed water in the back for a fire. COLEMAN stated that she then looked towards the back of the bar and observed smoke. COLEMAN stated that she then began to fill buckets of water with ice and take them to the back and give them to security officer BURRELL in attempts to combat the fire.

There was an undetermined number of bar patrons inside of the bar at the time of the fire who all fled prior to police arrival.

I then proceeded to walk into the above listed bar and toward the back of the bar. I observed that at the end of the front bar area (middle of the bar) there was damage to where I was told was formerly a closet. The closet was located on the south side of the bar and in the middle of the bar, first floor. I observed burnt ash and smoke damage around the area and leading up to the ceiling.

I then notified District One Late Shift Lieutenant Adam ZIEGER of the circumstances surrounding this incident.

Squad 1340 (Crime Scene Technician/P.O. Aaron FROH) took photographs of the scene and damage.

Engine 1 (Lt. PECARAO/red shift), Engine 2 (Lt. SCOTT/red shift), Truck 2 (Captain ALWIN, red shift) were also on scene during this investigation.

Upon arriving on scene P.O. Brendan KULCINSKI of Squad 1340 spoke with the General Manager who was identified as Kamisha C MCNEALEY (B/F 02/21/91). MCNEALEY stated there was patron who was refusing to the leave their establishment. MCNEALEY stated she along with her security personnel asked the patron to leave the bar several times, but she refused. MCNEALEY stated her staff eventually got the female to leave the location, but the female's behavior continued to escalate while they were on the sidewalk. MCNEALEY stated the female struck her and the security supervisor several times, so they called the police. MCNEALEY neither she nor security put their hands on the female.

MCNEALEY and her security team did everything they could to handle the situation in a professional manner, and were cooperative during our investigation.

The female suspect was later identified as Teyona L TURNER (B/F 05/11/99), TURNER was issued two citations one for Assault and Battery (105-2) and the other was for Disorderly Conduct (106-1-1).
