This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/26/21 at 8:07p, officers conducted a License Premise Check at Mojo MKE, 134 E. Juneau Av. The agent was on scene and no violations were found.
- 2. On 08/16/21 at 12:27am, officers observed a fight in the street outside of Mojo MKE, 134 E. Juneau Av. Investigation revealed a patron was being removed from the bar, at which time he attempted to punch the security manager. The security manager then pushed the patron to the ground and kicked the patron in the shoulder. Medical attention was refused by both parties. The security manager was advised regarding professionalism and proper use of force in removing patrons.

3. On 06/25/22 at 12:15am, Milwaukee Police observed a security guard from 134 E. Juneau Avenue physically assault a homeless person in front of the tavern. While taking the security guard into custody for the assault, another security guard removed a holstered pistol from the assault suspect and handed it to another person, who then disappeared into the crowd of patrons. After placing the subject into handcuffs, police asked security for the gun and they originally stated that "his guy" was going take the gun, then stated to officers that there was no gun.

- 4. On 07/09/22 at 10:54pm, a Milwaukee Police officer was instructed by a supervisor to inform the tavern at 134 E. Juneau Avenue that it was playing their music to loud. The officer found the front door to the establishment to be locked and told the manager to lower the music and unlock the front door. The manager said he would lower the music and unlock the front door. He explained to police that the front door was locked because he did not want to put another "door man" on the front entrance because most of his business was on the patio. Later in the evening (2:03am), police observed a large fight in the patio area of the tavern. It took approximately 15 officers to break up the physical fight. The manager, who was unaware of the large fight, was told that there has been an "uptick" in problems at the establishment with patrons and employees. He stated that he wanted to cooperate and would try to find a solution to the problems.
- 5. On 07/13/22 at 8:16pm, Milwaukee Police conducted a license premise check at 134 E. Juneau Avenue. Police informed the manager that they could only have 49 patrons on the patio and they needed to lower the volume of the music. No violations were observed and all individuals on scene were cooperative.

On Saturday, June 25, 2022 at approximately 12:15 a.m. I was on a specialized patrol in the area of E Juneau Ave and N Water St. While on foot patrol I was stationary in the 100 Block of E Juneau Ave. While on scene I did observe a black male wearing a blue button up dress shirt later identified as Antonio S. DUNDY (B/M 5-3-1991) approach another black male in dark clothing carrying a plastic milk crate containing his property. The man with the milk crate was a known local homeless Randy THOMAS (B/M 8-2-1971). While observing the crowd I did observe DUNDY approach THOMAS and speak to him, and THOMAS began to collect items which were on sidewalk in front of the tavern. During the time that THOMAS was collecting items from the sidewalk, and placing them in the milk crate I observed DUNDY punch THOMAS to the face which knocked him to the ground then stand over his body while he was on the ground and punch him again. Upon seeing the Battery I approached the opening to the patio gate which is the area which security lets patrons in and and out on busy summer nights like the night in question. DUNDY approached the area where two other security guards were standing. Upon approaching DUNDY I informed DUNDY to place his hand behind his back as I had just witnessed the Battery. DUNDY stated to me that he was security. I informed DUNDY that he was still under arrest do to the fact I had just witnessed him attack THOMAS in a unprovoked manner. While placing DUNDY in custody it was clear due to his large muscular stature he would require the use of two to three sets of handcuffs. While coordinating the placement of the handcuffs I had the left arm of DUNDY and I could feeling DUNDY blading the back right side of his body away from me and he had his head turned and was saying something to the other security guards which were over his right shoulder. I could not hear what he was saying due to the extremely busy and loud bar atmosphere. I then observed at this time one unknown security guard remove a holstered pistol from the back of DUNDY'S pants. I at this time was still placing DUNDY into handcuffs along with P.O. PETERSON who was still on scene. I was able to get DUNDY into handcuffs and could observe the security guard had passed the gun of to another person who was eventually lost in the crowd. When I asked security for the gun they originally stated that "his guy" was gonna take the gun, then stated to that there was no gun.

I walked DUNDY to the median of the 100 Block of E Juneau Ave where he was detained. I then spoke to THOMAS who stated to me that he did not want anything done regarding being Battered by DUNDY.

DUNDY stated while being detained that he did not have a Concealed Weapons License.

I attempted to speak to the Licensee Todd WARGULA, but as of the date of this report have not been able to speak with him regarding this Licensed Premise Report.

This report is written by P.O. Jacob BACZEK, assigned to District 1, Late Power Shift. During the course of this investigation, I was in full MPD uniform and was wearing a fully operational Body Worn Camera.

On Friday, July 9th, 2022, at 10:54 p.m., while working on squad 1440 (CODE RED DEPLOYMENT), I was instructed by squad 1410, Sergeant Fawn SCHWANDT, to inform the tavern located at 134 East Juneau Street that the music was being played too loudly by the DJ. The music was audible well over 60 feet from the business store front, I also observed that the music was louder than normal. While attempting to enter the front of the tavern, I observed that the front door was locked. At this time, I notified the manager, Daniel J. HUTCHINSON (W/M 04-09-78), that the music was too loud. I explained to HUTCHINSON that I could not hear my handheld radio, even though I was over 60 feet from his business. I also informed him that my supervisor, Sergeant SCHWANDT, could not hear her radio or hear other officers speak to her. HUTCHINSON stated that he would have the DJ turn the music down. I then explained to HUTCHINSON that the front door had to remain open, because locking it would be a fire hazard. HUTCHINSON did cooperate and unlocked the front door to the business. HUTCHINSON stated that he locked the door because most of his business is on his patio and he did want to put someone checking ID cards on the doors. HUTCHINSON then locked the gate enclosing the patio.

At 2:03 a.m. I observed a large fight on the patio at MOJO's. I responded with approximately 15 officers to break up the fight, who were also working the code red deployment. I observed multiple individuals leaving the patio area when police arrived, holding their mouths and faces. None of the subjects wanted police service from officers on scene. I asked an employee to speak with HUTCHINSON, who I did not observe on the floor of the business. HUTCHINSON came downstairs and stated that he was unaware that there was a large fight in his tavern. I instructed HUTCHINSON that I was going to be filing a tavern report regarding the incidents that have occurred this evening and based on a recent uptick in problems at the location. HUTCHINSON stated he was unaware of any recent problems, at which time I informed him of the most recent incidents that I have experienced with patrons and employees at MOJO's. HUTCHINSON stated he wanted to cooperate and would try to find a solution to the issues that were discussed.

INTERVIEW OF Sara M MARTELL/MANGER

At approximately 8:20 PM I spoke with the on-duty Manager who identified herself as Sara M MARTELL (W/F 06-10-82). I informed MARTELL that I was there to make sure all licenses that they had were up to date and in accordance with Wisconsin State law.

OBSERVATION

At approximately 8:25 PM I observed that the Mojo's Bar licenses were in their proper place and visible. I observed that the Green Occupancy License stated that there were supposed to be (49) People on the Patio, 1st Floor (150) People and 2nd Floor (40) People. It should be noted that during night operations at Mojo's Bar there are approximately (200) Two Hundred or more patrons out on the patio. I informed the Manager MARTELL that if the Occupancy License was in error that they need to try to correct it right away. I also informed Manager MARTELL that they need to adjust the volume of the music being played out on the patio. There has been several times during business operations that the music has been so loud, you could not even hear the person next to you across from the location. I observed NO other violations.

Informed the Manager MARTELL that a report regarding this Tavern Check would be filed . All individuals on scene were cooperative.

Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
